

DEPARTMENTAL COMMITTEE ON GARRISON HQ/CANTONMENT BOARD AFFAIRS



Sheikh Zahid Hameed, Chairman Departmental Committee on Garrison HQ/Cantonment Board Affairs warmly welcomed the members in the meeting on June 26, 2020. He thanked the members and discussed the agenda of the meeting to discuss general issues related to cantonment area especially of fluctuation of electricity of supply of cantonment area due to pending tree trimming. He suggested that the Committee Members should generate a welfare fund for initiating new welfare projects. He also shared some of his suggestions regarding the arrangement of Oxygen Cylinders, establishing a mortuary in Cantonment Area, ambulance for the movement of dead bodies, patch work of roads in Cantonment Area etc. The Chairman also appreciated Mr. Ayyaz Chaudhery on successful running of welfare projects of Ambulance Service and mortuary services at Janazgah Shaheedan.

Committee Members were discussed the abovesuggested points by the Chairman Committee; members endorsed the point of view of the Chairman and emphasized on the regular follow-up regarding the issues discussed in the Committee meetings. It was also emphasized that all the issues related to Cantonment Board should be taken up with the Station Headquarter. Members discussed about the newly established drain system of Cantt area which had not been functional; so that such projects should be focused and working should be started with proper planning. Mr. Ansar Aziz Puri, Senior Vice Chairman Committee invited attention of the members toward Clock Tower Feeder where electricity was fluctuated and creating lot of problems for the consumers. In the end of the meeting, it was discussed all the issues would be taken up with the Station Headquarter through written letter.

ONLINE MEETING WITH GOVERNOR STATE BANK OF PAKISTAN

Mr. Reza Baqir, Governor, State Bank of Pakistan, convened a meeting on July 2, 2020, to inform the Trade Bodies and Chamber of Commerce and Industry, on a project of online collection of Duty and Taxes that was in the transition and before the launch of the same, SBP wanted to know the feedback from the industry. He added that the purpose of gathering the recommendations of Trade Bodies and Chamber of Commerce and Industry to make the initiative more productive and business-friendly. Governor SBP added that the newly designed atomized system would help in paying the taxes and duties by utilizing the RTGS (Real-Time Gross Settlement) system that was in the practice of Commercial bank, to collect taxes through the internet and mobile banking.



Mr. Saleem Ullah, Executive Director, FRM said that in total 14 types of levies and taxes would be collected from the facility by utilizing mobile and internet banking of any commercial bank. Mr. Shafiq Ur Rehman, Chairman Departmental Committee Banking and Finance Committee lauded the initiative of Governor State Bank of Pakistan and said that recommendations would be shared by the Sialkot Chamber of Commerce and Industry in written. He mentioned that the services would help many Small and Medium Businesses across Pakistan.

VISIT OF DEPUTY COMMISSIONER SIALKOT DR. NASIR MAHMOOD BASHIR



On July 03, 2020, Friday, a meeting Chaired by Mr. Muhammad Ashraf Malik, President SCCI was held with Dr. Nasir Mahmood Bashir, Deputy Commissioner Sialkot, wherein Honorable Mr. Muhammad Usman Dar, Advisor to Prime Minister on Youth Affairs, and Chairpersons All Associations Sialkot, were also present. President SCCI said that the lockdown was relaxed by the Government of Pakistan and permission to operate under compliance with SOPs, was given to the export-oriented businesses across Pakistan, from Monday to Friday 9:00 A.M. to 7:00 P.M. He further added that with limited manpower the majority of exporters of Sialkot were facing difficulty while completing their export orders, therefore the Industry of Sialkot should be allowed to work on Saturdays as well.

Dr. Nasir Mahmood Bashir, Deputy Commissioner Sialkot, said that as per the notification only 5 days would be allowed to businesses with compliance to the SOPs, however, only those companies which were opened during the lockdown after getting Exports Order verified from TDAP Sialkot, would be allowed to work for production purposes only. He clarified that the permission would remain in the verbal agreement and would not be brought in writing at any flat form until notification was issued by the Government of Pakistan. He also requested to share the list of manufacturers of PPE's who were willing to operate on Sunday.

MEETING WITH MR. USMAN JAMIL DIRECTOR MARKETING, LIAISON OFFICE FOR MESSE DUSSELDORF

Mr. Ikram-ul-Haq, Chairman Committee welcomed Mr. Usman Jamil (Director Marketing, Liaison Office for Messe Dusseldorf), MEDICA's regular exhibitors from Sialkot at SCCI on July 06, 2020. He briefed about the restrictions imposed on Pakistan to enter in the European countries due to COVID-19; therefore the whole scenario was much confused for an exhibitor to take decision either they withdraw their application or to wait for some improvements in the said condition. He said that there were two types of exhibitors from Pakistan either exhibit privately or through TDAP; he asked about the requirements and other policies for both types of exhibitors in 2020. He said that generally there were limited visitors who used to visit on Pakistani booths in MEDICA and also shared the expectation of limited visitors would be allowed this year due to pandemic.

Mr. Usman Jamil, Director Marketing, Liaison Office for Messe Dusseldorf thanked SCCI representatives for inviting him on Zoom Meeting and said that Pakistan was also one the significant countries and on 17th number in all participating countries in MEDICA. Shared the efforts were made by the Fair Organizer to organize MEDICA with all possible arrangements specially focusing on security/safety measures; therefore, business activities should be promoted with all positive & possible endeavors. "Messe Dusseldorf is in liaison with the Government, Exhibitors, Visitors and other relevant organizations to finalize the arrangements with all possible efforts" he added. He told that Messe Dusseldorf had also been contacted to different countries around the globe in order to get their feedback regarding the said event and optimistically work on it to make this event possible in 2020. He told about the postponement and cancellation of some international events in current year due to some emergent situation; so that there would be the possibilities of postponement of MEDICA at the eleventh hour due to any tragedy; therefore the situation would be dependent on many other factors.

Regarding the discussion on cancellation charges, Mr. Usman Jamil, Director Marketing, Liaison Office for Messe Dusseldorf stressed that it was the corporate decision by Messe Dusseldorf to charge 860 Euros from the participants to cancel their participation. He told that TDAP had been withdrawal their participation in MEDICA due to some uncertainties; therefore,

interested participants would participate privately in current year. Members discussed all the points & possibilities to make consensus as the whole situation was unclear due to pandemic and it was also sure that EU would not show any flexibility for Pakistan in current circumstances; therefore, it would be suitable to withdraw this year and to wait for the next year.

VIDEO CONFERENCE WITH GOVERNOR STATE BANK OF PAKISTAN



Mr. Reza Baqir, Governor, State Bank of Pakistan convened a meeting on July 9, 2020, to inquire about any issue members of the Sialkot Chamber of Commerce and Industry had been facing in availing the facility of Rozgar Scheme introduced by State Bank of Pakistan, during Covid-19 crisis. Governor SBP said that State Bank of Pakistan had established helpdesk at Chambers of Commerce and Industry across Pakistan, including the Sialkot Chamber of Commerce and Industry. He added that SBP wanted that the information of the Scheme of State Bank of Pakistan should reach to the maximum people. He further inquired that no gueries were received from the Sialkot Chamber of Commerce and Industry and whether any query had been raised by the member. Governor State Bank of Pakistan said that 23 cases of Corporate/ SME sector were received and PKR 232 Billion was released to the applicants.

Mr. Muhammad Ashraf Malik, President SCCI, acknowledged Governor State Bank of Pakistan on decreasing the Long term investment rate to 2 % and also on the business-friendly initiated by State Bank of Pakistan in the Covid-19 crisis. He clarified that a few members of the Sialkot Chamber of Commerce and Industry including Sialkot International Airport had availed the Rozgar Scheme Facility and the majority of the members Sialkot Chamber of Commerce and Industry were owned by Small Businesses, who avoided to taking loans from banks due to high-Interest rates. He further added that SCCI would keep sharing the Schemes launched by SBP, from time to time.

MEETING OF DEPARTMENTAL COMMITTEE ON TRAVEL AND TOURISM



Meeting of Departmental Committee on Travel and Tourism was held on July 14, 2020 at SCCI. Mr. Nadeem Ahmed, Chairman Committee welcomed the members and discussed about the lockdown, which resulted in the closure of businesses and commercial activities across Pakistan. He said that the concerns related to the Travel & Tourism Industry would be discussed in the meeting, and the resolution would be sent to the competent authorities. He said that after \ ease in the lockdowns across the country, a few special flights carrying the passengers were allowed; however, the Committee would propose the Government to revisit the policies and should start flight operations to the countries which had eased their lockdowns. He discussed about the new traveling policies from U.A.E and Saudi Arabia.

Members also discussed the travelling policies of UK, USA and U.A.E after COVID-19 and said that policies of many countries were still not clear. For traveling to the U.K. 14 days quarantine policy was in practice and test from accredited Lab, was also mandatory before leaving from Pakistan; furthermore, every country had been practicing their policies according to the Covid-19

situation. It was also suggested that Sialkot Chamber members should negotiate with airlines for getting discounts while traveling abroad during exhibitions season. It was also discussed that Government was not supporting the travel industry in COVID-19 situation in reviving International traveling; while traveling to European countries, a test of COVID-19 was mandatory on the International traveler. It was proposed that guidance should be provided to the members to avoid rejection of Visa to Europe during hotel booking and air ticketing. After the detail discussion, it was decided that the Committee would also write emails to the Embassy of U.A.E and Saudi Arabia to seek the latest travel advisory by their Government.

VIDEO CONFERENCE WITH STATE BANK OF PAKISTAN, FBR, AND PRAL

Mr. Qader Bakhsh, Additional Director, State Bank of Pakistan-Karachi welcomed the participants from FBR, PRAL, Customs and Chambers of Commerce on Joint Video Conference on July 21, 2020. Mr. Bakhsh told that SBP had designed a project of submitting Taxes and Duties online through the online banking system by utilizing the RTGS (Real-Time Gross Settlement) system that was in the practice of Commercial banks. He added that the newly designed system would also help in getting a refund without human intervention and make the system more efficient. Mr. Saleem Ullah, Deputy Director-SBP shared the progress of the project that was initiated in light of the problems arising in claiming the Duty Draw Backs. He added that the joint meeting with Chambers would help in addressing the ambiguities of the business community. He said that an Exporter had to update the details of his Commercial Bank, on WeBOC profile, where the refund would be made, once export proceeds were matured.

Mr. Habib Ahmad, Additional Director Exports, Pakistan Customs shared that once the export process had been matured and on receipt of remittances into the account of the exporter, the concerned bank would intimate the SBP as well as FBR, on completion of the exports process, thereafter refunds into the account of exporter would be made. Whereas, Mr. Saleem Ullah, Deputy Director, SBP, shared that the system was developed the make payment of Taxes and Duties, as well as, receipt of refunds. He further added that 10% Post Audit, would be opted by the system, and also clarified that SBP was devising the refund of pending claims, and a solution would be made very soon.

Mr. Shafiq Ur Rehman, Chairman SCCI's Departmental Committee on Banking and Finance said the initiative taken by SBP was commendable and also highlighted issues related to reporting of the appeal of problems, into the system. Mr. Muhammad Ashraf Malik, President SCCI appreciated the State Bank of Pakistan, FBR, and PRAL on designing the new project. He stressed that the three departments should have a strong liaison with each other to make the system error-free. Mr. Malik also sought the information of the Post Refund Audit condition of PRAL and also inquired for resolution of pending DLTL cases of the year 2014 from SBP.

MEETING OF DEPARTMENTAL COMMITTEE ON SURGICAL/DENTAL/VETERINARY INDUSTRY



Mr. Ikram-ul-Haq, Chairman welcomed the members in the meeting of SCCI's Departmental Committee on Surgical/Dental/Veterinary Industry on July 27, 2020. He explained the working of Amazon had done with the Ministry of Commerce, Government of Pakistan to get the names of Pakistani firms interested to start business on Amazon. He encouraged the surgical industry to start doing online business through different platforms and elaborated about Online Business, Eligibility criteria, Guidelines/Steps to Start Online Business, Payments system, direct service of Amazon, other Direct & Indirect Services, Delivery cost using Amazon Direct & Indirect Services, Direct Shipment from Pakistan and Business Model suitable for Amazon Direct

Services in detail. Industry should explore the different ways of businesses in international market to grow.

Mr. Naeem Anwar Qureshi, Mr. Omer Khalid, Mr. Zahid Rafique Towne, Mr. Salman Sheikh, Mr. Zaid, Dr. Gohar Igbal and other members participated in discussion about the said agenda. The dynamics of Online Business especially through Amazon, scope of surgical instruments on Amazon, process/requirements to do business on Amazon, payment terms & technicalities, taxation system imposed on such payments etc. Amazon as a giant platform having their large team to maintain the working and to keep check on the trend of sale of all the products; it became a buyer of a most trending product and sold the said product on its platform to the direct customer. Sialkot Industry should also move forward to cater many un-tapped markets around the globe via online business platforms. It was suggested that an online web-portal (as a marketing & selling platform) could be established for providing a virtual space to the Sialkot based surgical instruments manufacturers. Chairman Committee mentioned the export share 1.67% of Sialkot Surgical Industry in total exports, decreasing trend in international trade and emphasized that Sialkot Surgical Manufacturers suffered due to the pandemic and should search out the new business mediums to survive in the market. He said that there was global drift of businesses towards the online platforms and to connect the world through online trade; therefore, it was highly recommended that Sialkot Industry should learn about the shift and adopt the new modes of businesses.

VIDEO CONFERENCE WITH AMBASSADOR OF PAKISTAN TO DENMARK H.E. MR. FAROOQ AHMAD

Mr. Muhammad Ashraf Malik, President SCCI welcomed H.E. Mr. Farooq Ahmed, Ambassador of Pakistan to Denmark for the video conference on July 27, 2020. He congratulated him on assuming the charge. H.E. Mr. Farooq Ahmad, Ambassador, of Pakistan to Denmark, thanked and said that the Embassy of Pakistan in Denmark surveyed the local markets of Denmark, wherein they had found that China, Bangladesh, and India were acquiring the majority of the shares related to Textile Products. He told about the mechanism for the trade of surgical instruments through Germany and also added that the Danish markets also had the potential for Footwear and Sports Goods. He said that the Commercial Section would share the details of potential importers of Danish markets, and would also help in organizing the B2B webinar session for Pakistan Exporters.



Mr. Qaiser Iqbal Baryar, Mr. Khurram Aslam Butt, Ch. Jalil Aslam, Mr. Muhammad Umair Mir, Miss Syeda Shabina Gillani and other members appreciated the honorable guest on his working and assured to provide "Made in Sialkot" product to the Embassy of Pakistan in Denmark for display. It was added that the Sialkot Chamber of Commerce and Industry also had a history of organizing CSR and Sustainability projects for the welfare of society, "the list of the same would be shared". Scope/market of the products made from organic cotton and organic leather produced by Sialkot's Industry were discussed. Commercial Section was also requested to help in organizing B2B meetings with local distributors, buyers, and importers, through webinars, during the times of Covid-19, and also share the list of importers of Denmark markets as well as the details of famous Trade Fairs and Exhibitions related to the Industry of Sialkot.

MEETING OF DEPARTMENTAL COMMITTEE ON FBR, CUSTOMS, SALES TAX AND FEDERAL TAXATION

Meeting of Departmental Committee on FBR, Customs, Sales Tax and Federal Taxation held on August 6, 2020 at SCCI. Ch. Ahmed Zulfiqar Hayat, Chairman Committee welcomed the members and informed that FASTER had been operational since July-19. He urged the members to file Annexure–H in sequence i.e. first for the month of

July-19 and then for the subsequent months in sequence. He informed that by elimination of sequential gaps, processing of claims could be expedited. Moreover, refund amount claimed should strictly match the consumption reported as per Annexure-H. In case of any mismatch between the two, the refund claims would be deferred. He also shared the guidelines for the claimants in detail.



Members highlighted the several issues/concerns including the issue of partial/non-payment of Sales Tax refunds (for the period of January and March, 2020) etc. Issue of non-payment of Duty Drawback Claims on Eidul-Adha due to payment of Custom refunds during Covid-19 pandemic situation from the Government's General Account instead of Revenue Account was discussed in detail. Problem faced by exporters in obtaining Export Oriented Unit license under SRO327 (I)/2008 dated March 29, 2008 and the issue of notices received from Punjab Revenue Authority PRA were also discussed with the house.

In addition to the main agenda of the meeting, following matters were also discussed during the meeting; delay in payment of Income Tax refunds, issue of payment of PESSI and EOBI contribution and surcharge for the period of lock down of the economy during Covid-19 pandemic situation and issue of 5% Withholding Sales Tax on Exporter Companies, under 11th Schedule to the Sales Tax Act, 1990. After due deliberation, it was decided that letters would be sent to The Chief (Sales Tax), Commissioner PESSI and Chairman EOBI in order to discuss the above mentioned concerns related to their jurisdiction.

MEETING OF DEPARTMENTAL COMMITTEE ON POST OFFICE/TELECOMMUNICATION



Meeting of Departmental Committee on Post Office/ Telecommunication held on August 11, 2020 at SCCI. Mr. Zaheer Amir, Chairman Committee welcomed Mr. Muhammad Arshad (Deputy PMG, Pakistan Posts-Sialkot Region) and Mr. Abid Mehmood (Chief Post Master GPO Sialkot) with the appreciating remarks for the services of Pakistan Post. In his address, he discussed the complaints, delays/impediments in receiving the parcels containing export samples and told about rates of EMS (ISP) Service offered by Pakistan Post was higher than other private companies like DHL, UPS, FedEx, etc. He shared the frequent complaint by the members about not receiving the Chamber Bulletin. PERSONAL PROTECTIVE EQUIPMENT AND THE GLOBAL OUTBREAK OF COVID – 19



Personal Protective Equipment (PPE), essentially refers to the equipment that provides protection from infections or injury. Exposure to workplace hazards such as chemical, radiological, physical, electro-mechanical, or other risks including biohazards and airborne particulate matter can lead to such infections and injuries. PPE is addressed in specific OSHA standards for General Industry, Maritime and Construction. And it requires that PPE must meet the standards developed by the American National Standards Institute (ANSI). It includes items such as protective clothing, helmets or hard hats, gloves, gowns, face shields, safety goggles and shoes, earplugs or muffs, face masks or respirators, coveralls, vests and full body suits or other specific equipment particularly designed to provide protection. As defined by OSHA and ANSI, PPE can be used by the employees working in a sensitive environment for occupational safety and health purposes and for sports and other recreational activities.

The sole purpose of PPE is to minimize the effects of hazardous accidents or infections that might occur at a workplace. Improper use of PPE or equipment failure may result in an unwanted exposure to danger. To arrest such eventualities, employers must provide proper PPE and ensure its correct usage workers. It also directs to a need of employees' training with enough emphasis on addressing risks present at work place and in selection, maintenance and usage of PPE.

Although PPEs are categorized last in hazard control ladder yet it proved the only effective shield against the novel Corona Virus. The sudden outbreak of COVID-19 caught the professionals and experts unprepared in terms of effective arrangements for its elimination or substitution or even bringing in engineering or administrative controls. As a matter of fact, this pandemic took the world by surprise and challenged the existing infectious outbreak prevention procedures. With each passing day, PPE was becoming the one and only way forward to deal with COVID-19. The slightest mishandling of PPE could make a person from being safely covered to dangerously exposed. Regular and continuous use of PPE (gowns, full body suits, gloves, face masks and respirators) laid down the basis of safety of paramedic staff, nurses and doctors busy in handling COVID-19 patients in hospitals, clinics and labs. And in COVID-19 environment, PPEs became the requirement for paramedic and general public alike instead of choice or luxury.

The threatening COVID-19 spread assured the mandatory use of PPE in health care settings such as hospitals, doctor's clinics/ offices and clinical labs. When used properly, PPE acts as a barrier between infectious materials such as viral/bacterial contaminants and skin, mouth, nose, or eyes (mucous membranes). PPE have the potential to block transmission of contaminants from blood, body fluids, or respiratory secretions. PPE also protects the patients who are at higher risk for contracting infections through a surgical procedure or having a medical condition, such as immunodeficiency, from being exposed to potentially infectious material brought in by visitors and healthcare workers. The proper usage along with the other infection control measures such as handwashing, using alcohol-based hand sanitizers, and covering mouth while coughing and sneezing minimizes the spread of infection from one person to another. The proper disposal of used PPE is equally important to prevent germs and viral spread.

Handling of COVID-19 by Government of Pakistan met due recognition at all forums in the world. In addition to, enforced usage of PPEs by professionals and general public alike, implementation of SOPs such as social distancing, self-isolation also known as quarantining of positive cases, smart lock down i.e. sealing of virus concentration areas and above all awareness campaigns run on tele-social media, set the ground for effective control where the world has generally suffered a lot at the hands of COVID-19. When an infection outbreak affects a broad population, such as current pandemic COVID-19, Drug Regulatory Authority of Pakistan (DRAP) is responsible for making specific recommendations for infection control measures in different circumstances and settings. In COVID-19 environment DRAP pursued the government for ensuring use of relevant PPEs (surgical masks, N95 respirators, medical gloves, and full body suits/ gowns) and implementation of SOPs. DRAP also ensures that PPEs intended to be used as a Medical Device in Pakistan must follow its regulations and should meet voluntary consensus standards for protection. These standards and DRAP's requirements may vary depending on the specific type of PPE. However, when these standards and regulations are followed, they provide reasonable assurance that the device is safe and

effective. DRAP has an authority to put any PPE on review under Premarket Notification or 510(k) Clearance before making it available in the market for general use. PPEs are supposed to meet specific criteria for performance, labeling, and intended use to demonstrate substantial equivalence. Voluntary consensus standards may also be used to demonstrate sterility (when applicable), biocompatibility, fluid resistance, and flammability. PPE approved and cleared by relevant authorities such as FDA/ ANSI and NIOSH for use in EU and USA have market access in Pakistan market as well.

COVID-19's curve in Pakistan started flattening by mid of July. As of today, Pakistan has about 6000 deaths due to COVID-19 against total reported cases of about 200,000.00. This was only possible due to implementation of stringent policies and relevant SOPs. The severely affected areas were sealed to avoid mixing of carriers with the normal population. The medical and law enforcement authorities remained vigilant throughout this global hit. Off the late, life is coming back to its normal routine. Offices and Education Institutions are going to get started as usual. Keeping in mind this fact, that the virus is not completely eradicated, and it takes nothing but a slight carelessness to initiate the unending chain, the proper use of PPE still continues without exception and SOPs being strictly followed. The only way forward to get life and economy on the right track.



STARTLING -- DEVELOPMENTS

China and Iran have drafted a comprehensive military and trade partnership. The deal will make way for about \$400 billion worth of Chinese investment into Iran's key sectors i.e. energy and military developments, for the next 25 years.

This agreement would lead to closer military relations between Beijing and Tehran, including joint military exercises, weapons developments and intelligence sharing. It would also increase Chinese investments in Iranian banking, telecommuni-cations and transportation. The reported agreement also includes that China would help in building infrastructure for 5G telecommunication network in Iran. It is reported that the deal had been first proposed by Chinese President Xi Linping during his 2016 visit to Tehran, and the proposed draft was approved by Iranian President Hassan Rouhani and Foreign Minister Mohammad Javad Zarif over the last couple of weeks. The Iranian officials have publically acknowledged that there is a 'pending agreement with China' which hopefully will be approved by their Parliament because of its high utility and bilateral enhancement of trade relations. Beijing is also still to disclose its terms; Iranian

government has meanwhile approved the draft of 25-year deal with China on economic and political cooperation; the deal being of more importance for the whole region. Iran's foreign ministry spokesman, Abbas Mousavi, said it was a proud moment for the Iranian diplomatic history.

Tehran has not revealed yet, the full details of the agreement, but a previous report by the Petroleum Economists suggest that Iran is set to grant huge concessions to China, including significant discounts on oil and gas, and the ability to delay payments for up to two years. It has also allowed China to pay in soft currencies. China's more pronounced interest in Iran should alert the US to review its past approach to Tehran. The deal comes at a time when the Iranian economy has been completely damaged by US sanctions, which reproached that any country in the world that deals with Iran would be cut off from global financial system. Presumably this stance will change soon, owing to the Iran-Chinese joint ventures.

The estrangement between China and America owing to COVID-19 had peaked, as Trump named this COVID-19 as 'Chinese Virus'. There are also irritants in the south Chinese sea between China and America and highly objectionable sanctions imposed on Iran thereafter, quite arrogantly. Clashes between China and India due to their Ladakh dispute have disrupted peace in the region. Nascent tensions have engulfed Iran and India too, because of the Chabahar port and railway track to develop from

Chabahar to Zahidan, as was agreed between them. The project was started by both India and Iran, to extend trade opportunities to Afghanistan, Central Asia and Europe. But Modi's recent enchantment with US and his anti-Islamic Hindutva- (Hindu nationalist) based foreign policy isolating it in the world, has lost a



project which was more beneficial for India itself. Iran will now complete its Chabahar project with the help coming from China. China has provided 400 billion dollars for this project, as the relations between China and Iran are fast growing in the form of trade and financial policies and India owing to its fallacious policies with every country of the region, has lost its metal. Both Iran and China have expelled India, in a way strategically. This happens to go in favour of Pakistan which is consistently pursuing a balanced foreign policy and is better placed due its CPEC-BRI collaboration and the US's need of Pakistan to help resolve its Afghanistan imbroglio.

In its efforts to destabilize Pakistan and divert its attention from Kashmir and the LOC, India has activated Pakistan's western front, in order to engage it militarily. India had ostensibly invested in Chabahar Port too and other projects in Iran to create an alternative-trade- corridor to Afghanistan and CARs states, thus bypassing Pakistan. However the cover of Chabahar Port was also exploited to establish its spy and terrorism network against Pakistan. Kulbhushan Yadav, a serving Indian Navy Commander, was settled in Chabahar as the spymaster to organize terrorist activities in Baluchistan to target CPEC-BRI and Karachi, to threaten Pakistan's economy like it had helped MQM based in London. will now be construed by China. India had committed another folly and that was its intrusion in the Eastern Ladakh which brought embarrassment to India with heavy casualties and loss of its strategically important territory besides a bashing-humiliation in the eyes of the world. Trump has now realized that he had betted on a wrong horse.



Yadav was picked up by Pakistani intelligence on one of his forays into Baluchistan. The Indians are also sponsoring dissident elements like BLS, BRA to carry out terrorist activities. Their operations are controlled from New Delhi and are RAW engineered and sponsored with voluminous money.

Prime Minister Khan's regime has initiated the Diamer Bhasa Dam construction. India has come up with the tactical assumption to sabotage this move by Pakistan. A report disseminated on Indian media that the dam would induce the ecological catastrophe in the region and intensify the number of earthquakes by 300 in one month. On the contrary, Pakistan dismissed the inadequate report as it was based on fallacious features. Pakistan is constructing the dam with the help of China and India does not appreciate this. Beyond that, India also feels alone on the global stage as Iran expelled it in the Chabahar Port project which

PM Modi is on record having stated earlier that CPEC does not suit India. Obviously he meant by his last month's military action taken, to obstruct the CPEC route via Gilgit-Baltatistan. Modi is known for his abrupt and unwise steps like his mentor Trump, because of which his army men in Ladakh got a bashing and a humiliation by having been beaten by Chinese soldier's military boot-kicks, the scene which went viral throughout the world. Modi had attacked eastern Ladakh, on the directions of his masters, to engage China in the mountains and then attack Gilgit - Baltatistan to cut off the CPEC route; a thinking much larger than his physical and mental size and capability. He had to change the plan soon after receiving an unforgettable thrashing of his soldiers on the Chinese border and sensing the great unity between China and Pakistan that he could face both China and Pakistan's armies on its triangular borders;


he has immediately receded to his auqat (worth) and preferred to continue shelling the civilian houses in the Azad Kashmir border villages; a timid Hindu specific approach.

According to the 'Pakistan Economic Survey 2019-20' the installed electricity generation capacity reached 37,402 MW in 2020, whereas the total demand of Pakistan is 25,000 MW. This huge surplus is due to CPEC's 17 energy projects which have been installed in various cities in Pakistan and 13,000 MW energy added in the national grid stations. So the question is this: if Pakistan's maximum energy demand is 25,000 MW and the installed capacity is 37,000 MW, so is there really an energy crisis or is it just an incompetency on the part of the government institutions? Another part of the Economic Survey 2019-20 says that the transmission and distribution capacity is stalled at approximately 22,000 MW. Some simple math will help understand this anomaly.

So, we have the capacity to meet our demand, but the problem lies in the part of transmission. Every new government installs new power plants and increases the installed capacity, but no government has focused on improving the transmission and distribution capacity. Pakistan's energy problem can easily be solved if experts are given the authority and distribution capacity, and efficiently so, if the government (any government) is serious enough in addressing and handling this issue faithfully, rather than focusing on building more power plants It is important to work on transmission. Once Pakistan gets uninterrupted light, its economy will boost and attract more foreign investors.



ON-GRID SOLAR SYSTEM WITH ENERGY STORAGE (HYBRID)


