نیکا پورہ کا علاقہ "نالہ ایک" کے کنارے آباد ہے، جہاں مختلف برادریوں کے لوگ آج بھی ایک گل دستے کی مانند رہائش پذیر ہیں۔ حافظ محمد صدیق نیکا پورہ کے ایک آسودہ حال تاجر تھے جو کپڑے کی تجارت کرتے تھے۔ 15 جنوری 1955 کو محمد رفیق کی صورت میں رب العزت نے حافظ محمد صدیق کو بیٹا عطا کیا تو حافظ صاحب نے سجدہ ریز ہو کر اللہ تعالیٰ کا شکر ادا کیا۔۔۔ گھر کے آنگن میں بیٹے کی پیدائش پر بے پایاں مسرت و انبساط کا اظہار کیا گیا۔

VISIT OF MR. SHAHID BASHIR, PAKISTAN'S EX-AMBASSADOR TO WTO



Mr. Shahid Bashir, Pakistan's Ex-Ambassador in WTO visited the SCCI on September 28, 2021. He thanked and shared his experience at various positions in public sector and as the Ambassador/Permanent Representative to the WTO. Mr. Khurram Aslam, Mr. Ikram-ul-Haq, Mr. Waqas Akram Awan, Mr. Salman Sheikh and other members discussed the facts about the Surgical Industry of Sialkot, its trade figures, impediments and suggestions for their growth & development. Fact presented by a BBC Report was shared that Sialkot had providing approximately 90% of the metal-based surgical instruments around the globe. Govt. should be supported in imports of technical machinery either new or used machines to enhance the production capacity as well as the quality of the surgical products. It was discussed that joint ventures should be promoted on Government level in order to bring the foreign investment and to work on import substitutes. It was also discussed that Sialkot Industry was combating for its survival but with certain support, this city can do wonders due to its actual potential. Furthermore, Raw-Material Bank should be established to minimize or eliminate the issues regarding availability of desired quality materials on justified price.

Mr. Shahid Bashir, Pakistan's Ex-Ambassador to WTO thanked for the feedback by the Sialkot Chamber and also acknowledged the inputs of Sialkot Surgical Industry to design and refine the research project. Mr. Ikram-ul-Haq thanked Mr. Shahid Bashir, Pakistan's Ex-Ambassador to

WTO for his visit to discuss an important matter and assured that the required information would be provided to him at the earliest. He also thanked all the participants for their inputs.

MEETINGS ON TRADE DELEGATION TO TURKEY DELEGATION



A meeting was held on 11th October 2021, Chaired by Mr. Khurram Aslam, Former Senior Vice President, on Turkey Delegation. During the meeting Mr. Aslam briefed about the hotel booking and advised the Delegates to confirm their air tickets as soon as possible. He further inquired about the status of Visas of Delegates. He shared that a supporting letter from Sialkot Chamber of Commerce and Industry was also written to Consul General of Turkey in Lahore to issue visas to applicants. He added that COVID-19 PCR test should be done within 48 hours before taking the flights and mentioned the documents to be kept during the trip. He shared that the final schedule of the meetings will be shared once received from the Consul General of Pakistan in Istanbul.

MEETING ON TRADE DELEGATION TO UKRAINE DELEGATION

Meetings were held on 11 Oct & 16 Oct 2021 at SCCI to discuss the SCCI's Trade Delegation to Ukraine. 1st meeting was organized to discuss the execution of Trade Delegation. Mr. Khurram Aslam, Former Senior Vice President, presided the meeting to discuss the Ukraine Delegation and discussed about the status of Visas of Delegates and Air Tickets booking of the Delegates.

Mr. Khuram Aslam, Former SVP, chaired another meeting on 16th October 2021, wherein he informed with the Delegates should get their COVID-19 PCR test 48 hours before the flight. He also shared that the hotel booking had been completed by the Embassy of Pakistan and details would be shared on WhatsApp group of Delegation. Three members Committee will look after the expense of the Delegation; whereas, refund policy was also elaborated in detail.

MEETING WITH MR. FARRUKH H. KHAN, CEO/MD OF PAKISTAN STOCK EXCHANGE



Mian Imran Akbar, President SCCI welcomed Mr. Farrukh H. Khan, CEO/MD of Pakistan Stock Exchange (PSX) to visit the Sialkot Chamber on October 21, 2021. He expressed his satisfaction that Pakistan Stock exchange was being led by Mr. Farrukh who was an experienced economist and provided his services in privatization of various organizations, guiding in financial matters and bringing international investment to Pakistan, he added. He addressed the audience that SMEs were considered important in the entire world as they boosted the industrial economy, provided employment, enhanced skills of laborers, equally distributed wealth and promoted trade. Sialkot considered as the center of SMEs and they had been offering their best to develop the cottage industry, the goods manufactured in Sialkot carried global repute and demand in international market. The President stated that, even though the Covid-19 pandemic damaged the big economies, the Sialkot export-oriented sector experienced growth and earned more than 2.5 billion USD foreign exchange to support the

economy of Pakistan. "Pakistan Stock exchange had played its role well to bring investment to SMEs to increase their capital and valuation of assets", he added.

Mr. Farrukh H. Khan thanked the SCCI and invited participants to visit Pakistan Stock Market at Karachi to get introduction and awareness about capital market. He told about the PSX had the vision to provide a fair, transparent and efficient marketplace to facilitate capital formation for the benefit of all stakeholders. PSX had achieved many milestones such as in June 2017, 20% stake of PSX was acquired by the general public by public offering. PSX ownership was shared between China Financial Futures Exchange, Shanghai Stock Exchange, Shenzhen Stock Exchange, Pak-China Investment Company Limited and HBL, where patterns of shareholding were divided into 40% to Chinese Consortium and 60% General Public, Corporate Entities & Other Foreign Investors, he added. He shared about the role of PSX in the economy as a capital provider to the businesses, growth indicator, and a source to attract foreign exchange/capital etc. Companies listed on PSX provided employment and benefits to millions of Pakistanis and their families and generated significant tax income to the Government of Pakistan.

DEPARTMENTAL COMMITTEE ON GARRISON HQ/CANTONMENT BOARD AFFAIRS

Meeting of Departmental Committee on Garrison HQ/Cantonment Board Affairs was held October 23, 2021 and chaired by Sheikh Zahid Hameed, Chairman Committee. He mentioned the names of previous five Presidents and acknowledged the learning from the last five tenures. He gave a presentation to describe the previous performance of the Committee for the members. He shared pictorial views of some areas and also shared his suggestions regarding the commercialization of the area on Khawaja Safdar Road. He also shared his idea about the Cantonment Board Dispensary to collaborate with the Cantonment Management with the aim to upgrade the dispensary for providing the quality medical facility to the residents of

Mr. Nasir Saleem Mirza, Chairman presided the Committee meeting on October 25, 2021. He discussed the issues regarding Law & Order and Traffic Management System in Sialkot in order to facilitate business community and citizens. He also emphasized to establish a "Driving license Desk" at Sialkot Chamber for facilitation of Members. The Chairman invited suggestions and proposals from the committee members for the improvement of traffic management system and committee performance.

Members congratulated the Chairman on assuming Charge as Chairman Committee and suggested that the awareness lecture should be

arranged in different Schools and Colleges in which ASP, DSP Traffic Police and Representative of Chamber may deliver the lecture and educate the students for observing traffic rules; whereas, members also shared their suggestion regarding the traffic management, low manpower in traffic police, number of parking stands tenders issued by TMA on almost all roads of Sialkot and poor road constructions etc.



Mr. Zohaib Rafique Sethi, Senior Vice President SCCI endorsed to arrange awareness seminars for public. In conclusion, the Chairman assured that all above said recommendations would be workable but time taking; therefore, all the committee members should extend maximum cooperation for early resolution of the problems of the members of Sialkot Chamber.

WCCIS believes that women in our community deserve a platform that can provide practical solutions to their problems, expand their vision and identify opportunities for them.

Women owned businesses are still in the minority, and the hurdles faced by women who have embraced entrepreneurship are vast and often very different from those experienced by their male counterparts in Sialkot. To shed light on some of these disparities, and to promote, stimulate and protect the key challenges women entrepreneurs face, it was the need of the hour to establish the Women Chamber of Commerce & Industry, Sialkot.

CHANGING WORLD ORDER

Within little more than a year (since January 2020) the world has undergone a drastic change. No one could have imagined a complete devastation of the most advanced health system achieved by man in the past century, by having to face a sudden fall of COVID -19 on the world which made its large population succumb to death and un-paralleled grief. The tragedy has not ended yet and is re-surfing its head again and again like a sea-monster.

Even more devastating has been its effects on the human activity, loss of industrial pace and growth, poverty among the masses, rise in beggary and sufferings. No one could imagine or anticipate, overnight collapse of industries, airlines and tourism including, that the oil-dependent economies would suffer irretrievable rise in losses : that the West would be forced to yield to China (and the East): and that the myth of Indo-Pacific , designed to contain China would decipher, resulting in the 'containment of India' instead, along with the fall of the infamous Trumpian anti-Islamic period, pinning hopes on Biden who prefers diplomacy against brinkmanship – a negation of Trump's thought process. We seem to be passing through a gigantic phase of global change. Much like the period of the two World Wars, or the collapse of the Soviet Union in 1991; history bears witness to the fact that an alteration in the global power structure necessarily affects the governance systems of its corollary states.

A merely hundred years ago, the world was unrecognizably a different place. Europe and the Middle East were predominantly split between the Austro-Hungarian Empire, the British Empire, the Ottoman Caliphate and the French pockets of power. Russia, China and Japan had empires of their own. India which had been ruled by Mughal Emperors for centuries now belonged to the British (which personally, I abhor, because they intentionally made the continent poor, uneducated and backward). And this “empire” structure

of the ruling powers also dictated the manner in which local governments operated. Raj, Khilafat and Kingship were the accepted norms. Democracy was not the mantra of any people. The only exception, at the time was the United States, whose influence did not extend beyond its oceanic boundaries. The First World War changed the whole scenario. The Ottoman Empire, along with its Khilafat structure, was entirely obliterated. The Austro-Hungarian Empire disintegrated, giving way to German Austria, Hungarian Republic, Czechoslovak Republic, and the spinning off of Croatia, Serbia and parts of Romania.

The United States, which had just arrived at the international scene, was not yet the power we see today. And its governance structure, an open democracy, had not been proclaimed as the preferred form of State structure across most parts of the world. Then came the Second World War and its decisive victory for the Allied Forces. This victory abolished the “Empire” structure of the old, ushering in the age of democracy. Japan effectively shed its cloak of Kingship, under American dictate, and adopted western governance structures. Even the British Empire, which was among the victors of the Second World War, could no longer retain its empire status, and chose the allied form of democratic enterprise. The self-coined name of 'Great Britain' had to be shed away as no other people of the world reconciled with this mentality of self-aggrandizement. Importantly, as empires crumbled, so did Britain, the ruling powers carved out a new map of the world. Israel was born mischievously by the British out of thin air. The Middle East was [literally!] split across borders that the Queen drew at the back of a napkin. The Indian sub-continent was split through borders drawn by the Viceroy—in many places, against the will of the domestic people. A highly inexperienced official named Radcliffe was assigned the job, who intentionally and upon instructions of his boss, drew combustible borders. Parts of Africa were split into smaller nation States. And institutions such as the United Nations (and other Western alliances) were established to institutionalize the allied power structure.

Importantly, the Western global powers, which redrew most of the global map at their whim, also guaranteed the sanctity of the new borders—either directly or through their proxies. For almost four decades after the Second World War, the only real challenge to Western hegemony was the Soviet Union. Within the territories controlled by the Soviet Union, the 'American democratic enterprise' was resisted. These territories--from Eastern Europe took their governance lead from the communist-state- structure of the Soviet Union. Fall of the Soviet

Union, in 1991, once again resulted in re-making of International boundaries. The eastern part of the Soviet Union was carved into 18 different international territories. Each of these borders was redrawn with the consent of the only remaining super power (the United States). And the consequent governments formed within these territories, also took their lead from the United States. Collapse of the Soviet Union ushered in the age of a unipolar world. For the first time, since the Roman Empire, the world was 'dominated' by a single country: the United States. This extraordinary turn of events ushered in the age of American Imperialism. Since 1990, the United States has enjoyed almost hegemonic power. It has invaded countries at whim, ousted governments it did not like, brought in army dictators who would easily obey them than the elected assemblies, even when the domestic population did not want it—e.g. changes in Afghanistan, Pakistan, Iraq and Greece, and several others. The US is still working on the same spree.

International governance bodies (e.g. IMF) forced countries to undergo reforms that suited the United States and to adopt American style of governance. Those who followed the American lead were rewarded (South Korea, India etc.). Those who differed (e.g. Venezuela, Iraq, Syria, Libya etc.) were punished. But 2020 seems to have changed all that. Crippled by the spread of COVID-19 and having been drained off, its global energies during ill-conceived wars, Donald Trump's reactionary "American First" policy—which shuns the idea of an inclusive American Dream—resulted in withdrawal of American hegemonic global influence. Trump's xenophobic Islamophobia has further disillusioned the Muslim world from the US. And American withdrawal has prompted competing interests to fill this vacuum. In Syria and Lebanon, for instance, France and Russia are already more important to the local power structure than America is. Countries like UAE, Qatar and Pakistan are looking east, towards China and Russia, for their long term goals.

In particular, the rise of China, which was slow and sluggish till recently, has gained tremendous pace during the course of Coronavirus epidemic. As the West reels from the effects COVID-19 and America loses itself to the madness of domestic strife, China is gaining ground In the South China Sea, as China asserts its claim on various territories (including Taiwan), American influence is dwindling. Maintaining status quo in the South China Sea may require the United States to threaten military conflict. One that the Americans are not sure they can win, despite the recent fanciful 'QUAD' pact signed between US, Australia and India. The later has been humiliated by China in Ladakh, to make feel their presence in the hot bed sea of the South. China's swift

aggression in Ladakh and a speeding up of CPEC projects (despite COVID – 19 lockdown) is a testament to the Global repositioning of China. A global reset is afoot. And the new age of "Look East" is about to start. Pakistan stands at the gaining end. Already, institutions such as WHO and even the EU are no longer in the strangle of American influence. This shift in global power has real consequences for international boundaries that were artificially drawn across the Middle East and even whole Asia. The powers that created those boundaries and guaranteed their sanctity can no longer do so. And places like Hong Kong, Taiwan, even Ladakh, are a perfect example of this. As China decides to consolidate its control over these areas, will the US risk a war to liberate them? If China stays in Ladakh, or expands its dominion across the Indian border through Nepal, will the United States and its friends come to the aid of India? Will they fight a war to jeopardize CPEC, or the larger Belt and Road Initiative? The answer is big NO; given the worst bad effects of COVID – 19 in the West and the humiliating ouster of Trump in the U.S which has followed a strong bilateral cooperation between Iran and China which seems impregnable. Lately, there has been an origin and spread of the new 'UK- Virus' as its third phase which has proved to be more lethal and has lately encircled the whole West where the situation is grimmer. Resultantly, the haughty posture of the past has minimized and will diminish with the time. The UK-Virus has reached Pakistan too with velocity. Pakistan though stands better in the ratings of COVID in deaths and affectless of COVID than India, Bangladesh, Germany, France or many other countries, but look at the mean nature of the UK, who have banned flights to and from Pakistan in particular for no other than their own UK- Virus reason. History bears witness to the fact that the rise of a new global power usually results in the corresponding spread of its peculiar governance structure too. Like the structure of the "Empires" in the time of First World War and the structure of American democracy, in the post Second World War period are before us. 2021 may be the first year of the rise of the East. And this new world order, which seems to be evolving before our eyes today, will have profound impacts for Pakistan and its assumingly dysfunctional democratic enterprise. In the months and years to come, countries in our region (and perhaps across the world) may be forced to pick sides between the United States and China. Those who come to the Chinese Camp may also have to grow out of the borrowed American model of democracy and follow something closer to the "Chinese model" – where a loose democracy is coupled with a decisive writ of the State.
