MEETING WITH MR. FAWAD ALI, SENIOR DIRECTOR COMMERCIAL, DHL-PAKISTAN



Mian Imran Akbar, President SCCI welcomed Mirza Fawad Ali, Senior Director Commercial DHL Pakistan and Mr. Usman Wali, Senior Director Operations DHL Pakistan upon their visit to Sialkot Chamber on November 02, 2021. He also expressed his gratitude to the executive committee members and other participants for joining the session. He said that the export sector of Sialkot was based on SMEs and business community of Sialkot had been offering their best to develop the cottage industry. He shared with the house regarding various categories of products that were being manufactured in Sialkot and said that the Sialkot export-oriented sector experienced growth over the years and earned more than 2.5 billion USD of foreign exchange annually to support the economy of Pakistan.

He further said that DHL was an international courier company that had earned international repute by providing best services to the industry. The Business Community of Sialkot preferred to send their shipments through DHL considering DHL as logistic partner, therefore it was expected that DHL would cooperate with the industrialists to resolve the pertaining issues, he added. He listed the problems faced by Export Oriented businesses in Sialkot.

Mr. Fawad Ali thanked Mian Imran Akbar, President SCCI and stated that DHL had done its best to control the prices, since the pandemic of Covid-19 started, DHL adjusted the prices and increased rates sequentially to avoid the sudden burden on the shoulders of Exporters. He also mentioned that most of shipments were sent to USA whose Emergency Surcharge charges were only 0.2 cents per kg rather than Australia/New Zealand which was not a targeted market for exporters. Wholistically the cost of

doing business and global supply chain was disturbed in the entire world because of Covid-19, however DHL absorbed those damages and operated under loss which was also documented, he said. Moreover, just like other brands if DHL would withdraw from the market the export market might face the direct impact, he added.

A meeting of the Departmental Committee on TM & Excise was held on November 05, 2021 under the chairmanship of Rana Nadeem Ahmed. The following issues related to TMA Sialkot and Excise were discussed in the meeting:

- Encroachments and illegal parking across the city have created traffic problems that need to be addressed urgently.
- Members face difficulties in getting approval of residential, commercial and factory maps.
- There should be a joint session of the Injman-e-Tajran, TMA, Sialkot Chamber and other stakeholders to clear the encroachments across the city.
- Situation created by ETO Sialkot due to door-to-door survey for acquisition of PT-I.
- Traffic Week should be organized to create awareness

among the people regarding traffic issues.

- A Facilitation Desk should be established in Sialkot ChambertoresolveTMArelatedissues.
- Awareness among the people regarding cleanliness in the city so that they do not throw their household and factory rubbish on the roads instead of dumping it in a proper place.
- 9 Heavy vehicles such as Trucks, Dumpers, Container and Tractor Trolleys should be banned from entering the city during office and school hours.

The Chairman Committee concluded the meeting and assured to make efforts to resolve the said issues raised by the Committee Members collectively.

MEETING WITH DR. ASIF MAHMOOD JAH, FEDERAL TAX OMBUDSMAN



On 8th November, 2021, Mian Imran Akbar, President, welcomed Dr. Asif Mahmood Jah, Federal Tax Ombudsman, Officers of the Customs and Inland Revenue Departments, representatives of Sialkot Tax Bar Association and members of Sialkot Chamber. He expressed gratitude to the Honorable Federal Tax Ombudsman for establishing regional office at Sialkot in the premises of Sialkot Chamber of Commerce and Industry for facilitation to the Taxpayers.

He said that Sialkot was the hub of export-oriented industry and business people of Sialkot had always been vigilant in fulfilling their genuine tax liability. He briefed the guests about industrial set up and various products being produced in Sialkot. He mentioned various achievements of the business community in terms of compliance

to corporate social responsibility and presented the documentary to exhibit the progressive approach and vision of the Sialkot entrepreneurship. During his address, he highlighted the following issues of the business community;

- Pendency of Appeal Effect and Deferred Cases
- Returned Goods u/s 22 of the Custom Act 1969 not to betreated as Import

- Abolition of Sind Infrastructure Development Cess
- Permission for filing of joint complaint on a common issue of the Taxpayers

VISIT OF FLT. LT. MR. TAHIR FAROOQ, DEPUTY COMMISSIONER SIALKOT



Flt. Lt. Mr. Tahir Farooq, Deputy Commissioner Sialkot visited Sialkot Chamber on November 09, 2021 and shared following developments of the city. The Deputy Commissioner shared the progress on mega development projects being executed under the PICIIP programinthe city. He shared that the project got delayed due to slackness of the Contractor for which necessary warning had been issued. The DC mentioned that project would be completed on priority basis to provide relief to the citizens. He informed that construction of Pasrur road was pending/stopped due to some hurdles. He shared that upgradation/renovation of Jinnah Stadium had been

started. He also shared that Beautification and upgradation work of Ramtalai and Sheikh Moula Baksh Talab had been initiated in which state of the art sports facilities would be provided for general public. He informed that first phase of the project of construction of Aiman Abad road had been completed. Moreover, construction of 7.5 KM of Aiman Abad Road in Second Phase had been approved and tender would soon be issued. It would be connected with motorway in the upcomingphases.

Mian Imran Akbar, President Sialkot Chamber welcomed Deputy Commissioner Sialkot at Sialkot Chamber and he said that the Supreme Court of Pakistan had banned the unregistered motorcycle-rickshaws; In this regard, he requested the Deputy Commissioner for implementation of the decision in letter and spirit. The President shared that the labor from South Punjab was observed to be leaving the factories and engaging in other; the issue had led to increase in encroachment on roads and shortage of labor in factories. He further asked about the status of construction of overhead bridge of Defence Road. Whereas, Mr. Qaisar Iqbal Baryar shared that significant work on cargo container terminal from Wazirabad to Karachi had been done and requested cooperation of the District Government in this project. The Deputy Commissioner assured his full support for the completion of Ring Road and other projects/matters which were discussed in the meeting. He also assured that all necessary measures would be implemented to resolve the issues highlighted by the President Sialkot Chamber.

MEETING OF DEPARTMENTAL COMMITTEE ON LIBRARY & PUBLICATION



A meeting of the Departmental Committee on Library and

Publication was held on November 11, 2021 at SCCI. Mr. Daud Ahmed Chattha, Chairman Committee presided over the meeting in order to discuss the matters regarding the printing, distribution and charges/rates of Chamber Bulletin on monthly basis, and upgrading of Chamber Library. With the mutual consideration in the light of the suggestions and opinions offered by the members, it was recommended that the publication and timely delivery of the Bulletin on would be ensured; furthermore, the website must have a "subdomain" for the digital library. It was also suggested by the house that senior students & teachers of Universities and Colleges would be invited to write on various topics for the Chamber Bulletin.

Regarding the material of Bulletin, it was discussed that Prof. Safdar Sandal, Former Executive Committee Member would also write articles on various topics to publish; whereas, the SCCI's R&D Department would also provide research reports on key topics including major International Trade Changes, Changing Marketing Trends, Trade Fairs, Modern Technology, Import-Export Inquiries, Production Techniques and other important topics, on monthly basis. Furthermore, the environment of Library would be improved by eliminating the noise factors for making it more convenient place to study.

MEETING OF DEPARTMENTAL COMMITTEE ON ENVIRONMENTAL PROTECTION/PHA



A Meeting of Departmental Committee on Environmental Protection/PHA was held at SCCI on November 11th, 2021, wherein discussion was made to devise a holistic and comprehensive strategy and working plan of the Departmental Committee. The Meeting was moderated by Chairman Committee, and other participants gave

their input about the future working plan and making it easy for members of Sialkot Chamber of Commerce and Industry to understand Environment Protection laws and compliances. Whereas, it was suggested that Committee should arrange a series of seminars of Environment Protection Department and related topics for general awareness of the SCCI members to comply with the requirements of the Government Department and identify the steps to apply NOC from Environment Protection Department. It was suggested that a Delegation (Comprising members from SCCI and Environment Protection Department) would visit the Company to identify best Environment Friendly practices and to make a documentary on them, to depict the practices as an example for others. Chairman Committee discussed that a member/focal person from Sialkot Waste Management Company should be added in the Committee.

Mr. Muhammad Atif Project Director Sialkot Tannery Zone suggested that sector-wise Seminar(s) should be arrange of Environment Protection Department for members of SCCI to guide them the steps to get NOC and to comply with the rules. He also requested that a list of students of Environment Department of Universities from Sialkot city should be shared to offer them internship in Industry of Sialkot. After deliberation and discussion, it was decided that a series of seminars for awareness of members would be arranged in coming future, a documentary would be prepared and cost would be worked to determine the installation of Air Quality Meter to be displayed in different locations of Sialkot city.

MEETING OF THE DEPARTMENTAL COMMITTEE ON CYBER CRIME



Mr. Omar Khalid. Chairman Committee welcomed the

participants for joining the session on Cyber Crime on November 11, 2021. Chairman Committee briefed the participants about the objectives of the committee which was to spread the awareness and knowledge among members of this Chamber for their safeguard against cyber-attacks and necessary precautionary measures against Cyber threats. He shared his plan of action for the year and points for general awareness of the member(s) such as "Man in the Middle attack", "Phishing/Vishing attacks" and "Penetration testing".

Mr. Aneel Sarfraz, Senior Vice Chairman briefed the house about Man in the Middle attack in which most of the attackers enticed the victim to open an attachment which compromised their security. He suggested that member(s) should track the IP of the email before opening to make sure that the sender was their valid customer. Moreover, member(s) should dedicate a computer for business communication and office dealing and should avoid working on the computer(s) on which they browse social media and had installed third party software, he added. Mr. Qasim Malik, Vice President SCCI endorsed the points and suggested that a person from FIA should be opted as Member of the Committee on Cyber Crime. The Committee was not an ordinary Committee, future belonged to the IT World and the Chairman could opt more member if he felt any need, the young minds from various universities in the field of Computer/Information Technology should also be considered as a member of the Committee, he added.

After a detail discussion, it was decided that young Minds from Academia should be opted as member of the committee, a list of authentic cyber security experts/companies should be gathered for member(s) willing to avail their premium services and precautionary page regarding cyber security would be added in fortnightly bulletin of SCCI. It was also decided that Mr. Aneel Sarfraz, SVC would work on IT tracking and brief the member(s) about it and Mr. Moti Laal would work on G-Suite and brief the member(s) about it.

DEPARTMENTAL COMMITTEE ON SME/TRAINING AND YOUNG ENTREPRENEURS

Meeting of Departmental Committee on SME/Training and Young Entrepreneurs held on November 13, 202. Mr. Fizan Akbar, Chairman presided the meeting and shared

the plan & topics of seminars and training sessions of the year 2021-22. He stated that training for newcomers to learn Business Ethics and Exhibiting skills of Trade Exhibition. He added that Committee would request President SCCI to write letters to the Embassies, Institutes and Minister, capacity building departments (USAID, UKAID, NPO, TUSDEC and SMEDA) to get details of Capacity Building programs they were offering for the SMEs. He also stressed that the Committee would engage Universities of Sialkot to sign MOU to design capacity building Courses for SME under the supervision of President SCCI. He said that series of seminars for capacity building of the members would conduct during the year 2021-22.



Members appreciated the vision of the Chairman and ensured their support to materialize the plans for the year. Ms. Rabia Armaghan briefed about the upcoming event "Lift Pakistan "and requested that a group of Delegation should visit the event for awareness. Mr. Nadeem Ahmed also proposed that Chairman Committee should arrange a meeting with Mr. Muhammad Usman Dar, SAPM, Youth Affairs to get a special from Ehsas Program for the SME.

MEETING OF DEPARTMENTAL COMMITTEE ON SURGICAL INSTRUMENTS/HEALTH/PERSONAL CARE & ALLIED INDUSTRIES

Mr. Zeeshan Tariq, Chairman Committee welcomed the Committee Members in the 1st meeting of the tenure 2021-22 on November 12, 2021. He shared the agenda of the meeting and his aim to work for the betterment of overall industry with the cooperation of Committee. He discussed about the requirements and features of the Medical Devices Regulations (MDR) as it was a new & complicated law imposed on Surgical Sector, but people should not try to escape or avoid its implication. Everyone

must have to implement the MDR who want to survive in the national as well as in international market for the long-run. He told about working of a member to prepare a booklet for the general awareness about MDR's requirements. He furthermore, suggested that a volunteer panel should be trained and would be available for giving consultancy services to the Sialkot Surgical Industry. Regarding the Industry-Academia Linkages, he endorsed the suggestions by the members that industry should be focused to collaborate with the Universities for process improvement and innovation.

The Committee discussed about the shortage of quality material and the bottlenecks faced in imports of the materials. It was suggested that there should be a monitory authority for the local steel manufacturers (mostly in Gujranwala) to check their quality & uniformity in materials; so that, industry could get the uniform quality materials with consistent standards locally. It was also explained that skilled workforce could be produced only through the on-job skill trainings within the factory premises; he gave the example of the garments industry as they hired most of their labor from the south Punjab and providing them the accommodation and training for the permanent jobs. He recommended that surgical sector could replicate the said pattern in industry to avoid the labor issues.

MEETING OF DEPARTMENTAL COMMITTEE ON GARRISON HQ/CANTONMENT BOARD AFFAIRS



Sheikh Zahid Hameed, Chairman Committee welcomed the Committee Members in the meeting on November 15, 2021 and told about his discussion with Mian Naeem Javaid (Former President of SCCI) regarding property & construction related taxation on the residents of the

Cantonment Area of City; therefore, it was decided to call a meeting for addressing the issue on a broader perspective. "We are the regular tax payers of the Government, nothing else but we as the respectable citizen must deserve the respect from Cantonment Management; therefore, the misbehave by the Cantonment Management should be stopped" he emphasized. He presented and elaborated the official letter on "Property Tax Assessment System in Cantonments" by the Ministry of Defense, Government of Pakistan, in which it was stated that Property tax of all buildings whether residential or commercial strictly in accordance to the spirit of Cantt. Act 1942 and bye-laws made thereunder. He further elaborated the "Section 64" of the Act regarding the formulas of assessment of different types of building within the Cantonment Area. He also shared the cost of property construction per square feet and emphasized to reduce the cost up to a certain level.

Mian Naeem Javaid, Former President SCCI and other committee members discussed the said matter for their possible solutions. "There are two basic types of taxes including property tax and water tax, but there is another tax charged by the Cantonment Management under the heading of Conservation Tax, which is never changed anywhere in the world and it is an extra burden on the taxpayers; whereas, there is no particular facilitation against this taxation" they discussed. They emphasized that matter regarding taxation on the residents of Cantonment Area should be addressed but with legal consultation/advice from a senior lawyer; so that, Committee's direction to address the said matter would be on right tract and results oriented in a proper way. Mian Imran Akbar, President SCCI endorsed all the points discussed by the members and acknowledged the suggestion by them to tackle the problems; he also said that Committee should work on the matter of "Water & Property Taxation and Assessments" with the consultation of Mr. Javed Igbal, Advocate and should chalked out the strategy for future plans.

MEETING OF DEPARTMENTAL COMMITTEE ON WAPDA / SUI GAS

Meeting of the Departmental Committee on WAPDA / Sui Gas was held on November 16, 2021 at SCCI. Mr. Mian Muhammad Anwar, Chairman Committee presided over

the meeting. After Introductory Session the Chairman briefed that he had been visited the office of the General Manager SNGPL, Sialkot; Mr. Sohail Akram informed him that Government of Pakistan banned on issuing new connections due to energy crises. He further informed about the role of Committee for installation of separate line of sui gas for supply of gas to Sialkot Cantt. The Chairman said that Chief Executive Officer, GEPCO, Gujranwala, the S.E GEPCO, Sialkot and the General Manager SNGPL, Sialkot assured him all possible cooperation with the Sialkot Chamber for resolution of issues of the members of Sialkot Chamber.



He also briefed about the number case/complaints of the members of Sialkot and Sialkot Tannery Zone Electrification issues resolved by the WAPDA Committee under his supervision / Chairmanship during the year 2020-2021. He said that he visited the office of Chief Executive Officer GEPCO, Gujranwala along-with the Management of Tannery Zone Guarantee (Pvt) Ltd, Sialkot to issues related to Tannery Zone. He further informed that he also represents the Tannery Zone Guarantee Ltd as its stakeholder. Chairman Committee concluded the meeting and assured his fullest support regarding the issues/complaints of the members related to GEPCO and Sui Gas Departments.

DE-BRIEFING MEETING ON TURKEY & UKRAINE DELEGATIONS

On 16th November 2021, a meeting was called by Mr. Qasim Malik, Chairman Departmental Committee on Fair and Exhibition/Delegation to take a briefing on SCCI Trade Delegations to Turkey (TDAP Subsidized) and Ukraine (Self-financed). During the debriefing of Ukraine

Delegation Mr. Khuram Aslam, Leader of Delegation/Former Senior Vice President, shared that the execution dates of the Delegation were 20th October to 24th October 2021. He mentioned that during the visit key meetings was held with the Minister for Commerce and Ukrainian Chamber of Commerce and Industry. He further added that the Staff of Embassy and the Ambassador had done an excellent working and arranged business to business meetings with Ukrainian counterparts. He also mentioned that the Ambassador of Pakistan in Ukraine was also working on Single Country Exhibition for product of Industry of Sialkot. He added that Ukraine was a good market for Pakistan and further efforts and exchange of Trade Delegation can increase the scope of exports of Pakistan to Ukraine.



After that meeting, another de-briefing on Turkey Delegation was also given by Mr. Khuram Aslam, Leader of Delegation/Former Senior Vice President, wherein, he briefed that the execution dates of the Delegation were from November 1st to 4th 2021. He mentioned that Mr. Bilal Khan Pasha, Consul General, arranged multiple Business to Business meetings for the Delegates including MUSIAD, President Beauty Association and Media Persons of Istanbul, Turkey European Turkish Businessmen Association Istanbul Turkey and Istanbul Chamber of Commerce and Industry. He said that unfortunately, the budget asked by Consul General of Pakistan, Istanbul was not provided and less funded was approved by TDAP/Ministry of Commerce, Government of Pakistan.

MEETING OF DEPARTMENTAL COMMITTEE ON SPORTS ACTIVITIES

A meeting of the Departmental Committee on Sports

Activities was held on November 19, 2021 under the Chairmanship of Mr. Asif Ali, Chairman Committee. After Introductory Session the Chairman briefed the Agenda Point of the Meeting i.e., Friendly Cricket Match with British High Commission, Islamabad. The Chairman Committee said that the Committee planned a Cricket Match between Sialkot Chamber and British High Commission, which required approval from the Executive Committee. He said that match would be played at Islamabad due to security issues.



The Chairman Committee informed that the Match would be hosted by Sialkot Chamber of Commerce & industry, therefore, all the expenses like Ground Charges, Trophies, Medals and Lunch etc. would be paid from Chamber's funds. The other expenses like travel, hotel etc., would be on self-finance basis which would be charged from the players/participants who desired to play or accompany with the team as perthe Previous Practice.

After thorough discussion, the Committee approved to play a Cricket Match with British High commission in December 2021. As concerned to the approval of the expenses of the event, the Committee formed a Sub-Committee for preparation a feasibility report of the expenses which would be shared with committee Members. After that, it would be submitted to Executive Committeeforfinal approval.

MEETING OF DEPARTMENTAL COMMITTEE ON FAIR & EXHIBITION/DELEGATION

On November 19, 2021, Mr. Qasim Malik, Chairman welcomed the members of the committee and the meeting was started with an introduction of members of the Departmental Committee. Chairman Committee

He said that few Self-Finance Trade Delegation were also in the plan to South American Countries, Egypt, Morocco, Kuwait, and Portugal. He also mentioned that once the Delegation were approved, the Department Committee would decide to devise a special quota for Women Entrepreneurs of SCCI.



Mr. Umair Nisar, Deputy Secretary R&D briefed about the criteria of selecting Delegates of Self Finance Delegation. Whereas, members shared their remarks and reviews about the said matter.

MEETING HELD WITH MS. KATHLEEN GIBILISCO POLITICAL & ECONOMIC SECTION CHIEF CONSULATE GENERAL OF THE USA, LAHORE



On 23rd November 2021, a meeting was held with Ms. Kathleen Gibilisco Political & Economic Section Chief, US Consulate Lahore, wherein Sh. Zohaib Rafique, Senior Vice President, while giving his welcoming remarks to the

guest, highlight key issues including delay in appointments of US visas and stressed to avail the potential of trade and joint ventures between both countries. Senior Vice President, SCCI elaborated the facilities Government of Pakistan was giving to the exportoriented units and the role of Chamber in playing the role of facilitator in getting the relief for the industry. He shared that NTU LAB had many facilities to check the materials and their features but had no authentication/accreditation to provide certifications. He discussed the several issues and matters regarding industry's concerns.

Mr. Fayaz Gul, In-charge, GPO Sialkot thanked and shared about the 4 major categories of international mail; he said that charges of international freight could also be calculated on the website of Pakistan Post. He assured that he would monitor the export consignments which would be sent through GPO Sialkot and assured to resolve the problems of Business Community on priority. Pakistan Post had launched EMS Plus Service with the partnership of some courier companies which was fast, reliable/economical, and offered end to end tracking facility to the esteemed customers of Pakistan Post. He discussed the points shared by business community as well as told about their services & facilities offered ibn detail.

MEETING OF THE DEPARTMENTAL COMMITTEE ON EVENT MANAGEMENT AND LIAISON



Meeting of the Departmental Committee on Event Management and Liaison was held on November 24, 2021 at SCCI under the leadership of Mian Khalil Ahmed, Chairman Committee. The Chairman thanked the members and described the agenda point of the Meeting. At the end of the meeting, the committee members emphasized that the Awards was considered as a good step towards encouraging the exporters of Sialkot and offered their suggestions for better organization and assured their full cooperation.

ONLINE AWARENESS SESSION ON STATE BANK OF PAKISTAN'S (SBP) RE-FINANCE SCHEMES

On November 25, 2021, a webinar was arranged on the Re-finance Schemes of State Bank of Pakistan, wherein Kashif Shahzad-Deputy Chief Manager-SBP BSC Sialkot, said that the webinar was coordinated enhance the awareness of the Re-finance Schemes of SBP. Mr. Zohaib Rafique Sethi, Senior Vice President, welcomed the team of State Bank of Pakistan, BSC Sialkot at Sialkot Chamber and said that the session would enhance the understanding of members and will help in resolving the issues of those who were being refused by the Commercial Banks. He also added that SBP should keep an eye on the Commercial Banks who didn't support the exporters despite fulfilling the criteria.

Mr. Safian Taseer-Assistant Director-SBP BSC Sialkot, explained the Refinance Schemes initiated by State Bank of Pakistan for SMEs sector of Pakistan. He further elaborated that scheme which give the provision to import machinery for exports purposes. Mr. Taseer said that depending on the export performance of an exporter and upon the complete of first scheme, the percentage of interest can be decreased by the Commercial Bank(s) (as per the lending criteria). The session was followed by questions and answers session between the team of State Bank of Pakistan and members of SCCI. It was also proposed by the Chair to designate a focal person from State Bank of Pakistan BSC Sialkot to visit SCCI once a

week to educate the members about the refinance schemes offered by SBP, which was welcomed by SBP. Kashif Shahzad-Deputy Chief Manager-SBP BSC Sialkot said that he would forward the suggestion of SCCI to Head Office for consideration.

DEPARTMENTAL COMMITTEE ON MARTIAL ARTS/MMA/FITNESS & GLOVES INDUSTRY



Meeting of the Departmental Committee on Martial Arts/MMA/Fitness & Gloves Industry held on November 30, 2021. Mr. Junaid Shahid, Chairman welcomed the members in the 1st meeting of the tenure 2021-22 and thanked them. He shared his introduction and assured his fullest support to addressed the industrial issues for their resolution. The Chairman explained the SOPs of all Departmental Committees of SCCI issued by the President SCCI. Sethi (Senior Vice President, SCCI) and other committee members discussed about the matters related to cluster development to import material collectively, through establishing a material bank. It was discussed to hire the laborers from the south Punjab, giving them the trainings and facilities to sustain then in long-run. Whereas, it was emphasized that systems and human resource should be well-equipped with the sufficient as well as required knowledge in order to avoid the malpractices. It was stressed by the members that swift action should be taken on that matter by the Sialkot Industry with complete paper work to claim the high rates of rebate.

WORKSHOP ON REX REGISTRATION SYSTEM BY TDAP



Mr. Kamal Shahryar welcomed the members of Sialkot Chamber for their kind participation and interest in European GSP Scheme and GSP Plus status granted to Pakistan on December 09, 2021. He shared that Pakistan was a beneficiary for the GSP Schemes of the European Union (EU), Switzerland, Norway, Turkey, UK, USA, Canada, Australia, New Zealand, Japan, Russia, Belarus, and Kazakhstan. Accordingly, import of GSP-eligible products into these countries from Pakistan would enjoy preferential tariffs (i.e., reduced or zero import duties). He encouraged the exporters of Sialkot to make themselves well aware of the terms and conditions for the aforesaid GSP schemes to derive optimal benefit from the concessionary import duties applicable to their products while exporting to these countries. During the presentation Mr. Kamal Shahryar shared with the $participants that Pakistan completely switched \, over to \, the$ REX system on December 31, 2017; Effective January 1, 2018 TDAP stopped issuing Certificate of Origin/Form-A for exports to the EU (27 countries), Switzerland, Norway

and UK. Currently only REX-Registered exporters were authorized to issue "Statement on Origin" for their export consignments destined for EU, Switzerland, and Norway. He discussed that Registration under REX would remain open and the TDAP would continue to register exporters into the REX System, around 9,000 exporters had already been registered under REX till September 2021. Accordingly, all exporters to the EU, Switzerland, Norway and Turkey who were not yet registered were advised to get their entities registered under the REX system. He shared about the guiding documents were available on TDAP Website and also shared links about the "Preapplication Form" for registration to REX system, exporter's data displayed on EU website, REX system information displayed on official EU website etc. Mr. Kamal Shehryar explained the eligibility requirements for registration and Step by Step procedure to become Registered Exporter under REX. Furthermore, he elaborated the mechanism for necessary adjustment of REX Registration Data and making out Statement on Origin.

Referring to the ongoing development works in the city, he said that the concerned departments have started digging roads for us without on board, due to which traffic problems are being created.

Mr. Asim Bashir, Excise and Taxation Officer, Sialkot said that the entire system of excise and taxation has been computerized. The purpose of the PT-I document is to collect taxes only, with the help of which document, the ownership of the property cannot be changed or transferred.

Members shared their views and feedback on the said subject. The Senior Vice President shared that Sialkot Chamber would like to have a series of meeting with CEC after getting detailed and most relevant information from CEC.

MEETING WITH MR. AHMAD KAMAL, COMMISSIONER INLAND REVENUE

Ameeting was held with Mr. Ahmad Kamal, Commissioner Inland Revenue on December 21, 2021 at 2:00 pm at RTO Sialkot. Meeting had been called for working for withholding sales tax payable by companies under 11th schedule to the sales tax act, 1990. After holding various meetings and considering proposal of Joint Trade Bodies of Sialkot and proposal based on Departmental Working, sector-wise purchase formula has been agreed upon between Tax Department and Sialkot Chamber to settle the issue of 5% Withholding Sales Tax on Companies against purchases from unregistered persons. On the basis of above understanding, following revised purchases as percentage of exports would be considered for levy of 5% Withholding Sales Tax on Companies;

- For Surgical and Cutlery Industry @ 15% of exports madefrom July 2019 onwards.
- For Leather Garments and Gloves Industry @ 25% of exports made from July 2019 onwards.
- For Sports Goods @ 25% of exports made from July 2019 onwards.
- For Apparel, Hosiery and Garments @ 27% of exports made from July 2019 onwards.

It has been agreed further that deposit of Withholding Sales Tax by Exporter Companies as per above understanding would be final discharge of liability under the law.

DEPARTMENTAL COMMITTEE ON SURGICAL INSTRUMENTS/HEALTH/PERSONAL CARE & ALLIED INDUSTRIES

Meeting of Departmental Committee on Surgical Instruments/Health/Personal Care & Allied Industries held on December 21, 2021. Mr. Zeeshan Tariq, Chairman Committee welcomed the members and talked about the

agenda of the meeting. He shared his experience to visit the University of Sialkot (USKT) and University of Management & Technology, Sialkot (UMT) along with the Committee members and briefly explained the main points discussed with the University faculty e.g., Short skilled-based courses should be designed by the Universities with the collaboration of Industry, internship programs for students by the coordination of SCCI & Universities, providing of trained HR by the Universities to the Surgical Industry for implementation of MDR and development of ERP system etc. Chairman also emphasized to work on MDR for long term and added that an awareness session as well as a training course regarding MDR could be arranged from the platform of SCCI. Furthermore, he said that the accreditation of PNAC was valid in EU Countries; so that, coordination with those departments should be on the priority for MDR Implementation.



He introduced Mr. Jamil and shared that he had been worked on MDR, its regulation and implementation. He shard about the booklet prepared by Mr. Jamil on the helping details on MDR. He further shared that guiding document prepared by Mr. Jamil with the Committee Members to study and clear their views. Mr. Jamil elaborated the content of the document and tests required under MDR implementation. He stressed that people should have the complete knowledge about their own product and its complications, so that they would know the required testing/certifications and other obligations according to their certain products. He assured his fullest support to the industry to work on the Medical Device Regulation (MDR) either with the Universities or with the SCCI/MIDC to save the future of Surgical industry. Members shared their views and overall endorsed the suggestion/recommendations given; the Chairman concluded the meeting by thanking all as well as with some instructions for future working.

SEMINAR ON "INTELLECTUAL PROPERTY RIGHTS AND TRADEMARK & LOGO REGISTRATION IN PAKISTAN", IN COLLABORATION WITH IPO, PAKISTAN



Mr. Qasim Malik, Vice President SCCI welcomed Ms. Shakra Khurshid, Assistant Controller of Patent, IPO Pakistan for her visit to the SCCI on December 22, 2021 for an awareness session regarding "Intellectual Property Rights and Trademark & Logo Registration in Pakistan." Vice President also thanked all other participants for their participation and interest in the importance of the session. He shared that Intellectual property protection was critical to fostering innovation; without the protection of ideas, businesses and individuals would not reap the full benefits of their inventions and would focus less on research and development. He said that exporters faced unfair competition abroad, whereas buyers faced legal and safety risks from the threat of counterfeit goods entering their supply chains.

IPO Pakistan was an autonomous institution of the Government of Pakistan and was concerned with copyright, trademarks, patents, and other general types of intellectual property regulation. Sialkot-based small businesses were at a particular disadvantage regarding Intellectual Property, as they lacked the knowledge, expertise, or resources necessary to get proper recognition as a brand. The business community of Sialkot had worked for many years as a supplier to many brands but the time had come to create and introduce the world with their brands. Many small businesses of Sialkot might not have overseas personnel and operations as a

brand, so they lacked the need to be vigilant globally and the theft of their IP could often go undetected. In addition, small businesses generally did not have the level of access or the resources, such as specialized legal counsel, that might be available to larger companies.

The session would bring the knowledge and resources to help the small and medium businesses to learn about Intellectual Property Rights, Trademark and logo registration and to tackle IP protection and enforcement more effectively. Vice President SCCI suggested that IPO Pakistan should open a counter in the Sialkot Chamber for immediate information and resolution of matters of the members of this Chamber. Moreover, a series of sessions should be arranged in the future for awareness of members of the Sialkot Chamber, he added. He also proposed IPO to speed up their process of liaison with WIPO to get maximum benefits from internationally recognized intellectual property rights.

SCCI HACKATHON 2022- ANNUAL SOFTWARE DEVELOPMENT COMPETITION



The meeting was led by Mr. Adnan Akbar, Senior Vice Chairman of Departmental Committee on IT Exports; he welcomed the participants for joining the session and shared the vision of Mian Imran Akbar, President SCCI to promote IT Industry of Sialkot. During the presentation on SCCI Hackathon 2022, he shared with the participants that Hackathon would help SCCI to provide centralized platform, help to create a business incubation center, would develop knowledge economy and SCCI would provide platform for international exposure in future and could make database of IT entities in Sialkot. He also talked about the competition among software houses

and Universities and said that event would take place. He said that the registration regarding hackathon would start in December 2021 and Inauguration, demo and results would be announced in January 2022; participants would be able to submit draft of proposal online via e-form provided by SCCI. The transparency would be ensured in the event by Sialkot Chamber, whereas Certificate of Participation would be provided to all the participants; he further said that the top achiever would be given special certificates and the award ceremony would be held in Sialkot Chamber.

University of Management and Technology (UMT), University of Sialkot (USKT) and Government College Women University (GCWU) appreciated the vision of President SCCI, also shared their positive feedback and assured their fullest support in said regard. Mr. Usman Nazir (Theta Solutions) encouraged that such events should happen more frequently to revolutionize the IT industry of Sialkot. 



PAKISTAN LEATHER GARMENTS INDUSTRY

Pakistan's leather sector is in trouble and export earnings of leather and leather products have been on the decline. Exports of the leather sector include tanned leather, leather apparel and clothing, leather footwear and leather shoe upper, and all other leather products including leather bags, wallets, etc.

There are many reasons for the declining exports but some of the most important are:

- The system of collection of animal hides and skins from markets is obsolete and lots of hides and skins go to waste.
- Due to the lack of investment in the leather processing industry, most of the 800-plus tanneries produce lowto-average quality leather and as such the country cannot manufacture and export highly value-added leather products in large quantities. This keeps the average per-unit price of both tanned leather and leather products low.
- Vocational training institutes do not produce a sufficient number of highly skilled workers for the leather industry and the manufacturing units remain dependent on the unskilled and semi-skilled workforce. Similarly, leather fashion and designing institutes are few and they are not producing designers of the most fashionable leather garments and other products in sufficient numbers.
- Leather and leather garment industry of Pakistan is confronted with various challenges to survive in international market such as:
- Absence of advanced technology, shortage of human power: Absence of high-tech quality products and the shortage of skilled manpower to cater to the needs of the world market. There is a growing need to prepare labor force having capacity to produce leather garments on scientific lines and comply with the demands of international market to compete.
- High Cost of production: Cost of production is also very high in Pakistan as compared to competitors like China

and India. The high cost of various inputs, especially utilities and taxes make Pakistan's products – finished and unfinished – uncompetitive in international market.

- Environmental Impacts of leather industries in Pakistan: Leather tanning tends to be very polluting as compared to other manufacturing industries. Numerous measures are suggested to take care of the environmental hazard It causes but it is not implemented due to lack of funds. At every unit of output, the level of toxicity is high due to the heavy hides-leather converting process.
- Leather Export Associations of Pakistan There is no specific association that looks after overall leather sector, except for SMEDA, the Small and Medium Enterprise Development Association, which focuses on developing more industries, but has its hands ties due to lack of funds. The most prominent association is PLGMEA (Pakistan Leather Garments Manufacturers and Exporter's Association).

CHALLENGES AND ISSUES

Leather manufacturing sector in Pakistan can also suffer because of massive smuggling of livestock to other countries, shortage of raw material and absence of the organized dairy farming in the country. Moreover, diseases in the livestock in Pakistan can prove hurdle in the manufacturing and exports of finished products of leather. As a result the live animals are suffering from different diseases that damage the quality of the leather and tarnish the image of products at international level.

The duties on the import of tanneries related machinery need to be further reduced. The machinery made locally is technologically inferior which not only increases the cost of production but restrains from developing at par with the international market.

The problem with Pakistani policymakers is that they never follow up on the results of the policies that are introduced with much fanfare and never implement them in letter and spirit.

The leather industry consists of six sub-sectors namely, tanning, leather, footwear, leather garments, leather gloves, leather shoe uppers, and leather Goods. The Tanning industry plays a vital role in the progress of these sub-sectors by providing the basic material i.e. leather. Today, Pakistanis, are among the leading countries in the production of Leather Garments and Gloves. The leather and leather made-ups industry plays a significant role in the economy of Pakistan

At the time of independence there were only a few

tanneries producing sole leather and that too at a very small scale. However, since then this industry has been flourishing. During 1950s, some well-equipped tanneries were set up at Karachi and Lahore, while during 60s and 70s more units were established at Hyderabad Kasur, Sialkot, Multan, Sahiwal and Gujranwala. Starting with the production of picked and vegetable tanned hides and skins, the tanneries, today, are producing not only wet blue and crust, but also fully finished leather.

CREATIVITY DEFICIT

In these circumstances, much depends on the exporters' creativity and product differentiation, and a key for achieving that necessitates better designing and branding. Currently, the product range offered by Pakistan's leather industry is limited, and is concentrated more upon jackets and gloves. A few companies have come up with new products such as leather furniture and more products in footwear, but there are only a few and the potential for growth is immense.

Several producers of leather products, even in the downstream sector, are content with producing unbranded, low-priced products, and some actually manufacture their products for well-known. international brands, without any credit given to their efforts or skills, or to the country, for that matter. Because many producers merely replicate the designs sent by foreign companies, they are not able to benefit from premiums which the foreign companies accrue, and which come from the power of good designing and branding.

CONCERNS FROM THE INTERNATIONAL ARENA

While the domestic issues and challenges might be quite a few, the leather industry also has to prove its grit amidst competition from regional players such as China and India. Numerous incentives given to regional competitors by their respective governments, such as duty-drawback rates, have been oft-cited by players in the industry as a source of great grievance. Duty-drawback refers to a system whereby manufacturers of exported goods are refunded the duty paid for importing raw materials used in the manufacturing process by the government.

Take the product portfolio of Pakistan for example; the exports are largely dominated by leather garments and tanned leather, with the former making up over 40 percent of the total leather exports. On the other hand, India has a more diversified portfolio including a high percentage of footwear, made-ups such as wallets, saddlery, etc. besides leather garments which make up

around 13 percent of India's total exports. Such product differentiation can be constructive for establishing a reputable image of the domestic industry amongst international buyers, needless to say, will also help capture a bigger market.

Not much can be expected from the government either. as the still-pending implementation of the trade policy and fiscal constraints speak for themselves. For the leather industry, the tremendous growth potential is the key for success. Even players in the industry, recognize that a lot more can De done. Pray. don't let a sparkling opportunity fall in the face of indolent policy implementation and a lack of vision

CONCLUSION

There is no doubt that the leather industry needs a major pull out from the slums if it is to compete in the international trade scenario and the standards set by the World Trade Organization. It needs to overcome its weaknesses, but it will only be possible once the government realizes the importance of the leather sector to the economy, there is a transparency of funds injected into the sector by the government and brand names need to be introduced on an international scale.

With the introduction of new standards from REACH and Leather Working Group (LWG) it is now mandatory for any business involved in leather products to ensure that necessary compliance has been made right from the start of value chain which seems impossible to implement given the present scenario.

India which once had a total of USD 300 (M) against Pakistan's USD 500 (M) in leather sector has surpassed USD 5 (B) whereas, we are just around USD 1 (B). The huge growth in Indian Leather exports is purely because of proper incentives provided to the industry and facilitation in terms of Infrastructural development, Establishment of Leather Promotion Council, Product Development Centers, Leather Design Institute and most importantly effective Tannery Zones all around India.

Government should, immediate form a high powered Leather Promotion Council and establish 10-15 Tannery Zones in Leather Clusters of Pakistan with all the compliances ensured right from slaughter houses to end product.

"The Government should also encourage the vendors of Leather Industry, including Slaughter Houses, Collection Centers, Tanneries and others to recognize themselves according to latest LWG Standards and provide them with incentives for doing the same",


