PRESIDENT'S MESSAGE

Dear Members,

Sialkot Chamber of Commerce & Industry has always been at the forefront with its advocacy efforts in the best interest of the export sector of Pakistan in general and Sialkot in particular. For almost 4 decades, the premier trade body of the country has been voicing its opinions and playing its promised role in industrial development, economic growth, and sustainability. This Chamber is not just an organization but an institution wherein our collective efforts have given us the fruits of many successes. As the 39th President of SCCI, it is a moment of immense pleasure for me to present to you the Annual Report for 2022 an eventful year that brought many key developments to the existing projects as well as allowed us an opportunity to explore new horizons.

The year 2022 indeed posed several challenges for businesses across the country. We, at Sialkot Chamber, were fully cognizant of the varying dynamics and remained ever-ready to maneuver the industry through any situation as evident from a number of meetings with Government functionaries at both Federal and Provincial levels. I feel satisfied in mentioning that as always, you were our number one priority, and getting the best for our members has been at the very core of our strategy. From a number of issues getting resolved to a wide array of new services being offered to our members, Sialkot Chamber made sure we live up to your expectations with a resolve to continue our role as a catalyst of growth for our industry in the years to come.

As I assumed charge of the Presidency, I had a clear roadmap in mind with my targets set on getting the most burning issues of the industry resolved amicably and getting new projects and initiatives approved by the Government. Continuing the legacy of the Sialkot Chamber, this year also kept us busy working on various issues and projects including but not limited to the 5% Withholding Tax on Export Companies, Temporary import of Artificial Leather under SRO 492, Sales Tax on Export Processing

Zone, Revocation of SRO 1275, University of Sialkot Industrial Zone, and Safe City Program.

This year at Chamber, we also focused on capacity building and enhancing the skillset of our members through our initiative of the Business Executive Course in collaboration with top Consultants and Trainers of Pakistan.

The following report highlights the key progress areas for the year 2022:

1. ISSUE OF DUTY-FREE IMPORT OF PU LEATHER UNDER SRO 492 RESOLVED

I am pleased to share with you that after strong advocacy and lobbying efforts of the Sialkot Chamber of Commerce & Industry, the Federal Board of Revenue allowed the import of PU Leather under the SRO 492 (I)/2009 vide their clarification C.No.11(17)DRD/2010(PT-I) issued on May 12, 2022. This was a breakthrough achievement of this Chamber as the deadlock was persisting for last many months.

Sialkot Chamber took up the issue with all the stakeholders including the Finance Minister, Commerce Minister, Chairman FBR, and Member Customs (Policy). In this regard, a delegation led by the undersigned had a meeting with the aforementioned Government functionaries and pleaded that Synthetic Leather or Polyurethane Leather is different from natural leather as it is made of elastomeric polymers and rubber and is completely identifiable after value addition.

We also informed the Government that the impact of barring duty-free PU Leather imports would be disastrous for the Football Manufacturing and Export Sector of Pakistan as the annual export earnings of the sector stand at USD 120 (M) which can peak at USD 200 (M) during the world cup season and all the business could be lost to China and India.

Moreover, the import of lining material was also allowed under the aforementioned SRO which would immensely benefit the Leather Sector. I remain thankful to Mr. Miftah Ismail, Finance Minister, Mr. Naveed Qamar, Commerce Minister, and Mr. Asim Ahmad, Chairman FBR for understanding the gravity of the situation and accepting our demands on merit. I would like to especially thank Khawaja Muhammad Asif, Federal Minister for Defence for his unwavering support extended to the Sialkot Chamber.

2. ISSUE OF 5% WITHHOLDING SALES TAX AGAINST PURCHASES FROM UNREGISTERED PERSONS

The issue of levy of 5% Withholding Sales Tax against unregistered purchases has been a disadvantage for the Corporate Sector of Sialkot. This Chamber has always maintained that 5% withholding Sales Tax on Exporter Companies against purchases from unregistered persons should be abolished with retrospective effect i.e., from July 1, 2019. As I took over the Presidency, this was the first issue I took up with the Government and I am pleased to share with you that we were successful in getting partial relief as leather and surgical sectors were made exempt from the levy of the aforementioned tax. This was indeed a huge development as we were able to break the deadlock thanks to the strenuous efforts of the team working on the project under my supervision.

The announcement was made by Mr. Miftah Ismail, Honorable Finance Minister in the National Assembly session held on June 24, 2022. We understand that the issue is of equal significance to other sectors and I would like to assure you that we are in continuous follow-up with the Government to extend the facility as ab initio for other sectors as well.

Here, I would like to thank and acknowledge the services of Mr. Ahmed Zulfiqar Hayat, Chairman Departmental Committee on FBR/Taxation in getting the issue resolved for the industry.

3. ISSUE OF SALES TAX ON EPZ

Supply of goods or import of goods in Export Processing Zones has always been exempt from levy of Sales Tax through the Sixth Schedule of the Sales Tax Act. However, The Federal Government through the Finance Bill 2021 had omitted Entry No.102 of the Sixth Schedule of Sales Tax Act, 1990 withdrawing the Sales Tax Exemption to the units in EPZ. The Sales Tax exemption has been a major incentive for the investors of the EPZ and the foreign companies wishing to bring FDI to Pakistan.

Sialkot Chamber immediately took up the matter with relevant quarters at the Ministry of Finance, Federal Board of Revenue, and EPZA. Thankfully, the issue was resolved and the amendment was retracted to allow Sales Tax exemption to the units in EPZ.

4. SRO 1275 - REVOCATION OF MINIMUM EXPORT PRICE

I am pleased to share that after strenuous efforts and consistent follow-up of this Chamber, the Ministry of Commerce through its SRO 1275 (i)/2021 dated September 30, 2021, accepted a long-standing proposal of the Sialkot Chamber for exemption of Minimum Price Fixation for Beauty and Single Use Instruments Sector by making an amendment in Export Policy Order 2020.`

As per the amendment, the aforesaid order paragraph-14 and schedule-iv thereto shall be omitted (which exempts the HS Codes mentioned in SRO 243 (i)/2011, dated March 14, 2011, from the Minimum Price Fixation obligation.

The development proved to be a huge relief for the Beauty and Single Use sector to unleash its real potential.

5. SCCI BUSINESS EXECUTIVE COURSE

Training and enhancing the skill set of our members has been a domain of particular interest for the Sialkot Chamber. We take pride in coordinating and facilitating tailormade workshops and awareness seminars on all the topics of interest to our members as we believe that sharing of knowledge is the key component of creating a conducing environment for the businesses.

I am pleased to share with you that this year we took the initiative of the Business Executive Course to train the new exporters and aspirants through several courses to equip them with correct and up-to-date knowledge of entering into the export business. I would like to thank Mr. Zohaib Rafique Sethi, Senior Vice President, for his support in the execution of the project. I am pleased to mention that a total of 10 courses have been offered till August 10, 2022.

6. ISSUE OF FREE SALE CERTIFICATE

Issuance of Free Sale Certificate had become a hassle for the exporters especially in the surgical sector as the District Health Office had stopped the issuance. The certificate is of paramount importance and a key requirement for foreign buyers. This Chamber was quick to take up the matter with the district administration and thankfully the office of the DHO Sialkot agreed and reinitiated the issuance of Free Sale Certificates.

7. FACILITATION DESKS FOR MEMBERS

Sialkot Chamber has been an avid supporter of offering one window services to its members. We understand that an average exporter has to deal with numerous departments for various services pertaining to their businesses. In order to make the whole process hassle-free and facilitate our members, we entered into arrangements with various Government Departments to offer their services under one roof of the Sialkot Chamber. I am pleased to mention that we were successful in setting up the following facilitation desks for the members:

- a) GEPCO Facilitation Desk
- b) Municipal Corporation Sialkot's Facilitation Desk
- c) Customs Facilitation Desk
- d) Pakistan Single Window Facilitation Desk

8. PROJECT OF SAFE CITY

The project of Sialkot Safe City has been very close to my heart as I had announced it in my speech while assuming charge at the Annual General Meeting. At that time I had no idea when the project would be approved by the Government but I was firm with my resolve to set its foundations and enter it into the pipeline.

The prevailing security and traffic situation of Sialkot has necessitated that a sophisticated IC3 system is installed in the city especially considering the city's strategic importance. In this regard, I had several meetings with stakeholders at both provincial and federal levels. Thanks to the Almighty, the project was approved within my tenure asthe Government of Punjab officially included it in its Annual Development Program at the cost of PKR 1.936 (B).

The initial amount for developing feasibility has been allocated with a major chunk of funding expected to be released this year.

9. LEATHER PROJECT UNDER TUSDEC

Sialkot Chamber has made concerted efforts with Technology Upgradation and Skill Development Company in taking initiatives for the betterment of our sectors. We believe that manufacturing process enhancement and technology benchmarking are two key components if we are to compete globally with our products. Last year a project of the state of an art dyeing facility was initiated for which necessary funds were allocated by TUSDEC. Along the same lines, this vear we have initiated the project of CE Marking Lab in collaboration with TUSDEC. The lab would serve to localize the testing requirements of the leather sector by providing accredited testing services within Pakistan. Previously, the services of international labs were hired which proved to be an expensive undertaking for our exporters.

10. PAKISTAN ENGINEERING COUNCIL

To achieve strong export growth, the industry must work on its expansion, diversification of product lines, adoption of high-tech manufacturing solutions, and upgrading skills of its human resource at par with global standards. It is also significant that the industry prepares itself for the ever-changing dynamics of the modern world and rapidly evolving social compliances.

If we are to take the Industry of Sialkot to the next level and double our exports in the years to come, it is imperative that we create an enabling ecosystem through which a skilled human resource in the shape of technologists in respective sectors can be produced through the collaboration of all stakeholders and synergy of industry and academia. I am pleased to mention that this year, both SCCI and PEC took cognizance of the matter and agreed to enter into a collaboration through which several initiatives would be taken including joint sectoral research, facilitation in final year projects for engineering students to develop indigenous solutions for industry and most importantly providing internships to Engineering Graduates in the industry of Sialkot.

Here, I would like to extend my heartiest gratitude to the Pakistan Engineering Council for pledging PKR 20,000 per intern for 6 months whereas PKR 10,000 would be paid by the interested company. Never before has a project of such magnitude been undertaken with such a lucrative financial offering creating a win-win situation for both the graduates and the industrialists.

It is indeed a good opportunity for the manufacturing sector of Sialkot to hire quality produce from the top-ranked engineering universities at subsidized rates whereas, the engineering graduates would be able to get the feel of the industrial dynamism prevalent in the value-added sectors of the city.

I firmly believe that this initiative would improve the skills set of graduates and aid in bridging the gap between industries and academia resulting in better employment opportunities for young engineers and manufacturing growth through process innovation and product development. I would like to thank Mr. Qasim Malik, Vice President of Sialkot Chamber for his dedicated efforts in the execution of the project.

11. SME FINANCING CLINICS

Access to finance has always been an important topic for Sialkot Chamber. It is a matter of delight that our hard work of several years was met with a green light from the Government and several financing schemes dedicated to the SME sector of Sialkot were introduced including the clean lending facility. However, we observed that the commercial banks were not implementing the schemes in their true spirit either due to lack of capability or will. Sialkot Chamber took up the matter with the State Bank of Pakistan and arranged several SME Financing Clinics aimed at providing awareness to the members and encouraging banks to process the application of SMEs. I am glad that scores of our members benefitted from the initiative and successfully secured financing as per their needs.

12. EXPORT KNOWLEDGE COMPENDIUM

I still remember the days when I took up the export business as my professional career in my youth. It brings back so many memories of the struggle and hard work I had to put in to establish my business. But times have changed and global markets have evolved posing new challenges and adding to the complexity of the export business. I understand that it is extremely difficult for a new entrant to adapt to the same challenges and learn the tricks of the trade. On the other hand, it is our responsibility as the seniors of the industry to guide our youth so that they can make healthy career choices and establish themselves as the exporters of the future.

In view of the same, this year we planned on developing a holistic export knowledge compendium in the Urdu language to allow the new members to understand the art of export and all of its dynamics in a book form. The task is being executed in collaboration with the Government College Women University to convert all the practical knowledge of export into a book which would be offered to new members and youth aspiring for export business. The work on the project is in process and soon we would host a grand launch ceremony.

13. ISSUE OF PROPERTY TAX

The Punjab Government had levied a tax on properties other than agricultural land abutting National/ Provincial highways under section 10 of the Punjab Finance Act, 2019. The tax had resulted in an undue financial burden on the exporters of Sialkot as most of them belong to the SME category. It is pertinent to mention that due to a lack of proper industrial estates the industrial units have been dispersed within and outside the city and on roads including National and Provincial Highways.

Sialkot Chamber took up the matter with the Honorable Prime Minister Mian Muhammad Shehbaz Sharif and other key Government functionaries. Thankfully, our point was well taken by the Chief Secretary Punjab in a meeting held on June 16, 2022, wherein we emphasized that all Export Oriented Industrial units of Sialkot may kindly be exempted from the levy of tax under Section 10 of the Punjab Finance Act.

The Punjab Excise department has initiated necessary work to exempt the export factories from the levy of the aforementioned tax and soon a proper notification in said regard would be issued.

14. INFRASTRUCTURE PROJECTS

The city of Sialkot which is 0.5% of the total population of Pakistan and contributes 10% to the total Exports of Pakistan is in dire need of proper infrastructure and civic amenities. We cannot help but notice that we are being ignored in terms of development and infrastructure needs and civic amenity requirements remain un-attended giving an unhealthy and undeveloped look to Sialkot. It is also regretted that apart from the depleting condition of road infrastructure, the development projects that have been initiated are pending completion for years now.

Sialkot Chamber has always gone beyond its role as a business organization and has raised its voice at necessary forums for well being of the city. This year we were actively involved with the Punjab Government and I am glad to share the following updates in said regard:

a) The Project of Sialkot-Pasrur Road would be completed on priority. Funds of PKR 500 (M) have been allocated in the ADP 2022-23 and approval for further release has been taken by the Punjab Government. The Chief Secretary informed that new funds would be released after the exhaustion of the PKR 500 (M). The total project cost has been estimated at PKR 1.924 (B).

b) The Government of Punjab has approved the carpeting of the 16 KM section of Sambrial to Wazirabad Road. Moreover, the project of Sambrial to Sialkot Airport Road would soon be executed.

c) The project of widening of Muzaffarpur Railway Crossing would soon be initiated under the supervision of Secretary C&W.

d) Feasibility on the creation of a link from Aimenabad Road to Lahore Sialkot Motorway has been ordered. Necessary funds for the project would be allocated after the study.

e) The project of Sialkot Gymkhana would be initiated. The Honorable Chief Secretary agreed on the need for such a facility in Sialkot and promised early developments in this regard.

f) The Chief Secretary Punjab also gave his nod for the establishment of E-Sahulat Markaz within the premises of the Sialkot Chamber. PITB would be executing the project after the feasibility study.

15. AMAZON TRAINING MODULE

Sialkot Chamber's Knowledge series is a remarkable initiative taken by the Research & Development wing to provide knowledge-based videos for the benefit and awareness of its members. The project was focused to identify trending topics of trade and record easy to understand videos. I am glad that this year we rolled out a complete course on Amazon which is available on our website and all social media platforms. I am sure that the series would continue in the future with more interesting topics.

16. ORACLE CLOUD INFRASTRUCTURE FREE TRAINING & CERTIFICATION PROGRAM

As I assumed the office of the President, I presented a vision to identify new sectors of export from Sialkot. Indeed the traditional sectors are a hallmark of the success of the city yet I have always believed that new sectors should be included in the everdiversified trading spectrum of the city to quadruple our exports in the years to come. On the other hand, we have a huge youth resource pool graduating from Universities that should be channelized and I believe that IT and Software Exports is one arena wherein our youngsters can create many laurels.

You would be pleased to note that the freelance industry of Sialkot isthriving at a steady pace and earning a decent foreign exchange but the sector remains unchannelized. This year we decided to explore the possibilities of developing the IT Export Sector of Sialkot and have met various stakeholders from the industry. As a first step, we entered into a major collaboration with Oracle, the world's top software company, and offered their free training and certification program on cloud infrastructure for the youth of Sialkot. The program was a huge success as many candidates enrolled themselves for the program. I am affirmative that with more concerted efforts IT exports of Sialkot with stand in line with other prominent sectors like Surgical, Sports, and Leather.

17. PROJECT OF INCUBATION CENTRE

As mentioned earlier, in order for us to develop new sectors like Information Technology, it is imperative that the necessary ecosystem is provided to the young minds with bright ideas where they can find investments and commercialize their products and services. It is high time that the city of Sialkot has such a setup that is backed by venture capitalists, mentors, and all the facilitative interventions to incubate the success stories of the future.

In this regard, this year we have decided to set up an incubation center in Sialkot so that projects related to the existing industry as well as new sectors could be identified and incubated. In view of the same, we have had meetings with various industry experts including the CEO Nayatel, Management of the National Incubation Centre, and Ignite. I am hopeful that soon a state-of-the-art business incubation setup would be made available for entrepreneurs of the city.

18. ONLINE JOB PORTAL

Sialkot Chamber is always striving to bring new services for the ease of its members. In the same pursuit, I am pleased to share that SCCI developed an Online Job Portal wherein the members will be given access to numerous Resumes of willing candidates (fresh and experienced) while looking for eligible candidates for jobs in their factories.

It may be mentioned that previously the Resumes/ Curriculum vitae (CVs) were submitted to the Sialkot Chamber of Commerce and Industry in hard form, whereas the online portal will help employers to contact directly to the candidate through (email correspondence/chat facility available within the portal).

The Online Job Portal is live and would not only benefit the members but also the fresh graduates aspiring to become a contributing part of the Industry of Sialkot.

19. ISSUES PERTAINING TO EXPORT PROCESSING ZONE SIALKOT

The Export Processing Zone Sialkot has been a long-standing unresolved issue in the industry. Since its inception, it has failed to attract manufacturers to develop its projects due to stringent custom laws and management issues on the part of the Punjab Small Industries Corporation (PSIC). Throughout this year, the issue of EPZ was among our top agenda points as we had several meetings with the stakeholders including the Ministry of Industries, Federal Board of Revenue, Industries Commerce & Investment Department Punjab, Punjab Small Industries Corporation, and Export Processing Zone Authority. I am pleased to mention that the cancellation of plots would soon be reverted through a proper mechanism and the issues pertaining to Customs would be resolved within this year.

Moreover, expedited notification of BOM of Small Industrial Estate and Sialkot EPZ would be ensured by the Punjab Government.

20. THE UNIVERSITY OF APPLIED ENGINEERING AND EMERGING TECHNOLOGIES SIALKOT (UAEET)

As you know that the project of the University of Applied Engineering and Emerging Technologies (UAEET) was approved in 2021 as a result of strong lobbying and advocacy of this Chamber. I am pleased to mention that since the approval, this Chamber has been in continuous follow-up with the Provincial & Federal Governments for the earliest possible execution. I am pleased to share the following updates on the project:

- a) The Construction work for Phase-I of the project is in full swing by the contractor (CCECC-SALMAN JV). The phase is estimated to becompleted by September 2024.
- b) Punjab and Federal Governments have released the initial funding of PKR 1.37 (B) to the Project Office.
- c) The Charter of the University of Applied Engineering and Emerging Technologies (UAEET) has been approved by the Cabinet and would be approved as an ordinance within this week.
- d) HR Positions have been advertised and soon a Project Director would be hired.
- e) The Project Office would soon start working within the premises of the Sialkot Chamber.
- f) Tenders for the main building have been awarded and construction is due to start immediately.
- g) Work on Pre-Fabricated Building is in progress that would allow the University to start its classes within this year (Fall 2022).
- MOUs have been signed with Foreign Univesities including GDUT China, MCI Austria, FH Joanneum Graz, HUST China, and Johannes Kepler University.

The project is finally becoming a reality after years of struggle and efforts of the Sialkot Chamber. We are affirmative that after completion, the University is going to change the fate of the region by heralding a new era of industrialization. I would especially like to thank all the political leadership for their taking patronage of the project and commitment to this goal.

21. SIALKOT INDUSTRIAL ZONE

Sialkot Industrial Zone, the project for the future expansion of the city was conceived by the business leaders of Sialkot in 2016 and since then many headways had been made. I must appreciate the Former President Sialkot Chamber who actively followed up on the project until the baton was handed over to me.

Throughout my tenure and among all the meetings held, this has been the top agenda point. Although the project was principally approved and announced by the Prime Minister, no proper development could be made by the Government of Punjab. I am grateful to the Almighty's Blessings that the project of Sialkot Industrial Zone has officially been initiated as the tender for the development of a feasibility study and the master plan was given to NESPAK this year. The feasibility report is due to be submitted by September 15, 2022, followed by the necessary process for land acquisition at 1300 acres of the Sahowala Site.

Members would be pleased to note that the Punjab Industrial Estate Development & Management Company has also solicited official approval for Section 4 of the Land Acquisition Act on the proposed site beforehand to expedite the working.

22. PARTICIPATION IN INTERNATIONAL TRADE DELEGATIONS & EVENTS

Sialkot Chamber has been known to send international trade delegations on both self finances and subsidy basis. Although the past 2 years were relatively slow considering the pandemic situation, this year proved to be a rebound as we remain committed to exploring both traditional and nontraditional markets. In the same spirit, the Sialkot Chamber of Commerce and Industry collaborated with United States Agency for International Development (USAID) to organize a Single Country Exhibition "Made in Pakistan" during the month of May 2022 in Almaty, Kazakhstan, in which more than 20 companies participated. Similarly, another venture was made in collaboration with the Asia Pacific Leather Fair (APLF) in which more than 13 companies from Sialkot were sponsored by APLF in "Buyer Hosted Programme" at APLF Dubai in the month of March 2022.

SCCI also announced multi-sectoral Trade Delegations to Japan and Argentina to provide opportunities to SMEs to make business-to-business match-making. I would like to congratulate Mr. Qasim Malik, Vice President and Chairman of the Committee on Fairs & Exhibitions/Delegations for working tirelessly on the task.

23. ESTABLISHMENT OF A MODERN DYEING FACILITY IN SIALKOT CITY

Sialkot Chamber of Commerce and Industry (SCCI) has been vocally proposing a State of the Art "Modern Dyeing Facility" within Sialkot City for the Textile Industry of Sialkot under the National Strategic Programme of Acquisition of Industrial Technology (NSPAIT).

I am pleased to mention that the project was approved on CDWP Forum on 29th November 2021, with a total worth of PKR 3.206 billion, the project contains the Testing Laboratory for Technical Textile and Less Water Intensive Dyeing Facility, which would be established at Sports and Industrial Development Center (SIDC).

Moreover, SCCI has also proposed to initiate an intervention for the Leather Sector, against which a proposal for the establishment of a CE Marking Lab has been submitted to TUSDEC, against which PC-1 is under approval process.

24. CHILD AND SOCIAL DEVELOPMENT ORGANIZATION

Child and Social Development Organization is a flagship project of the Sialkot Chamber of Commerce and Industry established as a result of a partnership between the United Nations Children Fund, International Labor Organization (ILO), and this Chamber to eliminate child labor from the Soccer ball industry of Sialkot in 1997 in Atlanta Georgia. Currently, over 1000 privileged are getting free-of-cost education in the 7 schools of CSDO in slum and far-flung areas of the Sialkot District.

In order to ensure the project's sustainability Sialkot Chamber had requested the Federal Government for a grant of PKR 96 (M) that was thankfully approved by the Export Development Fund however, this year we were successful in getting PKR 15 (M) allocated.

25. SPORTS INDUSTRIES DEVELOPMENT CENTRE

Sports Industries Development Centre (SIDC) is a project of the Small and Medium Enterprise Development Authority (SMEDA) funded by the Ministry of Industries and Production (MoI&P) Government of Pakistan, to help the sports goods sector to adopt the new technology of Mechanized Thermo Laminated Balls by providing the production facilities for SME's, Technical Advisory Services, Mold Making Machinery Services and Training to Manpower. SIDC proudly introduces itself as an ISO 9001:2015 certified manufacturer of Bladders, Thermo Laminated Soccer Balls, Futsal Balls, Rubberized Basketballs, and Volleyballs using state-of-the-art technology.

SIDC has manufactured the following quantity of products in FY: 2021-22 for international brands through the local industry.

- a) American balls / Rugby ball & Volleyball samples are also developed. SIDC has developed a number of different types of dies for manufacturing bladders/ balls, etc for local industry.
- b) SIDC has facilitated SMEs for manufacturing around 3.71 million balls which supports and upgrades the industry and increases the exports of Pakistan.
- c) SIDC has facilitated/ help about 13 companies with the setup of their own thermo units by making their linkage with the imported machinery suppliers and many through reverse engineering. Some other organizations have set their industrial units by copying and getting help from the SIDC production unit.
- d) SIDC has facilitated different companies to improve their production process.
- e) SIDC have conducted laboratory test of balls for industry and also R&D work done on different products for industry. Workshop facilities are also provided to the industry regarding Teflon coating of molds, etc.
- f) SIDC is an ISO 9001:2015 QMS certified organization.
- g) PC-IV of the project submitted to Mol&P.
- Project is managing its operational expenses by generating revenues by providing services to SMEs and local industry.
- i) Exit Strategy:- SIDC project may merge into

SMEDA as a non-developmental project and operate as a subsidiary of SMEDA. SIDC may provide service and R&D facilities to SMEs / local and foreign clients directly.

26. PRODUCT DEVELOPMENT CENTRE

Product Development Center (PDC) for Composites Based Sports Goods is a project of the Small and Medium Enterprise Development Authority (SMEDA), Ministry of Industries & Production (Mol&P), Government of Pakistan to provide Common Facility Services to the sports sector in the manufacturing of Composites Based Sports Goods, increase exports and enhance productivity by providing technical consultancy services, to provide skilled workforce to the industry, laboratory testing of products and raw material, and to development of Prototypes for different products.

PROJECT OBJECTIVES

- Provide Common Facility Services in the manufacturing of composite sports goods i.e. Hockey sticks, Baseball and Cricket bats, Billiard Ques, Rackets, Fishing Tackle, Golf sticks, etc.
- Provide skilled workforce to industry for the composites based sports goods i.e. Hockey, Golf Sticks, Bats, Rackets, etc.
- Laboratory testing of products and raw material.
- Help develop imported machinery locally.
- Development of Prototypes for different products.
- Enhance productivity by providing technical consultancy services to new and existing industrial units.

PROJECT PROGRESS UPDATE:

- Project was approved on October 19, 2017.
- Civil Work completed and building handed over.
- Procurement of Machinery is completed.

Installation & commissioning will be initiated.

- Furniture & Fixture and IT Equipment procured.
- Project Staff hired as per requirement.

PROPOSED FACILITIES/ SERVICES TO SMEs AND LOCAL INDUSTRY

- Prototype Development: As one of the major components of the services, the Center would conduct research on the development of prototypes for composite-based sports goods, which the industry is still unable to market properly due to a lack of technical knowhow. The strategy will be to graduate industry from basic to advanced/high tech sports goods such as; Field, Roller and Ice hockey sticks, Baseball and Cricket bats. Billiard Ques, Rackets, & Fishing Tackle, Golf sticks, Water sports equipment, Snow sports.
- Testing Facilities: Provision of chemical and physical testing would be available at the center to analyze the material composition (mix) and physical strength of the product(s).
- Technical Consultancy: In order to build the capacity of the private sector to improve productivity, the Center would provide technical knowhow to the units that are facing problems in manufacturing composites-based products which may include the appropriate composition of raw materials to achieve desired weight & strength, selection of appropriate manufacturing process, machine, etc.
- Training of Labor: Center would be able to impart training in various fields of composite technology including; Material Identification & Selection, Inspection & Testing, Basic Machine Operations, and Composite Technology
- CFC Services: The center will also provide common facility services to the Sports goods sector in the manufacturing of the above-mentioned products.

27. AIRSIAL

AirSial has become an identity of Sialkot and has proved its mettle in a short span of time. With a rate of 98% Punctuality, 100% Regularity, and quality inflight services, the trailblazing airline has set the bar high and earned a positive perception rating among its clientage. With more than 2 years of flight operations, 5688 successful flights to date, and thousands of satisfied passengers, the AirSial is now ready to spread its wings to international destinations. This year, we took up the matter with the Federal Government for expedited approval of the International Operator license and I am more than pleased to announce that our request has been approved. Soon the mark of Sialkot would be witnessed in the skies of the Saud Arabia, United Arab Emirates, Iraq, Iran and other international destinations

28. SIALKOT TANNERY ZONE

The tanning industry is very important for Pakistan as it fetches more than 1.0 billion US\$ annually and is a source of employment. It was observed in the past few years the export of the leather industry is on the decline and one of the major issues is compliance with international environmental standards. The growth of the leather sector has, however, been restrained by an inability of the leather industry to meet rigorous customer requirements and compliance regulations of the importing countries. This is particularly important for the European Union (EU) markets as Pakistan was granted GSP+ status. Now a new requirement from the Brands of the European Union (EU) has been introduced which is the compliance of the Leather Working Group (LWG). In the future, without compliance with LWG regulations, no one can export its product to Europe / America.

There are 250 tanneries located in 10 different clusters, scattered all around Sialkot city and suburbs. These 250 tanneries of Sialkot are categorized as SMEs, while the products produces by these SMEs are 100% for export to Europe & USA. Being SMEs they are unable to meet the international standards, which are becoming more and more stringent with time. The main reasons for noncompliance are weak financials and not having technical know-how.

STZ project is considered a mandatory project, which is also look-after by Environment Projection Department (EPD), Govt. of Punjab, soon after the completion of STZ, EPD will force all 250 tanneries to shift to Sialkot Tannery Zone.

It is encouraging to share that the Basic infrastructure of STZ including roads, drains, and Electricity Network has been completed, whereas experimental runs of the Combined Effluent Treatment Plant are expected to be conducted in December. In the light of the development progress, The Plot Holders are formally invited to start construction of their tanneries and it is expected that in the next two years tanneries from Sialkot city will be relocated to the STZ.

29. KHUD KIFALAT ROZGAR TRUST

The model project has garnered acclaim from all walks of society for being a unique case study providing interest-free loans to the borrowers enabling them to start their businesses and find financial sustenance. Following are the key highlights of the project.







After the Almighty S.W.T., I would like to thank my Fellow Office Bearers, Executive Committee, Chairmen of Departmental committees, and the capable team of the Sialkot Chamber of Commerce & Industry who put their faith in me and made everything possible with their dedication and collaboration. I am humbled by the services I have rendered to the members of the Sialkot Chamber of Commerce & Industry by issuing visa recommendation letters which have helped them get easy access to the international markets.

This all has been made possible with the support of my leadership, their trust in my abilities, and giving encouragement to serve the business community of Sialkot.

MR. FARRUKH H. KHAN CEO/MD OF PAKISTAN STOCK EXCHANGE

Mr. Farrukh H. Khan, CEO/MD of Pakistan Stock Exchange (PSX) visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President of SCCI welcomed the guest and expressed his satisfaction that the Pakistan Stock exchange was being led by Mr. Farrukh an experienced economist who also provided his services in the privatization of various organizations, guiding in financial matters, and bringing international investment to Pakistan. He explained the dynamics of the Industry and SME-based culture of the city. The President addressed the audience that SMEs were considered important in the entire world for their role in boosting the economy, generating employment, skill enhancement of laborers, equally distribution of wealth, and promotion of trade.

"Sialkot is considered the hub of SMEs and they had been offering their best to develop the cottage industry, the goods manufactured in Sialkot carried global repute and demand in the international market", he added. Mr. Akbar gave a brief on all the industrial sectors including sports, sportswear, surgical, dental, beauty instruments, leather products, gloves, military uniforms, badges, musical instruments, etc.

The President SCCI stated that, even though the COVID-19 pandemic had damaged the big economies, the exportoriented sector of Sialkot experienced growth and earned more than 2.2 billion USD foreign exchange to support the economy of Pakistan. "Pakistan Stock exchange had played its role well to bring investment to SMEs to increase their capital and valuation of assets", the President appreciated. He also shared about the exceptional work of Sialkot's Business Community in the social & welfare sector. Mr. Farrukh H. Khan thanked the President Chamber and invited participants to visit Pakistan Stock Market in Karachi to get an introduction and awareness about the capital market. He shared that the PSX had the vision to provide a fair, transparent, and efficient marketplace to facilitate capital formation for the benefit of all stakeholders.

PSX had achieved many milestones such as a 20% stake of PSX was acquired by the general public by public offering in June 2021. "PSX ownership is shared between China Financial Futures Exchange, Shanghai Stock Exchange, Shenzhen Stock Exchange, Pak-China Investment Company Limited, and HBL, where patterns of shareholding are divided into 40% to Chinese Consortium and 60% General Public, Corporate Entities & Other Foreign Investors", he added. He shared about the role of PSX in the economy as a capital provider to the businesses, a growth indicator, and a source to attract foreign exchange/capital, etc. Companies listed on PSX were providing employment and benefits to millions of Pakistanis and their families and generated significant tax income for the Government of Pakistan.





Visit of SYED WAHAJ SIRAJ CHIEF EXECUTIVE OFFICER & CO-FOUNDER OF NAYATEL

Syed Wahaj Siraj, Chief Executive Officer & Co-Founder Nayatel, called on Mian Imran Akbar, President, Sialkot Chamber for a meeting to discuss avenues of cooperation and promotion of ICT Exports from the Industrial City of Sialkot. Mian Imran Akbar, President of SCCI lauded the role of Nayatel in spearheading the tech revolution in Pakistan by providing cutting-edge Internet, Cloud, and scores of other ICT services to the industry and the consumer market. The President Chamber said that Pakistan was making strides in domains of Software Exports, ECommerce,and Freelancing and that the tech industry owed a great deal to high-speed internet providers like Nayatel.

Mian Imran Akbar also shared his vision for a bustling IT Industry in Sialkot apart from already established sectors. He was of the view that the talent of the youth of Sialkot should be channelized in this domain and that the IT graduates of the city should be given a platform to exploit the tremendous potential of the global IT market. The President solicited support from Nayatel Chief in realizing the vision and building the necessary infrastructure in Sialkot.

He said that Sialkot had become a global phenomenon thanks to its hardworking craftsmen and business leaders working in various sectors. He also acknowledged the self-reliance of the people of Sialkot which had led them to successfully execute mega projects like Airport, Dry port, and Airline. Mr. Siraj stressed that the model of Sialkot should be replicated across Pakistan. During the meeting, Mr. Wahaj Siraj announced that Nayatel would soon be launching in Sialkot with cutting-edge services for both the Corporate and Consumer market. He also mentioned offering tailor-made services for SMEs of Sialkot including secured email servers, cloud-based camera security, and penetration testing. Moreover, he assured the President and Executive Committee Members of his full support in realizing the vision of establishing an IT Export Sector in Sialkot.

Mian Imran Akbar, President, and Mr. Wahaj Siraj CEO of Nayatel resolved to work jointly on the project of a state-of the-art Incubation Centre in Sialkot on the model of Ignite and National Incubation Centre (NIC). Both the gentlemen also agreed to work for the establishment of Sialkot Software Technology Park. The projects would be aimed to motivate the youth of the city to initiate ICT ventures. The President said that with the establishment of a thriving IT Industry, Sialkot's exports could grow significantly in the years to come.





Visit of MR. FAWAD ALI SENIOR DIRECTOR COMMERCIAL, DHL-PAKISTAN

Mr. Fawad Ali, Senior Director Commercial, DHL-Pakistan visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed Mirza Fawad Ali, Senior Director Commercial DHL-Pakistan, and Mr. Usman Wali, Senior Director Operations DHL-Pakistan upon their visit to Sialkot Chamber. President SCCI mentioned that DHL was an international courier company that had earned international repute by providing the best services to the industry. The Business Community of Sialkot preferred to send their shipments through DHL considering DHL as a logistic partner, therefore it was expected that DHL would cooperate with the industrialists to resolve the pertaining issues, he added. He listed the problems faced by Export Oriented businesses in Sialkot. He said that COVID-19 had affected businesses in the entire world, due to which courier Companies increased freight charges that had a negative impact on the promotion of national export and the economy.

President also suggested that import duty on samples having values equal to or less than USD 500 should be removed, as such imported samples were collected for development purposes to ultimately secure bigger export orders; thus, he requested DHL Authorities to ioin hands with the Chamber and raise the said matter in Government Departments. He informed that it had become very difficult for SMEs to control the production cost as constant increases in the raw material rates were observed due to Covid-19. Therefore, it was requested that DHL should introduce a special discount package for SMEs to bring relieve the xport-oriented community of Sialkot. He expressed his hope that the meeting would bring fruitful outcomes for SMEs based export-oriented sector of Sialkot.

Mr. Fawad Ali thanked Mian Imran Akbar. President SCCI, and stated that DHL had done its best to control the prices, since the inception of COVID-19. He mentioned that DHL had adjusted the prices and increased rates sequentially to avoid the sudden burden on the shoulders of Exporters. He also mentioned that emergency surcharge on shipments being sent to the USA was only 0.2 cents per kg rather than Australia/New Zealand which was not a targeted market for exporters. Holistically the cost of doing business and the global supply chain was disturbed in the entire world because of Covid-19, however, DHL had absorbed those damages and operated under loss which was also documented, he said. The Senior Director also mentioned that, just like other brands, if DHL would withdraw from the market the export market might face a direct impact. Whereas Mr. Usman Wali, Senior Director Operations said that all the businesses were disturbed internationally due to increasing cost, and DHL was no exception. He suggested that the exporters and DHL should work as partners and should understand each other.

After due deliberation and discussion, it was decided that DHL would introduce sector-specific tariff rates for Member(s) of SCCI,also DHL would generate a proper invoice on imported samples as well as the company would also train their clearing agents to allocate imported goods under proper SROs. It was discussed that Member(s) of SCCI could learn the Volumetric Measurement Demo Practice at DHL Office and DHL Express would provide a possible connection with DHL Logistics for awareness to Member(s) of SCCI. Office Bearers thanked the guest and their cooperation in the subject matter



Visit of SAMI ULLAH KHAN FORMER CAPTAIN OF PAKISTAN'S NATIONAL HOCKEY TEAM

Mr. Sami Ullah Khan, Former Captain of Pakistan's National Hockey Team visited the Sialkot Chamber of Commerce & Industry. Famous Player Mr. Anjum Rashid also visited the SCCI; whereas, Mirza Iqbal Baig (Senior Sports Journalist) and Mr. Shehnaz Sheikh joined the meeting online via Zoom. Mian Imran Akbar, President of SCCI welcomed the guests and appreciated them for their achievements.

Mr. Zohaib Rafique Sethi, Senior Vice President SCCI, and Mr. Qasim Malik, Vice President SCCI also welcomed the guests and participants. They shared their own experiences with Mr. Sami Ullah khan, and they also elaborated on the personality of "The Flying Horse" as a person, a player, and an international athlete. Office Bearers once again thanked Mr. Sami Ullah Khan to visit the Sialkot Chamber of Commerce & Industry; they presented a Souvenir to him as a token of appreciation.



Visit of MRS. AMBREEN AHMED TARAR COLLECTOR, COLLECTORATE OF CUSTOMS, SIALKOT

Mrs. Ambreen Ahmed Tarar, Collector Customs, Collectorate of Customs, Sialkot visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI, welcomed Mrs. Ambreen Ahmed Tarar, and other distinguished guests. He expressed gratitude to the honorable Collector of Customs for facilitation in the establishment of the "Customs Help Desk" at SCCI and said that members would benefit from this facility. He invited the attention of the Collector to certain issues regarding Custom, Advance Taxes, Removal of Multiple Audits under Temporary Importation Schemes, System integration of Collectorates across Pakistan, Clearance of outstanding Duty Drawback Claims of manual One Custom system, etc. He further discussed the appointment of a Focal Person to address issues pertaining to the subscription of Pakistan Single Window (PSW) for District Sialkot. He discussed the withdrawal of notices for production of records issued to the exporters availing Temporary Importation Schemes. President also suggested that the Export refund audit should be limited to 0.5% cases as all cases were subject to strict scrutiny at the time of issuance of refunds.

Mrs. Ambreen Ahmed Tarar, Collector, Collectorate of Customs, Sialkot, thanked the President and the members for their warm welcome and hospitality. She said that her visit to Sialkot Chamber was intended to directly interact with the business community regarding issues faced by them and to find an effective solution. She informed that the "Custom Help Desk" had been established at Sialkot Chamber at the request of the President and its inauguration would be instrumental in extending maximum facilitation to the exporters. She responded to the points discussed by President SCCI and explained all the points in detail. While during the Question/Answer session, members discussed the policy of the Government to allow Commercial Warehousing in the Sialkot Export Processing Zone, the revival of the Customs Advisory Committee at the Collectorate level, and WeBOC-related issues, Custom duties on Free samples, etc. Mr. Zohaib Rafique Sethi, Senior Vice President of SCCI also highlighted some of the concerns; It was requested to adopt uniform criteria for calculation of duties onimports and allowance of rebate on exports as freight had become a substantial component of the cost of the goods. He also suggested that HS codes should be locked at the time of import to save exporters from hassle. He also requested that the approved input-output formula should also be saved in the system to allow the export of temporarily imported inputs from any Collectorate in Pakistan. He said that Temporary importation schemes required insurance of the inputs which should be waived in cases where factory premises were already insured. In response, Mrs. Ambreen Ahmed Tarar said that entries should be cross-checked before issuance of machine numbers as wrong entries could not be rectified in caseswhere shipments would be routed through Green Channel. Moreover, the input-output formula once approved would apply to exports from any Collectorate of Pakistan. Insurance on temporarily imported inputs was required to secure Government Duties and Taxes that had been waived by the Government at the time of import.

Office Bearers thanked again the honorable guest and expressed hope that the above-discussed matters would be resolved at the earliest.



Visit of **DR. ASIF MAHMOOD JAH** FEDERAL TAX OMBUDSMAN

Dr. Asif Mahmood Jah, Federal Tax Ombudsman visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, the President, welcomed Dr. Asif Mahmood Jah, Federal Tax Ombudsman, Officers of the Customs and Inland Revenue Departments, representatives of the Sialkot Tax Bar Association, and members of the Sialkot Chamber. He expressed gratitude to the Honorable guest for establishing a regional office at Sialkot within the premises of the Sialkot Chamber of Commerce and Industry for the facilitation of the Taxpayers.

He said that Sialkot was the hub of export-oriented industry and the business people of Sialkot had always been vigilant in fulfilling their genuine tax liability. He briefed the guests about the industrial setup and various products being produced in Sialkot. He mentioned various achievements of the business community in terms of compliance with corporate social responsibility and presented the documentary to exhibit the progressive approach and vision of Sialkot entrepreneurship. During his address, he highlighted the following issues of the business community;

- Pendency of Appeal Effect and Deferred Cases
- Returned Goods u/s 22 of the Customs Act 1969 not to be treated as Import
- Inordinate delay in clearance of pending Duty Drawback claims of One Custom
- Abolition of Sind Infrastructure Development Cess
- Permission for filing a joint complaint on a common issue of the Taxpayers

Dr. Asif Mahmood Jah expressed gratitude to the President and the Executive Committee for inviting him to the Sialkot Chamber to discuss tax issues of the business community and conduct an awareness session for information of the taxpayers.



Visit of FLT. LT. MR. TAHIR FAROOQ DEPUTY COMMISSIONER SIALKOT

Flt. Lt. Mr. Tahir Faroog, Deputy Commissioner Sialkot visited the Sialkot Chamber. The Deputy Commissioner shared the progress on mega development projects being executed under the PICIIP program in the city. He shared that the project got delayed due to the slackness of the Contractor for which a necessary warning had been issued. The DC mentioned that the project would be completed on a priority basis to provide relief to the citizens. He informed that the construction of Pasrur road was pending due to some hurdles. He shared that the upgradation/renovation of Jinnah Stadium had been started. He also shared that the Beautification and up-gradation work of Ramtalai and Sheikh Moula Baksh Talab had been initiated in which state-of-the-art sports facilities would be provided for the general public. He informed that the first phase of the project construction of Aiman Abad road had been completed. Moreover, the construction of 7.5 KM of Aiman Abad Road in the Second Phase had been approved and a tender would soon be issued. It would be connected with the motorway in the upcoming phases.

Mian Imran Akbar, President SCCI said that the Supreme Court of Pakistan had banned unregistered motorcycle rickshaws. In view of the same, he requested the Deputy Commissioner to implementation of the decision in a letter and spirit. The President shared that the labor from South Punjab was observed to be leaving the factories and engaged in riding unregistered Qingqi Rickshaw. He said that the issue had led to an increase in encroachment on roads and a shortage of labor in factories. He further asked about the status of the construction of the overhead bridge on Defence Road.

Mr. Qaisar Iqbal Baryar shared that significant work on the cargo container terminal from Wazirabad to Karachi had been done and requested the cooperation of the District Government in this project. The Deputy Commissioner assured his full support for the completion of Ring Road and other projects/matters which were discussed in the meeting. He also assured that all necessary measures would be taken to resolve the issues highlighted by the President Sialkot Chamber.

Visit of **MR. KHALID JAVED** CHAIRMAN/DIRECTOR GENERAL, PAKISTAN POST

Mr. Khalid Javed, Chairman/Director General, Pakistan Post visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed Mr. Khalid Javed, Chairman/Director General, Pakistan Post for visiting the Sialkot Chamber. He shared that the export-oriented City of Sialkot represented an industrial setup, producing specialized products that were supplied to top brands and buyers all over the world due to which the city was earning US \$ 2.5 Billion annually to play an instrumental role in strengthening the national economy.

President SCCI said that Pakistan Post was not only playing an instrumental role in delivering the mail to the people especially businessmen but also providing services of Saving Bank, Tax Collection, and Postal Insurance. Moreover, the delivery network of Pakistan Post was established and more stable than all othe courier companies operating in Pakistan. He also said that Pakistan Post had adopted Modern Technologies and revolutionary steps to ensure speedy communication. He said that Businessmen of Sialkot had to deliver small consignments through Pakistan Post yet facing problems i.e., Timely Delivery, Tracking, and lost parcels incurring financial loss.

Mr. Khalid Javed, Chairman/Director General, Pakistan Post expressed his gratitude for inviting him to the Sialkot Chamber. He assured that the Pakistan Post would play its role to resolve obstacles regarding issues of consignments in Pakistan and abroad. He shared that Pakistan Post had been integrated with WEBOC and it was envisioned by the Prime Minister of Pakistan that export should be

promoted through Pakistan Post as currently only samples and gifts were being sent to international destinations for which charges of EMS would also be rationalized. He informed that state-of-the-art scaners were required for starting export through Pakistan Post which he would try to install from his budget for Sialkot. He shared that Pakistan Post had started the "EMS Plus" parcel delivery service which would enable citizens to post goods to 50 different countries including the US, UK, Japan, and Canada at a very affordable price within 72 hours. He also required the information regarding AIRSIAL to be recommended and forwarded to the Prime Minister for Issuance of Honorary Postage Stamp for AIRSIAL to acknowledge the services. He informed that complaints or any hurdles regarding consignments through Pakistan Post could be forwarded directly to him and he would refer to the concerned for expedited resolution.

Mr. Fayaz Gul, In-charge, GPO Sialkot thanked and shared about the 4 major categories of international mail. He said that charges of international freight could also be calculated on the website of Pakistan Post. He assured that complete tracking of the export consignments sent through GPO, Sialkot would be done by them to resolve the problems of the Business Community on priority. Pakistan Post had launched EMS Plus Service with the partnership of some courier companies which was fast, reliable/economical, and offered an end-to-end tracking facility to the esteemed customers. He discussed the points shared by the business community as well as talked about their services & facilities offered in detail.

He acknowledged that the proposals for the improvement of the export industry shared by President SCCI were remarkable. He welcomed to work for the betterment of Pakistan and to boost the export culture throughout the country. Mr. Tarig apprised about the export potential of the Sialkot-based Industry. He emphasized that to increase the exports of the Country, targets should be marked, followed by concerted efforts to achieve goals timely. He shared that Pakistan was exporting around 3,227 6- digit HS Codes to the world out of 5,026 6-digit HS Codes being traded globally. He said that Pakistan, along with focusing on the diversification of the Products, should put more efforts to increase the quantity of the products already exported by the Country and needed to increase the share of Pakistan's exports in the World.

Mr. Babar Iqbal, Former President of SCCI appreciated the thoughts of the Advisor to the Prime Minister regarding the improvement of export culture and expressed his concerns about the lack of a business-friendly environment in the Country. He pointed out the problems faced by the exporters and also mentioned that the rebate on the Surgical, Medical, and Dental Instruments was also reduced by the Government and implication of Sales Tax on Export Processing Zones.

Mian Imran Akbar, President SCCI said that except from the hurdles faced by the business community, a lot of work had been done by the Government for the betterment of the Industry like the Pakistan Single Window (PSW), Duty Drawback, and refund claims of the Exporters. He said that the quality of raw material available in the market specifically for the surgical sector was not at par with global standards. He suggested that regulatory authority should be formed to check the quality of the Raw materials. Furthermore, EOBI and Social Security issues needed to be addressed on an immediate basis, and a one-step deduction methodology should be introduced to keep the working of the exporters hassle-free.

Mr. Tariq Ikram noted all the issues highlighted during the meeting and assured that the above-mentioned points would be discussed with the other Government Officials for their early solution.



Visit of **PROF. DR. SALMA FAROOQ** NED, UET, KARACHI, AND HER TEAM

A delegation from NED University, Karachi visited the Sialkot Chamber of Commerce and Industry to brief about the project "Enhancement of Global Competitiveness of Pakistani Textile Export Value-chains by Capacity Building and Product Diversification". Mr. Zohaib Rafique Sethi, Senior Vice President, SCCI, welcomed the delegation and said that the Sialkot Chamber was willing to initiate a project related to the Leather Sector. He mentioned that the Government should focus on 'Import Substitution' in order to support the supply chain of the Textile Industry. During the discussion, members talked about the lack of proper institutes in Sialkot to support Research & Development Work for the industry. It was mentioned that both 'Academia & Industry' should join hands together to support the industry by finding out solutions to industry-related issues and bringing diversification.

Prof. Dr. Salma Farooq, NED UET Karachi thanked the Sialkot Chamber for receiving them and discussing the concerns. He explained the details of their project and said that an initiative had been taken to develop the fabric beingimported into Pakistan and to do reverse engineering for strengthening the supply chain of the textile sector. OfficeBearers of SCCI thanked the guests and their team for visiting this Chamber for such an important discussion and tocreate linkages between Industry and academia.





Visit of EXCELLENCY MR. BERNHARD SCHLAGHECK AMBASSADOR OF THE GERMANY TO PAKISTAN TO SIALKOT CHAMBER OF COMMERCE & INDUSTRY

Mian Imran Akbar, President SCCI welcomed H.E. Bernhard Schlagheck, Ambassador of Germany to Pakistan, Mr. Christian Boettcher (Commercial Counselor), and members of the Chamber on February 10, 2022. The President started his address with the hope that His Excellency's visit to SCCI would go a long way in improving understanding and interaction between the business communities of the two countries. The President further appreciated the role of Germany in the extension of the GSP+ status. He said that thanks to the facility, more than 78% of Pakistan's exports were entering the EU at the most concessional rates. Mian Imran Akbar expressed his gratitude to His Excellency for being an advocate of Pakistan and for his positive role in the extension of the scheme. He also discussed the online appointment system of the German Embassy and Visa related matters

The President Chamber also requested His Excellency to consider creating a focused linkage between the esteemed German Embassy and Sialkot Chamber. He also gave a brief introduction of Sialkot and all the industrial dynamics which enabled the city to enjoy the status of being the only Export Oriented City of Pakistan having executed several mega projects. Ending his address, he once again thanked His Excellency for visiting the Chamber and hoped that the meeting would result in promoting better understanding between the business communities of the two countries and wished that a new era of economic cooperation will open which would boost the trade to bring prosperity and happiness to both nations.

H.E. Bernhard Schlagheck thanked the President and said that Sialkot was the main link between German and Pakistani trade relations as the city had been a major contributor to bilateral trade. He expressed his satisfaction with the numbers of the German Pakistan Trade relations clocking at USD 3 (B) the biggest chunk within the European Union. He mentioned that the exports of Pakistan to Germany had increased by 15%. He said that the GSP Plus scheme would be drawing to a close in 2022 and would be revisited for the prospective extension.

The German Envoy informed that the Embassy had been under major reconstruction work that had affected operations. He also said that members could hire a representative and submit their visa applications in Karachi. He said that Sialkot Chamber should have a coordinating role and the Embassy would facilitate the processing of Visas in case of a significant number of applications for a specific trade fair. He said that President Chamber's request for facilitation of such cases would be entertained. The Ambassador once again thanked the leadership of the Sialkot Chamber and hoped that the relations between Pakistan and Germany would further strengthen in the future.



Visit of **RANA SHEHZAD AHMED KHAN** DIRECTOR GENERAL TDAP, PUNJAB

Rana Shehzad Ahmed Khan, Director General TDAP, Punjab visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President the Sialkot Chamber of Commerce & Industry welcomed Rana Shehzad Akbar, Director General, TDAP, Punjab to Sialkot Chamber for the meeting. He also thanked Syed Abbas Mehdi, Executive Director, Export Development Fund (EDF), Islamabad, and all the other participants of the meeting. He informed the house that the purpose of the meeting was to discuss the EDF-funded project the Child Labor Elimination Program. He invited Rana Shehzad Ahmed Khan, DG, TDAP, and Punjab to share his views on the said agenda point.

Rana Shehzad Ahmed Khan, DG TDAP Punjab explained to the participants the process to streamline and define the role of TDAP in disbursing and monitoring the EDF projects. He said that once a procedure would be in place, the disbursement would be made within 15 days subject to the availability of funds in the joint account. He shared that under the Child Labour Elimination Program, payments from July 2021 onwards would be made post expenditure after submission of duly verified vouchers by the co-signatory of the project from the SCCI side or a person authorized by the co-signatory on his behalf. It was agreed that as per the Legal Contract, the approved Minutes of Meeting of the EDF Board would have to submit to TDAP Sialkot, and would be forwarded to EDF afterwards. It was also decided that the beneficiary would be identified by the SCCI and will be shared with EDF and the agreement of SCCI with CSDO and IMAC would also be shared with TDAP.



Mr. Abbas Mehdi, Executive Director EDF said that audit of the previous years had been conducted, and based on the findings of the audit, the pending liability would be determined and the amount would be forwarded to TDAP with clear-cut instructions to pay to the SCCI.



H.E. MR. DEDDY FAISAL AHMAD CHARGE D' AFFAIRES OF HIGH COMMISSION OF MALAYSIA TO PAKISTAN

H.E. Mr. Deddy Faisal Ahmad, Charge D' Affaires of the High Commission of Malaysia to Pakistan visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed His Excellency Mr. Deddy Faisal Ahmad, Charge d' Affaires of High Commission of Malaysia to Pakistan & members of this Chamber in the meeting. He mentioned that Pakistan and Malaysia enjoyed close and cordial relations. Pakistan was one of the first countries to recognize and establish diplomatic relations with Malaysia in 1957. "Malaysia the land of impressive diversity in religion, culture, and history is also one of the most dynamic countries in the world economically. A factor that largely accounts for its growing international significance" he said. Pakistani Business Community should strive to penetrate and create bilateral trading relations with new markets and zones, especially in the ASEAN Region wherein Malaysia is an important player. President stressed that both countries should make efforts to take the relations to a new level by aggressively exploring opportunities for joint ventures in various sectors.

"As per the data of the ITC, the total bilateral trade between the two countries in 2020 was around USD 1.38 (B) with the balance of trade in favor of Malaysia. However, there is a huge potential to increase this volume of trade. Both sides need to ponder on developing a strategy for bringing improvements. We are encouraged by the resolve of both Governments to boost the trade yet we believe that people-topeople linkages especially the B2B relations should be promoted" the President stated. He further emphasized the exchange of trade delegations and single-country exhibitions, and discussed the 'Look Africa' stressing that the Government of Pakistan should replicate a similar initiative for the ASEAN region, especially for Malaysia. He also requested facilitation from His Excellency in the creation of linkages with the importers in Malaysia, especially in the Sports Goods, Sports Wear, Surgical Instruments, and the Leather sector as they have a significant demand in the Malaysian market. He also shared about the Sialkot Chamber of Commerce & Industry, as the representative body of the Private Sector of Sialkot, was greatly contributing to the economic development of the country.

H.E Mr. Deddy Faisal Ahmad, Charge d' Affaires of the High Commission of Malaysia to Pakistan thanked and mentioned the bilateral relations of both countries; as he mentioned the cooperation of both the countries on the platform of the Organization of Islamic Cooperation (OIC). He further talked about the political relations, coordination, and frequent exchange of high-level visits by the Government Representatives of Pakistan & Malaysia. He also appreciated that the trade ties between the two countries enhanced from the last year, as he mentioned the trade figure of USD 1.395 B indicating the boost. He said that the Malaysian Government was fully focused on its economic strategy and included some sustainable development projects to increase the potential opportunities for the next five years. Malaysia encouraged the other countries to attract foreign Investment and provided many relaxations to the investors to provide them ease and encouragement for Joint Ventures.



Visit of SYED TAHIR RAZA HAMDANI DIRECTOR GENERAL (IPWM), GOVERNMENT OF PUNJAB

Syed Tahir Raza Hamdani, Director General (IPWM), Government of Punjab visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed Syed Tahir Raza Hamdani, Director General (IPWM), Government of Punjab, and his team to the Sialkot Chamber. The President appreciated the positive role of the Government of Punjab for its economy despite the critical economic situations and prevailing challenges. Meeting with Nadeem UI Haque, Vice-Chancellor PIDE PAKISTAN INSTITUTE OF DEVELOPMENT ECONOMICS (PIDE)

A delegation from the Pakistan Institute of Development Economics (PIDE) visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President of SCCI welcomed the Honorable Guest Dr. Nadeem UI Hague, Vice-Chancellor PIDE, and his team at Sialkot Chamber. President SCCI mentioned that the model of Sialkot was indeed a case study that could be an answer to the economic issues of Pakistan if replicated across the country in true spirit. He shared about the dynamics of Sialkot, its cottage industry, and remarkable social & development projects initiated by the SCCI. He said that Sialkot was an important economic center and the only export-oriented city in Pakistan earning over 2.5 billion US Dollars annually through its exports in various sectors e.g., Sports Goods, Surgical Instruments, Leather Products, Gloves of all sorts, Textile items, Sports Wear, Martial Art Uniforms & Accessories, Musical instruments, Military & Police Uniforms Accessories, Highland Outfitters, Badges, Kitchen Ware, Hollow Ware to Knives and Cutlery items.

He shared that The Pakistan Institute of Development Economics was a premier research institute and a public policy think tank located in the vicinity of Islamabad. Furthermore, he appreciated the role of the Business Community of Sialkot in contributing to the national cause and inputting 2.5 billion USD into the country's foreign exchequer. Visit of **PAKISTAN NATIONAL ACCREDITATION COUNCIL (PNAC)**

Director General. Pakistan National Accreditation Council (PNAC), Ms. Asmat Gul Khatak visited the Sialkot Chamber of Commerce and Industry (SCCI) for an awareness Seminar for the Sialkot's Industry. Mian Imran Akbar, President of SCCI welcomed the honorable guest, team from PNAC, and participants/ members of SCCI. While addressing to the participants of the seminar, President SCCI shared the facts & features regarding the industry and exports sector of Sialkot. He gave detailed information related to the trade figures, international exposure of the city, and its remarkable achievements in the Social & Development Sector. Furthermore, President SCCI elaborated on the industry's requirements regarding the certifications & standardization of the products exported to the international market.

Mr. Akbar also submitted his proposals about enhancement in subsidy in Product Certification by the Government, provision of trained consultants for the acquisition of standards (e.g., Leather Working Group (LWG), Medical Device Regulation (MDR), FDA and ISO certification, etc.) and establishment of a Material Testing Lab within the EPZ. President SCCI also mentioned that there was no accredited lab available within Pakistan and foreign accredited names were being utilized for the testing of Sialkot-made Products making it costly and hectic to manage for completing the process. He further shared that already PKR 1 billion had been approved by the Government of Pakistan for the establishment of a Material Testing Laboratory in the Export Processing Zone (EPZ), for which PNAC should play its role to initiate the project.

Sh. Zohaib Rafique, Senior Vice President, elaborated that the leather Industry was the most regulated industrial sector of Sialkot, and leather products were certified by accredited labs. He also discussed the requirement of a 'Testing Laboratory' for the Leather Sector. Senior Vice President also said that the industry was lacking behind in new product development due to the absence of state-of-the-art facilities & institutes where labor could be trained and new experiments could be done for developing novel products.

During the session, a Certificate was also presented to Khawaja Masud Akhtar (SI) by DG PNAC for the accreditation of his lab facility within M/s. Forward Sports. Moreover, representatives from SGS and TTI also gave their input to improve the facilities in Sialkot City for the Exporters. Office bearers of SCCI thanked the guests to visit Sialkot and appreciate the discussion held for the betterment.





Visit of H.E. MR. WILLIAM MAKANEOLE US CONSUL GENERAL LAHORE

- possible shifting of electricity poles.

- Working on linking Aimenabad Road to Exit 4 of the Sialkot-Lahore Motorway would be initiated for its prospective inclusion in the upcoming Annual Development Programme.
- The Government of Punjab would be requested for the initiation of the Safe City Project in Sialkot.
- Infrastructure projects under PICIIP Program to be expedited and quality of work would be ensured.
- The Project of Shahab Pura Flyover would be expedited in coordination with Pakistan Railways. Also, the project of Defence Road would be completed in parallel with the tentative inauguration by end of June 2022.
- Project of Sambrial to Sialkot International Airport would be expedited. Moreover, a 5 Km patch of Wazirabad Road would also be initiated.
- The project of widening of Muzaffarpur Railway Crossing would be taken up and initiated.
- Special courtesy of Commissioner Gujranwala Division was solicited for the early execution of the project of the Sialkot Industrial Zone at 1000 acres Saho Wala Site near Sambrial.
- As a special case, 200 arms licenses per month would be issued for the Export Sector of Sialkot upon due recommendation from Sialkot Chamber to the Deputy Commissioner Sialkot.



Visit of MR. ALEX BALLINGER UK REPRESENTATIVE FOR PUNJAB

Mr. Alex Ballinger, UK Representative for Punjab visited the Sialkot Chamber of Commerce & Industry. Mr. Zohaib Rafique Sethi, Senior Vice President SCCI welcomed the guest and the members of this Chamber. He expressed that The United Kingdom was a major trading partner of Pakistan considered to have higher scope for made-in-Sialkot products. Mr. Sethi said that the Industry of Sialkot had achieved marvels and done plenty of self-sustaining CSR projects. He mentioned that the exporters of Sialkot needed to travel to the UK to participate in Trade Exhibitions or to meet their clients, so a relaxed Visa policy for the businessmen should be opted by the British High Commission.

Mr. Sethi said that Pakistan had been foreseeing enhancing the exports of Information Technology (IT) and would also like to do JVs with IT firms in the UK to share expertise and training. While addressing the members, Mr. Sethi proposed to organize Made in Sialkot exhibition in the United Kingdom, to increase Business to Business interactions. He added that Leather Products and Personal Protective Equipment were being exported to the UK and SCCI would propose that a collaboration between the UK accredited Lab and Pakistan should be done, so that the tests could be in Pakistan at competitive rates. He also added that the interaction between SCCI and Trade Bodies should be promoted, and he requested the guests to work on the proposal of SCCI.

Mr. Alex Ballinger, UK Representative for Punjab, extended his gratitude for the warm welcome and praised the Industry of Sialkot for their collective efforts to promote a positive image of Pakistan. He said that Pakistan was the third largest import destination for the UK and endorsed the proposals of the Sialkot Chamber to promote Bilateral Trade and Business to Business interactions. While responding to the question of Sheikh Zohaib Rafique Sethi, SVP SCCI, Mr. Ballinger said that due to the economic crunch, the UK was only providing Aid for Women Empowerment. Mr. Muhammad Hamed Kamal, Deputy Director for Trade praised that Sialkot had innovative businessmen who could join hands with UK companies. He added that UK High Commission and SCCI could do joint projects and other proposals could also be undertaken.

Mr. Qasim Malik, Vice President, proposed that Trade Delegation to UK should be executed and requested the representative of the UK to share the information of Trade Fairs that were taking place in the UK related to products of Sialkot. He also added that the Industry of Sialkot was willing to do joint ventures with counterparts in the UK.




Visit of KHADIM ROZA-E-RASOOL HON'BLE SHEIKH NOORI MUHAMMAD AHMAD ALI

A delegation from World Bank visited the Sialkot Chamber of Commerce & Industry. Sheikh Zohaib Rafique Sethi, Senior Vice President, SCCI welcomed Ms. Adja Mansora Dahourou (Senior Private Sector Specialist), Mr. Douglas Zhihua Zeng (Senior Economist), Ms. Claudia Garcia Gonzalez (Consultant), Mr. Rafey Khan (Economist), Mr. Husnain Ijaz and Agha Tayyab Ilyas to the Sialkot Chamber. He shared the agenda of the delegation was to enhance private investments & competitiveness in Punjab province. He said that there were many areas where discussions could be done with the World Bank team to bring the investment in Industrial sectors, infrastructure, rehabilitation of public visiting places, and traffic control system, which was a dire need of the city. He added that the advancement in the Industrial setup could be achieved through joint ventures and the transfer of the latest technologies would increase the competitiveness and product diversification, increasing the skill and craftsmanship of the SME Industry and eventually increasing the exports of Pakistan.

He mentioned that Sialkot was the only city that had the capacity & capability to double its exports, provided with thesupport the entrepreneurs need to compete internationally and the infrastructure that could support the vision of Industrialization. He informed that the city had developed an SME culture highly conducive to business collaborations and joint ventures in various industries in Sialkot including Surgical Instruments, Sports Goods & Sports Wear, Leather Products, Manicure & Pedicure Beauty Instruments, Table Cutlery & Flatware, Martial Arts, and many more. He informed that the exporters were well versed in rules, regulations, and requirements of international trade, which has resulted in exports from Sialkot, being over USD 2.5 (B) annually.

Senior Vice President said that by keeping in view the agenda of the meeting, the following were the potential areasfor Investment in the Surgical Sector; Laparoscopic Instrumentations, Endoscopic Instrumentations, Sterilized Orthopedic Implants, Sterilized Neural Implants, Implants for Maxillofacial Surgery, Electric Motor System for Orthopedic Surgery, Artificial Joints, Bone Implants used in Bone Grafting, Assembling of General Life Supportive Equipment including, Nebulizers, Blood Pressure Monitor, ECG Monitor, Blood-Glucose Meters (Sugar Testing Equipment), Hospital Furniture, Aluminum Containers, Mash Baskets, Doppler's Testing Equipment, Carbon Fiber Instruments' Manufacturing Technology, Transducers (for ECG Monitoring) and Sterilization & Clean Room / Packaging Unit.



Mr. Qasim Malik, Vice President SCCI also shared that of all the industrial sectors of Sialkot, Textile Sector was the most booming sector. He informed that Sialkot was producing value-added products for international buyers, and the exporters of Sialkot relied heavily on the import of raw materials majorly sourced from China for value addition and re-export purposes. He said that the business community of Sialkot was planning to have a dedicated sub-zone to attract investments in the following fields to promote import substitution; Coated Textile Fabric, Kodura Fabric, PU Fabric, Reflective Fiber& Other types of cloths, PU (Polyurethane) Leather, Advanced Materials and Performance Fabrics and Rubber Soles. Ms. AdjaMansoraDahourou (Senior Private Sector Specialist), thanked SCCI's Office Bearers for their warm welcome and hospitality rendered to the delegation of the World Bank. While addressing the house, he expressed the importance of collaboration and willingness of the Malaysian companies to join hands with Pakistani companies in multiple sectors. He added that due to COVID-19, the economic activities were disturbed but with ease in restrictions, the business community would welcome the businessmen from Pakistan. He added that Malaysia had a lot of products to offer and could also join hands for Joint ventures. The Delegation gave their introduction and elaborated on their areas of interest and businesses they were doing at the present.

Mr. Qasim Malik, Vice President SCCI, said that Pakistan had a lot to learn from the Economy of Malaysia and their Industrial revolution. He added that Pakistan could follow in the footstep of Malaysia, especially in the field of the IT sector. Vice President SCCI also added that Sialkot Industry had the privilege of manufacturing three consecutive official footballs for the FIFA World Cups. He also mentioned that Pakistan was the most desirable destination for investment for international investors and companies for Joint Ventures, import substitution, and Transfer of Technology.



Visit of **Mr. Sajid Latif** DIRECTOR GENERAL, PUNJAB INFORMATION TECHNOLOGY BOARD

Mr. Sajid Latif, Director General of Punjab Information Technology Board (PITB), visited the Sialkot Chamber of Commerce and Industry along with his team. Mian Imran Akbar, President SCCI welcomed the guest, and other participants of the meeting. While presenting the welcome remarks, he referred to his visit to PITB and the discussions held with Director General PITB on prompt solicitation of initiatives taken by PITB to SCCI members. Mr. Akbar shared that the active members of the Sialkot Chamber were over 17 thousand, and this Chamber was a multi-sectoral Industry, wherein 99% of products produced were being exported worldwide and the majority of members of SCCI were small businesses being handled by one individual.

President SCCI discussed the difficulties for small entrepreneurs in interacting with Government Departments e.g., Excise Taxation office, Nadra, Passport Office, Registrar Office etc. It was discussed during the meeting that an E-Sahulat centre should be established in Sialkot where exporters of Sialkot take benefits regarding all facilities, without waiting in long queues. It was also brought into discussion that PITB could provide IT-related services to provide ease to new start-ups in registering their firms and starting an E-Commerce business.

Mr. Sajid Latif, Director General, Punjab Information Technology Board thanked President SCCI and mentioned that PITB had developed a portal "Ease of Doing Business" to encourage new business registrations under the paperless initiative. He also explained that it was proposed by PITB that members with SCCI Membership cards would be given priority on 135 ESahulat Centers while availing of the services. Mr. Latif added that PITB was making it easy for new start-ups to availing online services like Starting a Business, Paying Taxes, Registering Property (e-Khidmat Markaz) and Dealing with Construction Permits (e-Khidmat Markaz), especially for those aspiring to start E-Commerce business including Amazon, Ebay, and Alibaba. Furthermore.

After due deliberation, it was decided that SCCI would nominate three officers for the training of the portal initiated by PITB and a help desk would be established within SCCI for the guidance of the members of SCCI, and a full house session would be arranged in SCCI to create awareness of PITB initiatives. After the Meeting, the inauguration of the Help Desk for Ease of Doing Business was also held.



Visit of SYED ZEESHAN RAZA DISTRICT POLICE OFFICER (DPO), SIALKOT

Syed Zeeshan Raza, District Police Officer (DPO) visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed the guest and Mr. Qaiser Amin Butt, DSP City Circle, Sialkot and Mr. Sabir Chattha, DSP Traffic Police, Sialkot. While discussing the country's situation, the President emphasized all the important stakeholders should support each other for the progress of the city as well as the country. President SCCI appreciated the services of the Police Department and the cooperation with this Chamber. He further briefed about the industrial setup and various products being produced at Sialkot. He also shared the details regarding the development projects initiated and completed under the umbrella of Sialkot Chamber on a self-help basis including but not limited to Sialkot Dry port Trust, the City Package Programme, Sialkot International Airport, Sialkot Export Processing Zone, Sialkot Tannery Zone, Child labour elimination programme, Sialkot Business & Commerce Centre, AirSial project and International Hospital by the name of Sialkot Medical City Limited, etc.


Mr. Akbar shared that Sialkot Chamber had taken up the Safe City project with the Government of Punjab for its initiation/launching in Sialkot as per the criteria of safe city project being launched in other big cities of Punjab like Lahore etc and the Government of Punjab informed that it had been approved in the ADB of Punjab. He also emphasized the need for Improvement in the law-and-order situation of the city especially taking necessary corrective measures for stopping robbery or dacoity incidents. He stressed the need for the establishment of a Driving License Office on the premises of this Chamber and added that the Facilitation Desk of Police should be established at SCCI for the preparation of Character Certificates and submission of Police-related complaints of the members of the Sialkot Chamber. He suggested that the Manpower of the Police should be enhanced in Sialkot City to effectively control the law-and-order situation in Sialkot city.

Sh. Zohaib Rafique Sethi, Senior Vice President SCCI highlighted that District Police Sialkot, in any case pertaining to the business community, may take Sialkot Chamber on board before registering the FIR against the members, especially cases pertaining to cash and cheque involvement so that Chamber may play its role in managing the issue effectively. He also mentioned that member companies of this Chamber engaged in providing advances to their employees in routine but they would leave the job after borrowing huge advances/loans from factories, hence in this regard Police should make an easy mechanism for recovery of cash paid in the shape of advances to employees instead of lengthy procedure of launching FIR etc. He suggested that a joint Committee should be formed to



resolve such issues.

Syed Zeeshan Raza, DPO Sialkot thanked the President for his warm welcome and hoped that the Safe City project would be helpful in bringing improvement in controlling law and order situation and management of traffic efficiently. He said that he had devised a comprehensive plan to bring improvement in the Police department to provide safety to the life and property of the citizens. He shared that specific cases may be forwarded to Sialkot Chamber by adopting the case-to-case policy for its resolution amicably. In this regard, he further informed that I.G Office had already a plan to form the Dispute resolvingCommittees at the district level officially and the Sialkot Chamber focal









Visit of MR. DILAWAR SYED SPECIAL REPRESENTATIVE STATE DEPARTMENT

Mr. Dilawar Syed, Special Representative for Commercial and Business Affairs, Bureau of Economic and Business Affairs visited the Sialkot Chamber of Commerce & Industry. Mian Imran Akbar, President SCCI welcomed the honorable guest and his team including Ms. Gaia Self, Regional Policy Lead, U.S. International Development Finance Corporation (DFC), Washington DC, Ms. Kathleen Giblisco, Economic & Political Chief, and members of the Chamber. President Chamber thanked Mr. Dilawar Syed for visiting Sialkot Chamber to exchange the views with the members on issues of mutual interest. He hoped that the interaction would go a long way in improving understanding and interaction between the business communities of the two countries for the promotion of bilateral trade.

Mr. Imran Akbar highlighted the significance of trading partnership with the USA as reflected in trading figures between the two countries at USD 6.72 (B) having a major share in the total external trade of Pakistan. The President SCCI said that it was encouraging to note that Pakistan's exports of goods and services to USA witnessed a surge of 51.22pc during eleven months of fiscal year (2021-22) as compared to the corresponding period of last year. "The overall exports to the USA were recorded at \$6.15 (B) during July-May (2021-22) against exports of \$4.47 (B) during July-May (2020-21), showing growth of 37.60pc, as per the State Bank. On the other hand, imports from the US have also increased considerably", the President noted.

He extended his gratitude to Mr. Dilawar Syed and his team for showing interest in the Industry of Sialkot to

study its dynamism and potential for growth. President Chamber mentioned that the model of Sialkot was indeed a case study that could be the way forward to the economic situation of Pakistan if replicated across the country in true spirit. While addressing the house, the Chamber's President gave a briefing on the city of Sialkot and touched on the domains of industrial dynamism, the roadmap for economic development, and women empowerment. On the occasion, he gave a briefing on the project of the Sialkot Industrial Zone to facilitate Joint Ventures and to take the industry of Sialkot to the next level.

Mr. Dilawar Syed thanked the SCCI for extending a warm welcome and mentioned that he had observed the tenacity and skill of the people of Sialkot. Mr. Syed said that the most astonishing part of the industrial setup of Sialkot was the superior skillset of its craftsmen and the commitment of entrepreneurs to their businesses in an ever-changing world. He shared that he had observed the tremendous potential for increasing bilateral trade provided that an enabling environment is created from both sides. He also briefed the house regarding his role as the Special Representative in the Biden Administration to facilitate US Corporate Sector around the world. He shared that he was on a visit to South Asia and had picked Pakistan as the first stop. He said that the main objective was to further Pakistan and the US relationship in terms of trade. He said that at present the numbers of bilateral trade were not in tune with the relations spanning over decades. He stressed that both sides would need to engage on a frequent basis to create mutually beneficial opportunities.



Visit of **MR. IFTIKHAR BHALLI** DIRECTOR EXCISE, TAXATION AND NARCOTICS CONTROL DEPARTMENT, GUJRANWALA

Mr. Iftikhar Bhalli, Director Excise, Taxation and Narcotics Control Department, Gujranwala visited the Sialkot Chamber of Commerce & Industry. Mr. Imran Akbar, President, welcomed and apprised him of problems faced by the export-oriented industry of Sialkot due to levy of "Tax on Properties other than Agricultural Land abutting to National / Provincial Highways and within the area of Motorways outside the rating areas in Punjab" under section 10 of the Punjab Finance Act, 2019. He said that the levy of tax had resulted in an undue financial burden on the exporters as most of them belonged to the SME category and were already facing serious challenges in Post Covid-19 economic situation. He apprised that Sialkot had a unique Industrial arrangement as the Industrial Units were dispersed within the city and on

roads leading to the city including National and Provincial Highways and within the area of Motorways. He said that the prime reason behind this unique industrial layout was the lack of any Industrial State in the City since the year 1962.

Mian Muhammad Anwar, Mr. Muhammad Shahbaz, Mr. Adnan Yousaf, Mr. Rana Nadeem Ahmed, and other members also showed concern on increase in the number of taxes and levies on the export-oriented businesses in Pakistan. It was emphasized that the Department should focus on 'ease of doing business' by creating enabling environment for the business community. The issue of notices by the Excise and Taxation Department to the export-orient

PRESIDENT

1. LEAGAL STATUS AND OPERATIONS

The Sialkot Chamber of Commerce and industry " the Chamber" was incorporated in Pakistan on 28th July, 1982 under the companies Act 1913 (now Companies Act, 2017) vide Federal Government License No. 24 dated 15th, 1982. The main object of the Chamber is to promote trade, commerce and industry and conduct research and development work. The registered office of SCCI is situated at Paris road, Sialkot.

2. STATEMENT OF COMPLAINCE

These financial statements have been prepared in accordance with the accounting and reporting standards as applicable in Pakistan. The approved accounting and reporting standards applicable in Pakistan comprise of:

International Financial Reporting Standard for Small and Medium-sized Entities (IFRS for SMEs) issued by the International Accounting Standards Board (IASB) as notified under the Companies Act, 2017;

Accounting Standard for Not for Profit Organizations (Accounting Standard for NPOs) issued by the Institute of Chartered Accountants of Pakistan as notified under the Companies Act, 2017; and provision of and directive issued under the Companies Act, 2017.

Where provisions of and directives issued under the Companies Act, 2017 differ from the IFRS for SMEs or the Accounting Standard for NPOs, the provisions of and directives issued under the Companies Act, 2017 have been followed

3. BASIS OF MEASUREMENT

3.1 Basis of Operation

These financial statements have been prepared under the historical cost convention. Further these financial statements have been prepared under the accrual basis of accounting.

4. SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies applied in the preparation of these financial statements are consistent to all the years presented, unless otherwise stated and are as follows:

4.1 Property and equipment

4.1.1 Operation fixed assets

Operating fixed assets purchased are stated at cost less accumulated depreciation and impairment loss, if any, except land held for business use is stated at cost.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefit associated with the operating fixed asset will flow to the company and cost can be measured reliably. Normal repairs and maintenance are charged to expenses as and when incurred.

Depreciation is provided on reducing balance method over the estimated useful lives of the assets at rates specified in note 5.1.

Depreciation on additions is charged from the day of acquisition and on disposals up to the day the asset is in use. Maintenance and normal repairs are charged to income as and when incurred. Major renewals and improvements are capitalized.

Gain / loss on disposal of operating fixed assets is taken to the profit and loss account. Gains or losses on disposal or retirement of operating fixed assets are determined as the difference between the sale proceeds and the carrying amount of assets and are included in the income and expenditure account.

The company assesses at each reporting date whether there is any indication that operating fixed assets may be impaired. If such indication exists the carrying amount of such assets are reviewed to assess whether they are recorded in excess of there recoverable amount. Where carrying values exceed the respective recoverable amount, assets are written down to there recoverable amounts and the resulting impairment loss is taken to income and expenditure account.

4.2 Capital Work in Progress

Capital work-in-progress (CWIP) is stated at cost less any recognized impairment loss. All expenditures connected to the specific assets incurred during installation and construction period are carried under CWIP. These are transferred to specific assets as and when assets are available for use.

4.3 Intangibles and amortization

Intangible assets, which are assets without physical substance, are recognized at cost, which comprise purchase price, non-refundable purchase taxes and other directly attributable expenditures relating to their implementation and customization. After initial recognition, an intangible asset is carried at cost less accumulated amortization and impairment losses, if any. Intangible assets are amortized from the month, when these assets are available for use, using the reducing balance method, whereby the cost of the intangible asset is amortized over its estimated useful life over which economic benefits are expected to flow to the Company. The useful life and amortization method are reviewed and adjusted, if appropriate, at each reporting date.

4.4 General Store Inventory

General store inventory is valued at lower of cost determined on first in first out basis and net realizable value.

4.5 Advances and receivables

Advances and receivables are not derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for maturities greater than 12 months after the end of reporting period, in which case, these are classified as non current assets.

4.6 Cash and cash equivalents

Cash and cash equivalents are carried in the balance sheet at cost. For the purpose of cash flow statement, cash and cash equivalents comprise cash in hand and balances with banks in current and savings accounts.

4.7 Accrued and other liabilities

Accrued and other liabilities are carried at their cost, which is the fair value of the consideration to be paid in the future for goods and services received, whether or not billed to the company.

4.8 Taxation

Provision for current tax is based on the taxable income for the year determined in accordance with the prevailing law for taxation of income. The charge for current tax is calculated using prevailing tax rates or tax rates expected to apply to the profit for the year, if enacted. The charge for current tax also includes adjustments, where considered necessary, to provision for taxation made in previous years arising from assessments framed during the year for such years.

4.9 Staff Gratuity

The Chamber operates a fully funded gratuity scheme covering all of its employees. The Chamber has created a separate fund whose trustees are responsible for ensuring that the fund covers the gratuity payable at a particular date. However, annual transfer of funds is made to the fund in order to cover obligation under this scheme. This transfer equals the amount of provision for gratuity for that year after deducting any profits earned on the investments of gratuity fund in the same period.

4.10 Revenue Recognition Unrestricted / general fund

Revenue from admission, subscription and other receipts collected from members are recognized on accrual basis. Return on deposits is accrued on a time proportion basis by reference to the principle outstanding and the applicable rate of return.

Restricted fund

The organization follows the restricted fund method for recognition of its funds, as prescribed by ICAP in Accounting Standards for Non for Profit Organizations (NPOs). Under this method grants and contributions from members are recognized as revenue of the fund when received, irrespective of the expenses incurred.

4.11 Figures
