<u>Discussion:</u>

Mr. Muhammad Shahbaz expressed his concern about the working domain of the Departmental Committee on District Affairs. He said that the issues of different Departmental Committees of Excise & Taxation, TMA etc., were discussed in the meeting which seemed that the District Affair Committee represented different Committees. He said that he had already discussed and requested in last Executive Committee Meeting to set the domain of the District Affairs Committee because working of other Departmental Committees was affected due to it. He said that the main role of District Committee was to coordinate for the President with DC. Mr. Shahbaz Saim further said that either the other Departmental Committees should be abolished or the domain of District Affairs Committee should be set and clarified for working of other Committees.

The President asked the Secretary General what was written in the letter sent to the Chairman Departmental Committee on District Affairs.

The Secretary General replied that it was not mentioned to coordinate.

The President agreed with Muhammad Shahbaz and said that it was not appropriate that the matters of other Departmental Committees should be discussed in the District Affairs Committee. He said that some other Chairmen of Departmental Committees had also complained that the matters relating to their Committees were discussed in the District Affairs Committee. He said that District Affairs Committee did not mean to deal with the matters related to other Committees.

Mr. Naeem Yousaf said that point of Mr. Muhammad Shahbaz was appropriate but on the other side, Mr. Nadeem Ahmed was working properly according to the name of the Committee Sialkot District Affairs which covered district affairs. He suggested that there was need to rectify the Committee's name.

Miss Lubna Tubsim suggested that all Chairmen of Departmental Committees could associate with Sialkot District Affairs Committee so that they could perform along with the Chairman of Sialkot District Affairs Committee.

The President replied that it was not feasible.

Mr. Afzal Bhatti inquired about the SOPs of the Sialkot District Affairs Committee.

The President replied that the Chairman of Sialkot District Affairs Committee should coordinate President SCCI's office with DC office.

Mr. Naeem Yousaf suggested then the name of Committee should be changed.

After thorough discussion the house unanimously approved to change the name of Departmental Committee of Sialkot District Affairs with "District Affairs Liaison Committee".

Mr. Muhammad Shahbaz Saim said that the number of people in this meeting was very big due to which it happened. He suggested that meetings with big gathering should be arranged outside in the newly built yard.

Miss Lubna Tubsim shared that a Seminar was held in Lahore by the Labour and HR Department, Government of Punjab on December 21, 2023. She said that as Chairperson Departmental Committee on Employers & Worker/ Vendors Disputes and Executive Committee Member of the Sialkot Chamber of Commerce & Industry, she participated in the Seminar. The Seminar was about the practice and participation of the business community to ensure that they followed the rules related to labour laws and labour Act. The points deliberated in the Seminar were discussed in the Committee Meeting.

Miss Lubna added that a letter was received from the the Commercial Division, Embassy of Pakistan, Washington DC wherein salient points of the US Presidential Memorandum for the Heads of Executive Departments – Workers Rights, Empowerment and Heigh Labour Standards Abroad were mentioned. As per the letter, the Secretary of the State, in consultation with the heads of relevant agencies, would explore enhanced protection mechanisms for labor rights defenders and would keep a check that how the industries were facilitating the labor. The letter was relating to this Committee, therefore it was discussed in the Committee Meeting for the information of members. She requested the Office Bearers and EC Members to participate in the Committee Meetings.

Miss Lubna Tubsim said that minutes of the meeting were placed on the table and the members could ask the question, if they had. She also requested the members to study the minutes and ask the question to make the Committee more effective. She said that number of members had requested to join the Committee as members who were welcomed.

The President said that members could join this Committee as members .

24. Mrs. Gulzaib Waqas Awan suggested that a help desk should be setup in this Chamber to guide the visitors towards different departments.

The Secretary General replied that a help desk had already been set up in the Chamber but staff was not appointed there.

The President said that some space was available alongside Mr. Azhar Iqbal Dar's office and he had instructed Mr. Azhar to set up help desk over there and nominate someone.

Mr. Adnan Yousaf said that majority of the people visited Membership Section, therefore, help desk should be set up there.

The Secretariat informed that a help desk/reception was also set up in Membership Section but staff was not deputed yet.

Miss Lubna Tubsim suggested that Help Desk should be set up at prominent place, so that the visitors should reach there conveniently for getting information.

The President said that it could be mentioned out side the door. He also instructed Mr. Moazzam Ishaq to depute someone at Help Desk in Membership Section.

25. Mr. Saleem Akhtar Bhutta said that GPO had setup desk in SBCC but was closed later on due to some reason. Some members had requested him to reopen it for which he held a meeting with the concerned authorities of GPO and they restarted its operation, again on his request. Mr. Saleem Akhtar Butta said that GPO also invited him as Chief Guest in a program organized by them.

26. The President said that the fee of new membership and renewal fee of both Corporate and Associate classes were increased in its last Executive Committee Meeting. Some members had objected and requested to reduce it, so he had decided to reduce it, which required approval from the House. The President shared the proposed and approved fee Schedule Chart.

Mr. Afzaal Bhatti suggested that Renewal Fee of Corporate Class could be set according to the annual turnover of member companies.

The President replied that as per Rules it was not allowed.

Mr. Secretary General explained to the members that to increase in the annual subscription, approval was required in the Annual General Meeting, which was a lengthy process.

Mr. Zain ul Abideen thanked and appreciated the President to take the decision to decrease the fees. He said that number of members raised questions about increase in fees. He also requested the President that there was a need to review the trade delegation and exhibition fee as SMEs could not pay such high fee. He suggested that selection fee should be decreased from Rs. 30,000 to 10,000.

Mr. Saleem Akhtar Bhutta said that the renewal fee of Pakistan Surgical Association was Rs 7000/- and Rs.5000, respectively for Corporate and Associate Classes.

Mr. Muhammad Shahbaz Saim appreciated the President for taking the decision to decrease the fee because number of members had complained through emails and telephonic calls. He said that he had spoken to Mian Khalil that such high increase in fee would be a problem for SMEs especially the salaried persons who desired to get their firms registered for their better future. He further said that in the previous meeting Mr. Adnan and other members had given their suggestion which was approved. He was not even given the time to speak on this point so that he could be part of the minutes that he opposed. Mr. Shahbaz Saim requested to reconsider the Trade Delegation Fee.

Mr. Amer Majeed Sheikh agreed with the suggestion of Mr. Zain UI Abideen to decrease the fee of Trade Delegation. He proposed that the Application Processing fee should be Rs. 5000 and after selection it should be Rs. 15000. He added that if fee was increased to such an extent, then most of the members would not apply, which would ultimately reduce income.

Mr. Muhammad Shahbaz Saim agreed with the suggestion of Mr. Amer Majeed Sheikh.

Mr. Naeem Yousaf said that the trade allegation fee should not be reduced because due to small fee amount non-serious members also submitted their applications, which created problem. He said that Application Processing Fee of Rs. 10,000/- and Selection Fee of Rs. 30,000/- should be charged as per the approval of EC.

The President agreed and said that there were 2-3 members who submitted their applications in every delegation.

Mr. Wahub Jahangir suggested to charge Application Processing Fee of Rs. 10,000/and selection fee Rs. 10,000/- which also endorsed by Mr. Zain ul Abideen and Mr. Ahmed Imtiaz Khan.

Mr. Amer Majeed Sheikh said that selection fee could be Rs. 15,000/-.

Mr. Muhammad Shahbaz Saim suggested that application processing fee should be reduced.

Mr. Adnan Yousaf said that Mr. Shehbaz Saim had pointed him in the matter of increasing the annual fees. He said that he had no personal interest in the matter of increasing the fee. He had proposed to increase the fee only in the interest and betterment of this Chamber. Secondly, as concerned to the Trade Delegation, if a member planned to visit with foreign delegation and could not pay Rs.10,000-20,000/-, then how would he manage his remaining affairs?

The President said that there were members in this Chamber who had multibillion exports but they were not ready to pay Rs. 5000 for e-business letter fee.

Miss Lubna Tubsim said that 624 Associate and 06 Corporate new firms were registered in this month. As discussed about the initial fee, the members who were serious could arrange their initial fee, so it should be maintained. She said that nonserious members applied in trade delegations due to low fee and later on did not avail the opportunity due to which the genuine businesspersons suffered. It created a question mark on the Trade Delegations and services of this Chamber that what kind of people were being accommodated.

The President requested Mrs. Gulzaib Waqas Awan to propose about delegation fee.

Mrs. Gulzaib Waqas Awan said that statistics of receipt of applications should be checked. She suggested that Application Processing Fee of Rs. 10,000/- and Selection Fee of Rs. 10,000 to Rs.15000 could be fixed.

The President informed that applications of 55 members were received for the Australian delegation out of which 08 were to be selected and all applicants knew about it but they submitted their applications to become part of the delegation irrespective of increased fee.

The President and the Secretary General informed that no objection was received from the members regarding increase in delegation fee.

Mr. Saleem Akhtar Butta said that if no objection was raised by the members regarding increase in delegation fee, then there was no need to revise or reduce it.

After thorough discussion the house unanimously approved Trade Delegation Application Processing Fee of Rs. 10,000/- and Selection Fee of Rs. 20,000.

27. The President said that for the convenience of the members, the Chamber had planned the following facilities at the Chamber:-

- To install a credit card machine in the Sialkot Chamber so that the members could submit their fee. The services charges of 1.5% of each transaction would be paid from Chamber's account.
- Online Payment Service

Mr. Adnan Yousaf and Mr. Afzaal Bhatti requested to check about the service charges.

Mr. Amer Majeed Sheikh replied that it had been checked.

The house unanimously approved to install Credit Card Machine and Online Payment Service as proposed by the President.

28. The President said that the Sialkot Chamber had initiated a special service of China Visa Recommendation Letter after reaching an understanding with the Embassy of People's Republic of China. He said that lot of working like checking of documents, scanning and e-mail to Embassy were involved to complete the process for the issuance of letters. He said that re-consideration visa fee would not be charged in the cases of refusal of visa. The President asked whether the VRL fee of China Embassy could be increased or not.

Mr. Amer Majeed Sheikh endorsed that lot of working was involved in the Guarantee Letter for China, therefore, the fee should be Rs. 10,000-15,000.

The President said that it should remain same at the moment and, if required, it would be put up in next meeting for the approval to increase the fee.

Mr. Wahub Jahangir said that the Embassy of Republic of China had refused visa of one of the members of this Chamber, although the Guarantee Letter was issued to him.

The President replied that the list of required documents on the basis of which Chinese Embassy issued Visa was available with Mr. Salman Mir. He said that it might be possible that the Chinese company issued too many letters to various Pakistani companies due to which his visa was rejected. The President said that he had instructed Mr. Salman Mir to check the status of the invitee company in China before issuing Guarantee letter. He added that the Chinese Embassy informed that the invitation of state-owned enterprise (SOE) would be fully accommodated.

Mr. Muhammad Shahbaz Saim said that the fee of China Guarantee Letter should not be increased.

The President replied that the operational matters had to be run so free of cost services could not be provided. He said that in next EC meeting it would be discussed whether the fee needed to be increased or not.

The Meeting ended with a vote of thanks to the Chair.
