








VISIT OF UK-PAKISTAN INWARD
TRADE MISSION MANAGED BY ITC AND
BRITISH HIGH COMMISSION



On March 02, 2024: Mr. Amer Majeed Sheikh, Vice President SCCI, welcome to the distinguished delegates of the UK-Pakistan Inward Trade Mission, alongside Dr. Mariam Noman, President of WCCIS. Addressing to the house, Mr. Amer Majeed Sheikh emphasized the importance of strengthening bilateral relations between the UK and Pakistan. He expressed that the visit presented a unique opportunity to boost trade and investment between the two nations. Mr. Sheikh conveyed his appreciation to the delegation for attending the We-Exhibit, highlighting its role in promoting and supporting women empowerment.

He provided the delegates with a comprehensive overview of the Sialkot business industry, detailing renowned products and demonstrating a profound understanding of international trade regulations, aiming to contribute to the enhancement of Pakistan's exports. He further conveyed that the SCCI is not only committed to business excellence but also actively supports initiatives for Social Sector Development and Women Empowerment.

Mr. Ahmed Jamal Nasir Awan, President of the Greater Birmingham Chambers of Commerce, remarked that there is substantial potential for trade between Pakistan and the UK. He expressed his appreciation for the advanced technology utilized by Forward Sports and noted his impression upon observing the significant contribution of women in

the workforce to the economy.

Mr. Fabian Hartwell, Representative of the British High Commission, expressed his satisfaction with the collaboration between the British High Commission and the Women Chamber of Commerce and Industry to organize the We-Exhibit in coordination with the International Trade Centre (ITC) and the Foreign, Commonwealth & Development Office (FCDO). He stated that promoting women empowerment is a primary agenda of the UK Government and affirmed their commitment to continue supporting and promoting women empowerment in collaboration with the Sialkot Chamber of Commerce and Industry and the Women Chamber of Commerce and Industry.

Dr. Muhammad Aslam Dar, Former President SCCI, mentioned that the several important sectors of industry in the UK had been closed and emphasized that the embassy should assist in reopening those industries in Pakistan. He highlighted that Pakistan offers such services at much cheaper rates compared to China and suggested that joint ventures could be pursued in the future to support each other.

MEETING OF DEPARTMENTAL COMMITTEE ON POST OFFICE/TELECOMMUNICATION



On March 04,2024, a meeting of the departmental Committee on Post Office & Telecommunication was held at SCCI, Mr. Saleem Akhtar Bhutta, presided over the meeting and welcomed the guests from PTCL Department, Sialkot Mr. Adeel Ahmed Cheema, Operational Manager and Mr. Hasnain Abbas,

Manager in the meeting. Commending PTCL's overall performance, the Chairman noted improvements since Mr. Cheema's appointment as Operational Manager. He highlighted the prioritized resolution of Chamber members' issues and the ongoing emergency infrastructure upgrades at PTCL. The Chairman urged the Operational Manager to prioritize business hubs for the initial upgrade, addressing internet-related challenges faced by the business community. Additionally, he inquired about implementing day-by-day billing for internet services, advocating for a pause in charges during service disruptions.

Expressing gratitude for the special invitation, Mr. Adeel Ahmed Cheema assured the Committee that every effort would be made to promptly address their concerns. He shared that a comprehensive shift from Copper Cables to Flash Fiber was underway across Sialkot, with an initial focus on urban areas. Once 50% of the urban upgrade was completed, the process of cable replacement would extend to rural areas. Mr. Cheema encouraged the Committee to identify areas requiring immediate attention for Flash Fiber installation, pledging a priority approach. Furthermore, he announced the appointment of a Focal Person dedicated to resolving Chamber members' complaints, emphasizing their importance to PTCL. Discussing internet packages for the business community, he acknowledged the lack of awareness and committed to coordinating with the head office for an awareness session post-Ramadan to promote existing packages. He assured that all the suggestions and complaints submitted by the Committee Members have been noted, I will try my best to resolve them on priority basis.

MEETING OF DEPARTMENTAL COMMITTEE ON EDUCATION/UNIVERSITIES

On March 05, 2024, a meeting of the departmental Committee on Education was held at SCCI Mr. Dr. Khurram Anwar Khawaja, Chairman Committee welcomed the participants and members of the Departmental Committee and he shared that the

Committee had been running a scholarship program for the last 23 years with the donations being made by the Business Community of Sialkot. H also shared that under the said program deserving/needy students were being granted scholarships to bear their education expenses.

The chairman committee said that the committee has received about 35 applications for scholarships of children studying in different educational institutions, in which some are renewal and some are new cases. After mutual consideration, only one student's application was not approved for the scholarship, as she was not studying in a government school, but all 34 applications were approved.



The Chairman Committee further informed that with the support of volunteers from different Colleges and Universities of Sialkot, the Sialkot Chamber initiated a project of providing free tuition to the needy and deserving students of 9th & 10th classes in the Public Schools of the District Sialkot under a Project titled "Al-Suffa Free Tuition Centers" in collaboration of Education Department. Sialkot, Al-Khidmat Foundation Sialkot Welfare Council and GC Women University, Sialkot. In addition, the sports and other extra-curricular activities would also be promoted among the students to improve their physical health.

Responding to Chairman Mr. Shahid Naseer's query, Convener of Sialkot Welfare Council, provided updates on the progress of the Al-Suffa Free Tuition Program. He reported smooth operations and the

successful completion of the initial phase at five high schools. Plans are underway to expand the program to 11 additional schools in the upcoming academic year starting after April 2024. He further said that this year, we have launched an awareness campaign throughout the district to encourage the maximum number of parents to enroll their children in government schools. He assured that efforts will be made to offer free tuition, textbooks, medical checkups, merit-based scholarships, and uniforms, and promote participation in sports and extracurricular activities for students attending these public schools.

VISIT OF H.E. MR. DURMUS BASTUG CONSUL GENERAL OF TURKIYE, LAHORE



On March 8, 2024 H.E. Mr. Durmus Bastug Consul General of Turkiye, Lahore and Mr. Nurettin Demir, the Commercial Attache visited SCCI. Mr. Abdul Ghafoor Malik, President, SCCI welcomed H.E. Consul General of the Republic of Türkiye, Lahore, Commercial Attaché and members to the meeting. While highlighting the trade figures between both countries, Mr. Malik stressed that there was a great possibility and huge potential for joint ventures and cooperation in various sectors, which should be exploited optimally to further improve bilateral trade. He mentioned that Türkiye remained an important investment partner as numerous Turkish firms were working in Pakistan in the sectors like energy, finance, and infrastructure projects. We believed that both Türkiye and Pakistan should collaborate to utilize the expertise to drive mutual progress and prosperity, to foster closer business-to-business linkages. "The Pakistan-Türkiye Trade in Goods Agreement that comes into effect on May 01, 2023, is a step in the right direction to serve as a valuable framework for facilitating bilateral trade", he added.

The President SCCI requested H. E. Excellency's support in creating linkages between business community on both sides to promote made in Sialkot Products including Surgical Instruments, Workwear, Gloves, Sports Goods, and Sports Apparel, having considerable demand in Türkiye. He proposed to send a trade delegation from Sialkot to Türkiye facilitated by foreign missions of both countries. The President SCCI proposed to grant long term Business Visas to the members over the recommendation of the Sialkot Chamber of Commerce & Industry. He shared that the Sialkot Chamber issued Business Visa Recommendation letters to its members through a strict scrutiny process, facilitating their international business endeavors. Mr. Amer Majeed Sheikh, Vice President SCCI suggested to organizing a "Made in Sialkot Exhibition" in Turkiye to showcase the diverse range of products, manufactured in Sialkot. The Vice President inquired about the investment opportunities and requested to share the criteria to establish business offices in Turkiye for onward sharing with SCCI's members.



H.E. Mr. Durmus Bastug, Consul General thanked and appreciated the contribution of SCCI towards the promotion of exports of Pakistan and the social sector as well. During the meeting, the Envoy acknowledged the technological advancements of the Industry of Sialkot and expressed Türkiye's

readiness for increased collaboration in various sectors. Mr. Bastug further added that Pakistan and Turkiye should co-operate in matters related to improving bilateral trade between both countries. He mentioned the existing Pakistan-Türkiye Trade in Goods Agreement between the two countries would further enhance business cooperation and investment opportunities. While responding to the request made by President SCCI about the grant of Long-Term Business Visas, the Consul General assured that Mr. Bastug would convey the suggestion(s) for Long-Term Business Visas to the appropriate Authorities in Türkiye, recognizing the importance of facilitating seamless travel for businessmen seeking to explore opportunities in Türkiye. He informed that three-year visas for business travel were already being granted, which was appreciated by the members of the house. He further stated that the said matters would be taken up at the governmental level of both countries. Therefore, the relevant government authorities in Pakistan should forward such concerns to the government authorities in Turkiye for necessary action to be taken at the top level accordingly. However, he assured that the Turkiye Consulate General will be available to provide the necessary facilitation, wherever required by SCCI to address and communicate the concerns at their best capacity.

Mr. Nurettin Demir, Commercial Attaché, said that they would communicate all the suggestion(s) including the Free Trade Agreement between Pakistan and Turkiye to the relevant Authorities in Turkiye for consideration. Mr. Nurettin emphasized that government support was crucial for the successful negotiation, implementation, and enforcement of Free Trade Agreements. He further highlighted the pressing concerns of transportation and customs duties in Turkiye.

MR. AISAM UL HAQ QURESHI, PRESIDENT OF PAKISTAN TENNIS FEDERATION AND MR. ZOHAIB AFZAL MALIK, YOUNG RISING TENNIS PLAYER

He requested the delegates to keep the record of necessary invoices/receipts/boarding passes for onward submission to TDAP for the refund process. He further requested the delegates to manage the return flight from any Australian destinations only for the seamless procedure of refund from TDAP. Mr.

Moreover, Mr. Khan assured to render his guidance in case of any ambiguity while applying the visa by the delegates.

MEETING OF DEPARTMENTAL COMMITTEE ON FBR, CUSTOMS, SALES TAX, FEDERAL AND PROVINCIAL TAXATION



On 18th March, 2024, a meeting of the Departmental Committee on FBR, Customs, Sales Tax, Federal and Provincial Taxation was held at SCCI. Ch. Ahmed Zulfiqar Hayat, Chairman Committee welcomed the participants and he invited proposals for Federal Budget 2024-25. He said that Sialkot Chamber had always emphasized on promoting ease of doing business to improve competitiveness and would continue to sensitize the Government on the issues faced by the export businesses. He sought input of the members for formulation of Budget Proposals.

The proposals for Federal Budget were submitted to the Committee for consideration, the house discussed the proposals in detail, after due deliberation, the house unanimously approved following new Proposals for Federal Budget 2024-2025: -

I. There is no time limitation to conclude proceedings-initiated u/s 161(1A) against Withholding Agent. It is proposed that time limitation prescribed under Section 174(3) of the Ordinance should be prescribed for action under section 161(1A) as well i.e. for a period of Six (6) Years after the end of the corresponding tax year.

Ii. Currently, time limitation to file revised wealth statement u/s 116(3) is Five (5) Years from the due date of filing of return of income for the corresponding tax year. It is proposed that period of Five (5) Years should be reckoned from the end of the financial year in which the Commissioner has issued or treated to have issued the assessment order to the taxpayer as provided under section 122(2) of the Ordinance.

Iii. Tax deducted u/s 153(1)(a) & (b) in the case of Individual and AOP is treated as minimum tax, which is a harsh provision. It is proposed that tax deducted under this section should either be adjustable or final tax.

Iv. Presently, payments remitted abroad through debit, credit or prepaid cards are subjected to tax deduction at the rate of 5% u/s 236-Y, which is exorbitant, excessive and unjustified. It is proposed to reduce deduction of tax to 1% for filer / active taxpayer to provide incentive to the taxpayers.

V. Profit on debt up to Rs.5 million is charged u/s 7B at the rate of 15% and is treated under Final Tax Regime (FTR). However, if the income increases from Rs.5 million, the same is treated under normal tax regime and benefit of FTR no more remains available to the taxpayer. It is proposed to enhance the limit from Rs.5 million to Rs.10 million to keep the benefit

of FTR intact for persons falling within threshold of Rs.10 million.

Vi. After ICA order of the Honourable Lahore High Court, working of tax u/s 7E has been restored which is a part of income tax return. Currently, to file 7E information or to get certificate, taxpayer has to revise tax return as well as wealth statement which is a hectic and futile exercise. It is proposed to introduce separate module / form in IRIS to deal all such cases without the need to revise last year returns.

VISIT OF CIVIL OFFICERS OF THE 39TH MID-CAREER MANAGEMENT COURSE, NIM ISLAMABAD



On February 20, Mr. Abdul Ghafoor Malik, President SCCI, welcomed the delegation from the 39th Mid-Career Management Course, NIM Islamabad. He expressed his belief that the distinguished officers present possessed the intellect, vision, and spirit to contribute to the efficient functioning of the government at all levels. He appreciated the constructive measures of the Government, such as the establishment of Business Facilitation Centers in main Industrial Cities of Punjab and Special Investment Facilitation Council, aimed at attracting Foreign Direct Investment. He then provided them with an overview of Sialkot city and the Sialkot Business Community, as well as the Sialkot Chamber, highlighting their initiatives.

Mr. Muhammad Imran, Directing Staff NIM, extended appreciation to President of SCCI, for the warm welcome. He acknowledged the exemplary

status of the Sialkot Industry, serving as a model for the entire business community in Pakistan. The conversation revolved around maximizing the utilization of skilled youth within the industry and encouraging their involvement as entrepreneurs. It was emphasized that updating technical training programs to align with industry needs and incorporating the latest technology would be essential in achieving the goal.

During the meeting, there was a discussion about the importance of getting increased governmental support to emphasize the production of local raw materials. The emphasis was on establishing additional factories instead of relying on imports, with an emphasis on crafting stable policies and undertaking robust research and development efforts to meet the demands of international market. It was mentioned that the Sialkot market had placed significant emphasis on branding and certifications and had already developed numerous brands with the vision of further enhancement in future.

VISIT OF H.E. MR. TAPAS ADHIKARI, AMBASSADOR OF NEPAL TO PAKISTAN

On February 23, 2024: Mr. Abdul Ghafoor Malik, President, SCCI welcomed H.E Mr. Tapas Adhikari, Ambassador of Nepal. He mentioned that Pakistan

and Nepal had shared cordial relations since the establishment of diplomatic ties back in 1960. VISIT OF SECRETARY, LABOUR AND HUMAN RESOURCE DEPARTMENT, PUNJAB



On May 07, 2024: Mr. Wahub Jahangir, SVP, welcomed Mr. Muhammad Naeem Ghaus, Secretary, Labour and Human Resource Department, Punjab, Syeda Kulsoom Hai, Director General Labour Welfare, distinguished guests and members of Sialkot Chamber. During his address of welcome, he highlighted the following issues;

- i) Establishment of 2nd Labour Colony in Sialkot
- ii) Evacuation of illegal occupants of Allama Iqbal Labour Colony and allotment to next eligible workers of the relevant industry.
- iii) Digitalization of workers' record.
- iv) Implementation of departmental protocols during industrial inspections.
- v) Fulfillment of requirements of Workers' Welfare Schools concerning staff and furniture.
- vi) Appointment of specialist doctors and provision of medicines in Social Security Hospital Sialkot to

discourage practice of referring patients to private hospitals.

Mr. Muhammad Naeem Ghaus, Secretary, Labour and Human Resource Department Punjab, thanked Senior Vice President and members of SCCI for their warm welcome. He informed that primary purpose of his visit was:

I) To ensure implementation of Minimum Wage of Rs. 32,000 / month across all industries of Punjab to help workers make both ends meet under high inflationary pressures.

Ii) To encourage industries, adopt minimum international standards relating to Occupational Safety and Health (OSH).

While responding to the points highlighted by the Senior Vice President, He informed that;

- I) Non-availability of public land had been the major hurdle in establishment of new labour colony in Sialkot. Assistance was sought from SCCI to help identify land at appropriate location, convenient to the workers of the industry, to start acquisition process. It was said that SCCI might constitute Special Task Committee and instructions would be issued to Deputy Director Labour Welfare Sialkot to participate in the meetings as departmental representative. It was assured that sufficient funds were available with the department for establishment of new labour colony and department had strong preference for undertaking such projects. Ii) 31 labour colonies in Punjab, all had been developed following different protocols and some of colonies had been developed granting proprietary rights to the workers. He said that new colonies had been developed granting ownership rights to the workers. However, sale purchase of workers' flats was not permitted as per applicable rules.
- Iii) Government had been working on digitization of workers' records and latest status of the project would be elaborated subsequently through a presentation.
- Iv) Single incident of violation of departmental protocols, as reported by Sialkot Chamber, had been

strictly take care of and there would be no violation in future.

V) Due to shortage of capacity in the existing workers' schools, an idea of establishment of primary level school had been under consideration, which was also facing delay due to non-availability of appropriate land. It was said that SCCI's Special Task Committee might help identify land at appropriate place to suit the needs of industrial workers.

Ms. Syeda Kulsoom Hai, Director General Labour Welfare, thanked the Chair and delivered a comprehensive presentation on key initiatives of Directorate General of Labour Welfare, Punjab. She shared organogram of Directorate General of Labour Welfare (DGLW) and shared following functions of DGLW;

- I). Protection of rights of workers through implementation of Labour Laws.
- Ii). Prohibition of Child and Bonded Labour.
- Iii).Promotion of Tripartism (Participation of Government, Workers and Management in Policy Formulation)
- Iv). Gradual extension of labour laws to the informal sectors.
- V). Education and Training on Labour Laws, Occupational Health and Safety.
- Vi). Assured Freedom of Association and Collective Bargaining.
- Vii). Maintenance of Industrial Peace and Settlement of Industrial Disputes.
- Viii). Implementation and Reporting to International Labour Organization.

She said that DGLW required cooperation of members of Chamber of Commerce and Industry, Sialkot, to avail facilities of DGLW on occupational safety and health of workers and workplaces. She informed that following OSH facilities of DGLW were available to employers / workers.

- I). Risk Assessments of workplaces
- Ii). Medical screening of workers
- Iii). On-site trainings of workers and middle management on occupational safety & health (OSH)

- Iv). In-house trainings of workers and middle management on occupational safety and health (OSH) at Centre for the Improvement of Working Conditions & Environment (CIWCE) Township Lahore
- V). In-house and on-site trainings of workers and middle management on Labour Laws required to be implemented under GSP Plus Scheme and Provincial Legal Framework
- Vi). Awareness material on OSH, safety signs, risk assessment reports and sector specific OSH reports were available on link http://ciwce.org.pk
- Vii). Customized sector specific training facility was also available

She highlighted other initiatives of DGLW especially Consolidation, Rationalization and Simplification of 26 Labour Laws of Punjab through preparation of Draft Labour Code through technical cooperation of ILO. She said that draft legislation was ready for consultation with the stakeholders and would encompass Construction, Agriculture and Platform workers. She also shared initiatives of DGLW for elimination of child and bonded labour in Punjab. She informed further that digital transformation of DGLW was in process and would be implemented by next year.

VISIT OF MR. MUHAMMAD ZULQARNAIN, DEPUTY COMMISSIONER SIALKOT

He also informed that Pakistan's total export volume of the work wear sector recorded 3 billion dollars and had been steadily increasing each year according to statistics. He emphasized that we should actively participate in international Work Wear exhibitions worldwide, organize trade delegations through the Chamber, and develop practical solutions to address the industry's challenges. He suggested that a testing lab for work wear sector should be established in Sialkot for which collaboration should be made with NUST. Moreover, they could also assist in developing innovative raw materials. He also said that raw materials currently imported from China should be produced domestically to boost the country's exports.

The Chairman Committee acknowledged the various challenges faced by the members and said that all relevant matters would be strategically planned and addressed through the platform of the Committee for resolution. He mentioned that the next meeting would be scheduled at the earliest to further discuss issues and suggestions regarding the Work Wear sector.

TRAINING SESSION BY DEPARTMENTAL COMMITTEE ON SURGICAL INSTRUMENTS, HEALTH, PERSONAL CARE & ALLIED INDUSTRIES



On May 14, 2024, the Departmental Committee on Surgical Instruments, Health, Personal Care & Allied Industries in collaboration with UK Test Lab arranged a training session on MDR for the members of SCCI. Mr. Naeem Yousaf, Executive Committee Member, SCCI welcomed everyone and extended his sincere gratitude to the representatives from UK Test Lab, Mr. Enrico Allegra and Mr. Tautvydas Karitonas, for their visit to the Sialkot Chamber. He appreciated the UK Test Lab, which specializes in the complexity of medical device testing & validation, focusing particularly on instructions for use validation and material compatibility studies to ensure compliance with global regulations.

He highlighted that MDR emerged as a pressing issue in Surgical Industry. It has been observed that manufacturers are facing challenges in complying with the strict requirements of the MDR. He

Additionally, a same-day delivery option is available within Sialkot city.

On May 15, 2024, a meeting of Departmental Committee on Beauty Instruments/ Personal Care held under the Chairmanship of Raja Saqib Ashfaq.

He discussed the first agenda item which was the inclusion of exhibitions in the TDAP Annual Calendar to facilitate members. He highlighted the numerous benefits of exhibitions organized through TDAP and requested members to provide input on which exhibitions should be included in the TDAP Annual Calendar. He said that Russia was a significant market and Exhibition of Russia should also be included in TDAP Calendar and other sectors could also be included for making collective efforts in this regard.

He said that HS codes of Beauty products should be declared separate from cutlery and surgical as the sector had a handsome contribution to the exports of the Country. He expressed that with the formation of a dedicated Association for the Beauty Instruments sector, concerted efforts would be made to address and resolve existing issues to facilitate the members from the platform of the Association.

Members of the Committee recommended, that correspondence should be initiated with TDAP again to include CosmoProf in the Annual Calendar to facilitate Pakistani exporters, as private booking for CosmoProf was costly. Additionally, he also said that a meeting with TDAP officials would be arranged to discuss the said matter in detail.

It was also decided that a letter would also be written to the concerned Ministry regarding the declaration of separate HS Codes of the Beauty Instruments sector and a meeting would also be arranged with the concerned Minister to present the case for better understanding after consulting with the President Sialkot Chamber.

MEETING WITH DR. HINA SIKANDAR, CHIEF POST MASTER, GPO, SIALKOT

The Chairman Committee suggested that regular Mock Exercises should be planned with the factory for workers so that workers could know how to handle panic situations in case of fire. Moreover, it was decided after thorough discussion, that a letter was written to Deputy Commissioner Sialkot in which a request would be made to generate funds for establishing Tank Filling stations for Rescue 1122.

MEETING OF DEPARTMENTAL COMMITTEE ON EDUCATION

On May 21, 2024 Dr. Khurram Anwar Khawaja, Chairman Departmental Committee on Education welcomed all the members of the Committee and informed that the committee had received 14 new Scholarship Applications from deserving students. After reviewing the all applications of students, was found eligible for scholarship.

After approving the scholarship, the Chairman Committee informed that on April 27, 2024, Senior Officers of Schools Education Department Punjab Lahore, including Mr. Qaisar Rasheed, Additional Secretary (B&P), Mr. Naveed Hussain, Deputy Secretary (Planning) and Mr. Javaid Iqbal CEO Education Sialkot, along with other officials of Education Department visited the SCCI. During the meeting, a detailed presentation on the "Al-Suffa Free Coaching Center Sialkot" initiated by the Sialkot Chamber was given, which included discussions on the program's objectives and the provision of financial resources from the business community of

Sialkot.



He shared that 12 coaching centers were initially established throughout the city, where academically weak students from 9th and 10th classes of various government high schools would be provided free tuition. Additionally, these children will be provided with free uniforms, shoes, and medical facilities. He mentioned that the School Education Department Punjab Lahore, highly appreciated this Program initiated by the Sialkot Chamber, and the CEO Education, Sialkot assured complete cooperation to ensure the program's success.

Dr. Muhammad Nawaz, Principal Govt. Ms. Lubna Tubsim, Chairperson Committee shared with the participants of the Committee that the Commercial Division, Embassy of Pakistan, Washington DC issued salient points for the US Presidential Memorandum for the Heads of Executive Departments - Workers Rights, Empowerment and Heigh Labour Standards Abroad. She decided that the next meeting would soon be planned to discuss the Industrial and Labor Act in detail so that everyone could know where the Exporters/Industrialists stand. She said that after having a detailed overview, the Committee would be in a better position to suggest amendments to the law. She also business community of Sialkot and facilitated their laborers and their families through thick and thin, such as Eid, marriages, deaths, sudden incidents, etc., but don't have records of such deeds.

- Removal of Audit Objection regarding treatment of Returned Goods under Section 22 of the Customs Act, 1969, as import for levy of Advance Tax.
- Resolution of issues relating to EFS especially relating to reconciliation statements filed by the users of the scheme.
- System integration of Sialkot Collectorate with other Collectorates to facilitate online submission of documents.
- Record of local purchases should not be called from users of Temporary Importation Schemes.
- Approval of Input / Output Formula at Regulatory Collectorate level.
- Facilitation in Post Refund Audit.

Ms. Saima Shahzad, Chief Collector Customs Appraisement (Punjab), thanked the President and members of Sialkot Chamber of Commerce and Industry for their warm welcome. He shared that this meeting was arranged on an emergent basis to address the single-point agenda regarding the seal of Industrial Units within Sialkot District by District Council Sialkot due to non-payment of conversion/ building fees by the owners of Industries

in Sialkot. He invited Mr. Ulfat Shahzad, Chief Officer, District Sialkot, and requested him to explain the house on the prevailing scenario.



Mr. Ulfat Shahzad, Chief Officer, District Sialkot thanked Rana Nadeem Ahmed, Chairman Committee for inviting him and his team to discuss the issues with the members of this Chamber. He informed that during the visit of the District Officer (Regulation), District Council Sialkot, to check the illegal construction of Industries/ factories, it had been observed that the land lard/ owners of the Industrial Units do not cooperate with the staff of District Council in producing documents/ maps for verification rather they became offensive. He added that the said situation was alarming and dis-grace the Government functionaries. He requested the Sialkot Chamber to look into this matter and ask your members to cooperate with the staff of the District Council, Sialkot in producing the required documents regarding the payment of the conversion fee/ building fee, otherwise, the District Council would have every right to take legal action under section 183 of the Punjab Local Govt. Ordinance 2022 against all the defaulters.

After due deliberation, it was decided that: -

- the District Council would provide a list of Factories to the Sialkot Chamber
- Sialkot Chamber would e-mail those members regarding the payment of their necessary dues to the District Council, Sialkot in 3-4 instalments.

MEETING ORGANIZED TO HEAR & VIEW FEDERAL BUDGET 2024-25

On June 12, 2024: The Sialkot Chamber of Commerce and Industry (SCCI) convened a critical meeting to discuss the Federal Budget 2024-25. The session was chaired by Mr. Amer Majeed Sheikh, Vice President of the SCCI, and was attended by a diverse group including chamber members, representatives from the press, and electronic media personnel. The primary focus of the meeting was the implications of the Federal Budget for the export sector, particularly the controversial withdrawal of the Final Tax Regime (FTR) for exporters.

Key Budget Highlights:

- Withdrawal of Final Tax Regime for Exporters:
- Withdrawal of Sales Tax Exemption on Local Purchases:
- Release of Pending Drawback of Local Taxes and Levies (DLTL) Funds:
- Enhancement of Funds for Refinance Schemes through EXIM Bank:
- Allocation of PKR 539 Billion for Export Credit with Special 20% Quota for SMEs:
- Launch of Risk Sharing Scheme for Exporters:
- Enhancement of Minimum Wage to PKR 37,000:

Mr. Amer Majeed Sheikh expressed grave concerns over the withdrawal of the FTR, emphasizing the potential negative impacts on the export sector. He highlighted that the FTR had facilitated a simplified and transparent tax collection process, which minimized bureaucratic hurdles and corruption risks. He noted that transitioning to the NTR would likely result in increased paperwork, more frequent interactions with the Federal Board of Revenue (FBR),

and an elevated risk of corruption. This, he stressed, could significantly undermine the competitiveness of Pakistani exporters.

POST BUDGET PRESS CONFERENCE TO CONDEMN ABOLISHMENT OF FINAL TAX REGIME (FTR)

On 13th June, 2024 Mr. Abdul Ghafoor Malik welcomed representatives of Electronic and Press Media and members of Sialkot Chamber. He apprised that Press Conference had been called urgently to show displeasure and get protest of the business community recorded against abolition of FTR in the Federal Budget 2024-25.



He said that withdrawal of FTR would seriously hamper the growth of SMEs and Cottage industry as they would be frequently bothered to produce books of accounts and irrelevant records which would ultimately divert their attention from their core business activities and exports. He also highlighted that no reduction in electricity tariff for the industry had been announced while it was anticipated that tariff per unit of electricity for the export industry would be reduced by 4-5 cents.

Mr. Zulfiqar Ahmed Nasir, said that withdrawal of FTR had subjected exporters to normal tax regime whereby 1% withholding tax collected at source would be treated as minimum tax and additional 1% would be collected as adjustable advance tax, and exporters would also be susceptible to collection of Super Tax. He further said that Sialkot was a hub of Small and Medium Enterprises engaged in the business of exports and it was not practicable for

them to maintain hefty records as required by income tax department. Hence, instead of leaving SMEs to the mercy of the tax department, simplification in tax collection mechanism, as was under final tax regime, was highly desired.

After Press Conference, it was agreed by the participants that;

- Withdrawal of Final Tax Regime would be fatal for export industry and would go against the slogan of the Government to promote ease of doing business.
- Government would be demanded to revisit the policy regarding withdrawal of Final Tax Regime as it would seriously hamper the export business and exporters would be left to the mercy of the tax authorities.
- All measures by the Government regarding abolition of Final Tax Regime for exporters would be strongly condemned to safeguard the interests of the exporters.
- Meetings with the Political representatives and Government Officials would be held to sensitize them to the seriousness of the issue and to get FTR restored.

MEETING OF DEPARTMENTAL COMMITTEE ON SPORTS ACTIVITIES



On June 14, 2024 Mr. Asif Ali, Chairman of the Committee on Sports Activities chaired a meeting in which various sports events were discussed and planned. The committee decided to host a one-day Tape Ball Cricket Tournament for Sialkot's Trade Bodies on August 13, 2024, at Faraz Cricket Stadium.

A letter will be sent to all Trade Bodies to confirm their participation and coordinate the event. Additional events, including a Badminton Tournament at the Silk School System's indoor stadium and a Weight Lifting Tournament post-summer, were also approved. A proposal for a swimming event, supported by Mr. Muhammad Shahbaz Saim, was accepted, with his offering to sponsor the event and provide costumes.

Further, a Karate Championship was proposed by Mr. Tallat Mehmood to promote the local martial arts industry, with support from Mr. Muhammad Shahbaz Saim, who will arrange a Karate team. The meeting also addressed logistical aspects such as team kits and sponsorships, with Mr. Saleem Akhtar Bhutta suggesting Chamber sponsorship for player kits. Additionally, Mr. Asif Ali proposed a self-financed tour of the Sialkot Chamber Cricket Team to the UK, which was endorsed by the committee, with plans to request the Pakistan High Commission in the UK for B2B meetings.

WHY SIALKOT INDUSTRY NEEDS FTR TO SURVIVE



INTRODUCTION

The Final Tax Regime (FTR) was introduced in 1991, under the supportive framework of which the SME-driven export industry of Sialkot has thrived and progressed. This policy was instrumental in fostering growth, job creation, and empowering women entrepreneurs.

However, the recent policy shift to the Normal Tax Regime (NTR) poses a serious threat to the stability and competitiveness of Sialkot's businesses.

The Women Chamber of Commerce & Industry Sialkot (WCCIS) stands united with The Sialkot Chamber of Commerce & Industry (SCCI) and other prominent associations in urgently appealing to the Prime Minister for the reinstatement of the FTR.

It is perplexing that the same government which recognized the efficacy of FTR in supporting economic growth would now reverse this discerning policy. This is not just a budgetary adjustment but a fundamental measure to sustain our economic prosperity.

FTR VS NTR

The Final Tax Regime (FTR) and Normal Tax Regime (NTR) are two different methods of calculating income tax in Pakistan. The key differences are:-

Final Tax Regime (FTR)

- Taxes are applied directly to the total income, without considering any deductions.
- Income sources under FTR are specific. These typically include income from certain services, dividends, and other defined sources.
- SMEs in Pakistan benefit more from the Final Tax Regime (FTR) because of simplicity, fewer deductions and predictability as the tax liability is determined upfront, providing businesses with better financial planning.

Normal Tax Regime (NTR)

- Taxes are calculated on the profit after deducting all allowable expenses.
- Applies to most income sources not covered under FTR.
- Tax rates are progressive, increasing with the level of income.

THE IMPACT OF NTR WOMEN ENTREPRENEURS

The shift to NTR has introduced complex compliance requirements and higher tax rates, creating significant administrative and financial burdens for SMEs. Women entrepreneurs, who play a crucial role in the export market, are now forced to allocate their resources to navigate these bureaucratic challenges rather than focusing on innovation, production, and expansion.

In fiercely competitive international markets, this diversion of resources can be detrimental. Companies and Associations of Persons (AOPs) are struggling with unsustainable tax rates, jeopardizing their survival. The increased involvement of the Federal Board of Revenue (FBR) deteriorates the current situation, raising the risks of malpractices and business instability.

TAX BURDEN COMPARISON

To understand the gravity of the situation, let's compare the tax burdens under the current NTR and the proposed reinstated FTR:

- 1% Minimum Tax + 1% Advance Tax (2%) at source
- Tax rates: 29% for limited companies, 45% for individuals/AOPs after Assessment
- Surcharge: 5% for income > Rs 10M for AOP/Individuals.
- Super tax: 1-10% for income > Rs 150M.

This comparison clearly illustrates the complexities and higher financial burdens imposed by the NTR.

THE BROADER ECONOMIC IMPLICATIONS

For many women-led businesses, the NTR acts as a significant deterrent to formal registration and participation in the export sector. Unregistered businesses are unlikely to seek formal recognition under such onerous conditions, stifling the growth of new enterprises and innovation. This trend not only hampers individual business growth but also impacts the broader economic landscape, leading to a decline in exports and weakening Pakistan's competitive edge globally.

In the Financial Year 1991-92, the introduction of the FTR led to a substantial increase in tax revenue from the export sector, with a 149% rise compared to the previous year. This historical success highlights the potential benefits of reinstating the FTR. Here is a breakdown of the projected tax collections under different tax rates:

Tax Collection in PKR for Different Tax Rates

Tax Rate	Tax Collection (in Billion PKR)	% Increased
1%	85.806	Tax Collection in FY 23 at USD 30.645 (B) Exports
1.5%	128.709	50%
2%	171.612	100%
2.25%	192.240	124.04%
2.5%	214.510	150%

A proposed increase in the tax rate to 1.5% could meet the government's revenue targets while providing relief to exporters.

A CALL TO ACTION

The Women Chamber of Commerce & Industry Sialkot representing the interests of women entrepreneurs, strongly urges the government to revive the Final Tax Regime. This move is essential to unburden our exporters, simplify the tax structure, and secure a prosperous economic future for Pakistan. Restoring the FTR will enable our SMEs to thrive, foster a conducive

environment for business growth, and enhance our export potential.

The restoration of the Final Tax Regime is not just a fiscal necessity; it is a step towards empowering our women Entrepreneurs, sustaining our SMEs, and securing Pakistan's economic future. We call on all stakeholders to support this critical initiative and join us in advocating for a fair and supportive tax environment. By reinstating the FTR, we can ensure that our women entrepreneurs and SMEs continue to be the driving force behind Pakistan's economic growth and global competitiveness.
