Miss Lubna Tubsim said that she had studied the minutes of meeting and according to the minutes, the status of number of contractual employees was updated as employee of the Chamber. 20. Mr. Matloob Ahmed Qureshi discussed about the refusal of visa cases of China.

The President replied and suggested him to re-apply and submit his visa application to Mr. Salman Mir. He said that it had been observed that the Chinese Embassy granted visa in re-applying cases. He also suggested that the members should submit their visa applications well before the time of their visit plan, at least, one month before to avoid any such inconvenience.

21. Mr. Matloob Ahmed Qureshi requested the President to set up a Ministry of Foreign Affairs counter at Sialkot for attestation of trade-related documents for the facilitation of members. He said that the members had to go to Lahore/Islamabad for the attestation of their documents. He informed that Ministry of Foreign of Affair had approved and setup a facilitation desk in Gujarat.

Mr. Wahub Jahangir replied that with the efforts of this Chamber, Ministry of Foreign Affairs sent their Counsellor Affairs to this Chamber for one day for attestation of documents. It was requested to them to approve and confirm a visit on monthly or weekly basis to this Chamber but the MOFA did not agree due to lack of cases reported during their visit to Sialkot Chamber.

The President said that the attestation cases were high in Gujarat, therefore the MOFA setup their desk over there. He said that the MOFA Counsellor visited 2-3 times in this Chamber but most of the members of this Chamber presented request for attestation of their family case instead of business cases.

Mr. Amer Majeed Sheikh informed that President had also demanded to Mr. Mohsan Naqvi, during his visit to Sialkot, to set up a Ministry of Foreign Affairs counter at the Business Facilitation Center Sialkot for attestation of trade-related documents.

The President said that counter could not be set up even in BFC because the number of cases were very few.

- 22. Miss Lubna Tubsim said that her Committee had generated a Survey Form to gather the viewpoint from the industry regarding the issues of Industrialist with Labour which was discussed in last EC Meeting. It was approved by the Committee to circulate the form to members to study and complete the form by putting valuable information. The form was circulated to the members but nobody responded. She again requested the members to spare sometime to complete the form by putting their input, so that the Committee could proceed further on the basis of their information. She said that it was the duty of all members to support and make active all Committee with their participation and feedback etc.
