Banks lend record Rs1.78tr to agriculture sector

Financial institutions disbursed Rs1.776 trillion under agriculture financing during the previous fiscal year, which was 25 per cent higher year-on-year and was around 97.6pc of the agriculture credit target set by the State Bank of Pakistan (SBP), data showed on Wednesday.


Iran refuses to accept 'force majeure' notice
